## All Vote Center Workers:

- Must have an active email address
- Must attend required trainings before each election
- Must be a registered voter in Utah County
- Must be able to assemble and take down machines at the beginning and end of the day
- Must have transportation to and from the county, training, and vote center location

## Vote Center Managers:

- Must have a cell phone
- o Available for calls/texts to and from the county on all working days
- Must have reliable transportation to pick up and drop off supplies
- Must be able to lift 40 lbs.
- Must attend Basic and Manager training (Two separate 2-3 hour trainings)
- Must have general knowledge of all positions and be able to read a map
- Responsible for paperwork and closing forms
- Will issue and reconcile all ballots (provisional and any additional types)
- Acts as liaison between Utah County and Voters, notifying Utah County immediately of any issues
- Oversees vote center location and handles all problems
- o May be required to recruit vote center workers to fill vacancies at their location
- Responsible to ensure all equipment and ballots are returned at the end of Election Day in a timely manner

## Vote Center Poll Worker

- Must attend Basic training (One 2-3-hour training)
- Must be able to work with the public and other workers and take direction
- Must be able to lift 40 lbs.
- Must have good communication skills
- o Must be able to look up and verify voter's name and address
- Must be able to verify voter's ID
- Will collect voter's signature on poll pad
- Will record ballots accurately
- Will be required to reconcile any discrepancies
- o Required to accept assignments from Vote Center Manager
- o Will give instruction to voters and answer questions
- Will notify Vote Center manager immediately of any voter issues
