2021 Emission Control Application Guide Available

The 2021 Emission Control Application Guide is now available. If you will be due for an updated manual next year you can order the 2021 now. Remember, you must have a guide that is no more than **three years old.** If your newest guide is 2018 you will need a newer one in January. If you go past the grace period, March 31, 2021 you will be locked out **until you have the guide**. You can order 2021 now and have smooth sailing the next three years.

Training Requirement for Official Warnings

Due to the COVID situation we are waiving the requirement for Tamper class attendance for Official Warning infractions. This only applies to Warnings and not to Suspensions. This is temporary, training requirements will return when COVID restrictions on gatherings are lifted.

"On The Spot" Renewal Transmission Completion

Those stations that also do "On The Spot" (OTS) renewal need to complete the test prior to starting the renewal process. When the analyzer prints the certificate, the test is not complete and has **NOT** communicated with the Utah State system until you hit continue. The analyzer is waiting for the tech to choose "continue" and finish the test. If you do not complete the test, when OTS is attempted the vehicle emission test will not be located in the system. The State of Utah is discontinuing the manual entry of certificates. You will be required to complete the test going forward or you will not be able to perform the OTS registration for your customer.
