

Elimination of COVID Deadline Extensions

The extensions of practical and updated Application Guide deadlines will be discontinued. All technicians will need to complete a practical by 12-31-2021 or testing suspension will occur until completed. The grace period for an updated Application Guide will end March 31, 2022.

CLASS SCHEDULE FOR 2022

Diesel "Not Ready" Limits

After surveying the other emissions counties we will change to allow **two** "not readies" for diesel vehicles requiring OBD testing. This change will lead to more complete reciprocity between I/M counties. It should also reduce the driven miles necessary to obtain enough system readies to allow testing. Diesel waivers will still be considered for vehicles with documented ECM re-flashes. The change should be fully implemented in December 2021. The change will be implemented by the analyzer and will not require any change in procedure for the technicians.

Technician Renewal and Practical

Any technician that has not completed a practical in 2021 will need to seek out your auditor or **schedule** a time to come to the Tech Center **prior to the new year**. The previous time extension of 2021 related to Covid will not apply in 2022. Those **not** wishing to renew do not need a practical.

Failing a passing vehicle


Suspension time for FAILING a passing vehicle is 180 days minimum for station and technician. Failing a vehicle because you are not sure whether it passes is NOT an option. We do **NOT** want properly working vehicles FAILED due to poor inspection practices. Contact the Tech Center (801 851-7600) for help when you are not sure!

Illegal Diesel Programmer Procedure

As part of the diesel vehicle visual inspection process the certified technician must determine if components are inoperative or missing. Any inoperative or missing components must be recorded as a Fail in the analyzer. Once a fail is recorded the technician must indicate if tampering was the reason for the failure. Any diesel vehicle with a programmer must be verified as legal. The customer must have documentation showing an Executive Order or CARB approval number for the device. If proof **cannot** be provided, the vehicle must be FAILED for OBD visual inspection and it must be flagged as tampered. (See screen shots below)



Illegal programmer should be indicated by OBD Fail



Any "visual fail" will default (highlighted) to Yes tampering and should be selected if the fail was for tampering.

2022 Emission Control Application Guide Available

The 2022 Emission Control Application Guide is now available. If you will be due for an updated manual next year you can order the 2022 now. Remember, you must have a guide that is no more than **three years old.** If your newest guide is 2019 you will need a newer one in January. If you go past the grace period, March 31, 2022 you will be locked out **until you have the required guide**. You can order 2022 now and have smooth sailing for the next three years.

Certificate Removal from VIR

The final step in our conversion to electronic emission test results will be eliminating the certificate from the Vehicle Inspection Results (VIR) which prints at the conclusion of a test. We will implement the removal in January 2022. After which, the VIR will print the same as before but will not have a certificate and will not have a certificate number on the VIR portion. The electronic procedure will then be the only way to show a passing emission test for DMV and subsequent licensing.
