The above link provides access to information about On-Board Diagnostic systems. You can find information on "known issues" for emission testing problems for various manufactures. We have included an example below. A condition which we have received many calls about. If you are experiencing difficulties communicating with, or having readiness issues for certain vehicle, or need the latest TSB information, this is a great resource. Of course you can still call our office and we will continue to assist you as well.

Technician Renewal and Practical

Any technician that has not completed a practical in 2022 will need to seek out your auditor or **schedule** a time to come to the Tech Center **prior to the new year**. Those **not** wishing to renew do not need a practical.

Updated Technician Warning Procedure

Technicians receiving a Warning will be provided the applicable Utah County Technical Bulletin or Utah County Ordinance information for the required policy infraction. The technician will be required to study the information and re-test. This will demonstrate their understanding of the policy for which they received the Warning. They must contact the county and schedule the retest within seven (7) calendar days of the Warning notice date. Failure to do so may result in suspension until the test is completed and passed.

Updated Station Warning Procedure

Stations receiving a Warning will receive applicable Utah County Technical Bulletin or Utah County Ordinance information for the required policy infraction. The Station is expected to require the Technicians to follow policy.

Non-communication Issue Ford Models

Testing Procedure (Work Around)

Some 2020-2021 Escape/Corsair, Bronco Sport, and 2021-2022 E-Series may exhibit a communication fault with emissions inspection equipment. If this concern occurs, turn off the ignition and remove the key (out of range), close the doors, and allow the vehicle to sit inactive for 5 minutes **OR** *disconnect the 12V battery for 10 seconds. After the 5 minute soak time (or reconnecting the 12v battery), reenter the vehicle, reconnect the emissions testing equipment and restart the emissions test following the emissions testing equipment instructions promptly.

*NOTE: <u>Disconnecting the 12v battery</u> will clear readiness thus causing a non-passing condition! This should be used as a last resort as the vehicle will need to successfully complete a drive cycle before passing the test.

It has been reported that Expeditions may also be included.
