"Mini-truck" imported Vehicles

With the influx of mini-trucks coming into our county Utah Dept of Motor Vehicles (DMV) has made the following determination.

The DMV has determined that in Utah, a mini truck can potentially be registered as one of the following:

- 1. Off-Highway
- 2. Implement of Husbandry (IOH)
- 3. Combined IOH
- 4. Street Legal ATV If they are able to pass the ATV Safety inspection.
- 5. Low Speed Vehicle regardless of fuel type (electric, gasoline, diesel) as long as the rest of the low-speed requirements are met.
 - 1. A low speed vehicle must be assessed as a passenger vehicle, not as a street motorcycle.
 - 2. Low Speed Vehicle are exempt from emissions

None of the above require an Emissions test and testing requests should be refused and referred to the DMV. Passing a non compliant mini-truck will result in disciplinary action as per appendix D of the Utah County Emissions Ordinance.

Station Sales and Certificate Security

When a station changes ownership a new station application must be submitted and a new permit issued. When the transfer of ownership occurs the analyzer must be locked out and the certificates issued to the previous owner must be removed. THE NEW BUSINESS CAN NOT USE THE CERTIFICATES STILL IN THE MACHINE. As the previous owner you are responsible for the proper use and security of those certificates. There are **criminal** penalties for not securing certificates issued to the station. If the analyzer is sold with the business, a separate bill of sale with the serial number and ES number will be required before the new owner can set up their station. If you don't know the serial number and ES number call the Tech Center. We can tell you what it is. It typically takes three business days to accomplish the switch if all of the required paper work is submitted at the onset. Don't leave the analyzer and business without notifying the Tech Center of the change in ownership. The value of the remaining certificates will be credited back to the business responsible for them.

Technician Renewal and Practical

Any technician that has not completed a practical in 2023 will need to seek out your auditor or **schedule** a time to come to the Tech Center **asap after January 1, 2024**. Those **not** wishing to renew do not need a practical.

2024 Emission Control Application Guide Available

The 2024 Emission Control Application Guide is now available. If you will be due for an updated manual next year you can order the 2024 now. Remember, you must have a guide that is no more than **three years old.** If your newest guide is 2021 you will need a newer one in January. If you go past the grace period, March 31, 2024 you will be locked out **until you have the required guide**. You can order 2024 now and have smooth sailing for the next three years.
