

**Storm Water Coalition Minutes**  
**Thursday, August 26, 2010**

1. Welcome and Roll  
School reports were handed out to Coalition members.
2. Update on Education Instructor/Julia Cole
  - A. Eighty nine (89) schools have been visited out of the ninety two (92) on the education list. A total of 8611 students were taught the storm water presentation during the 2009-2010 school year.
  - B. School materials have been purchase for the upcoming year.
  - C. It was announced that Julia Cole will be resigning. She said she would be willing to assist the new educational instructor as needed. She has enjoyed working with the Stormwater Coalition for Utah County.
  - D. Regarding the suggested quiz given to students after a class stormwater presentation brought up at the June storm water meeting - Glen reported that Julia gives an oral quiz is done with each class presentation.
3. Overview and Discussion of training
  - A. It was agreed by the coalition members to host a storm water training in 2011. A date in the month of February or March will be chosen. The Accena group will submit a cost and a schedule for the topics to be presented. It was suggested that they focus on subjects such as compliance and maintenance of SWPPs, goals, and HDAs. Other suggestions included having the training duration shortened and to have more than one classroom for training topics. This way each attendee can choose which training to attend rather than having everyone go over the same information they have covered at previous trainings.
  - B. Accena group will have training details to Glen Tanner before the next coalition meeting that will be held in September.
4. Excal training videos
  - A. Coalition members were encouraged to use the newly acquired storm water training videos to train city employees.
  - B. One of our new videos will be shown at the next storm water meeting schedule on September 30, 2010.
5. Report from sub-committees
  - A. Inspection Committee - Ryan Johnson (Orem City), Juan Garrido (Springville City), Don Overson (Vineyard City), Mark Atwood (Pleasant Grove), Scott Allen (Provo City)
    - There was a brief update regarding inspections. The state has a generic permit form. The form can be downloaded using an Excel or a PDF format.
  - B. Education committee - Steve Johnson (Orem City), Glen Tanner (Utah County), Paul Miller (Lindon City)
    - The committee will advertise the position for the storm water educator to replace Julia Cole. They will conduct interviews for the position. Once the notification is made for applicants, each coalition member will be notified.
    - Over flow funds from last year will be used to order extra educational handout materials for this next year. They will research other items that can be used to encourage storm water education.
    - The Utah County Fair outreach project went well. Everyone seemed to take the droplets, pencils, bags, magnets, and stickers. A thank you was expressed to all those that took time out of their week to go by the booth.
  - C. Discharge Committee - Nestor Gallo (American Fork City), Stan Orme (Orem City), Rustin Porter (Springville City), Don Reynolds (Accena group)
    - Nestor Gallo was approved to be the coordinator for the Discharge Committee.
    - First on his agenda is get all of the committee members contact information.

- The second item on the agenda is to prepare the Rational Statement & Procedures and present this information to the coalition members at the next meeting.
- D. Post Construction Committee - Trapper Burdick (Spanish Fork), Rick Sabey (Orem City), Curtis Chatwin (Lehi City), Juan Garrido (Springville City)
  - The goal of this subcommittee is to gather subcommittee contact information.
- 6. State Meeting overview - Juan Garrido (Springville City) and Steve Johnson (Orem City)
  - A. The fall conference and expo was the main topic covered at the State storm water meeting. SWAC also encouraged all municipalities to sponsor at least one, if not two, attendees to attend the fall conference and expo.
  - B. Harry Campbell (State - Construction) presented information about the construction industry. He emphasized the need to have industrial permits completed.
  - D. A Notice of Termination (NOT) that is not signed off by a municipality will not be recognized until it has been signed off by the municipality.
  - E. Mike Herkimer (State) will be stepping down from the supervisor position.
