2. Storm Water Instructor update

The educators report has gone out. If you need to have any changes contact Glen Tanner. Jenny has seen 18 schools in the Nebo and Provo school districts. The response for the Storm Water class has been very successful. We are now receiving calls from teachers asking to schedule Jenny to come to their schools.
3. County Storm Water Training

A tentative date for the next Storm Water Training was set for February 5, 2013. The other suggested date was February 19, 2013. February 5th was recommended by the coalition since it was early in the year and prior to other conferences and trainings scheduled for the up coming year. This also gives the coalition members time to attend the APWA Expo conference being held October 2-3. Coalition members were asked to see if they would like to invite any of the speakers they enjoy from the Expo to come to the Storm Water training. Having a date already scheduled for the County training on the calendar gives the Coalition a better opportunity to have instructors available for the training.

The Education Committee has been reviewing some ideas to set up a contest to have high school students design a poster for Storm Water education. The poster would then be turned into a billboard. Coalition members were asked to come up with some subjects that would be on the poster. Location is yet to be determined. The costs to have the poster made into a billboard will be forth coming. Some estimates for billboard monthly costs range from sixty five dollars and up depending on the location of the sign. Suggestions for the winning student were a cash prize or perhaps a scholarship prize. Any suggestions or ideas can be sent to Paul or Glen.

Next the coalition was asked if they felt the items being used for the schools and fairs were items that were enjoyed by the students and residents. The coalition felt the items were good items and there was no need to make any changes to the items at this time.

The next question presented by the Education Committee had to do with the annual reports and evaluating the measure of progress the coalition members are seeing in each of their cities. Lindon City said they do this with the number of violations they hand out to the public. They follow by seeing how the public responded and fixed the violation. They have seen the number of violations decreasing. The members of the Coalition have noticed that those in the landscaping industries are more inclined to make violations. It was suggested that the County training offered in February include education for owners and their employees in the landscaping industries. It was also suggested that a generic flyer be designed that can be sent out to all the Cities to help educate those in the landscaping industries.
