## 1. Welcome and Roll

  - A. Vote was taken on increasing per school visit from \$200 to \$250 which passed with a vote of 15-2. The amendment to the contract will include the \$250 per school and a cost of living based on the published consumer price index. A copy of the amendment will be provided to each city once it passes.
  - B. Budget adjustment figures were passed out so each city could prepare for the increase for 2016-2017 budgets. These figures are approximate and are subject to change as soon as Mountainland puts out an updated population count as well as any changes to schools. Updated figures will be given spring 2016.
  - C. There was discussion about quantifying if the presentation is really getting home to the parents. Discussion included idea of sending home a follow up or asking the students if they made any changes during the week following the presentation and offering a stormwater trinket (beach ball, frisbie, etc) as incentive to report.
  - D. There was discussion about video taping Jenny's presentation. School districts are not as open to this idea but Glen will check with a charter school and see if this could be arranged.
- 3. Discussion about Stormwater Awareness Study. There is a need for a random sampling of addresses to mail out questions with a self addressed stamped envelope. It was proposed that each city submit a certain number of randomly selected addresses from utility bills and the county will get randomly selected addresses from the County Assessor to create a sampling. This data will them be collected and submitted to BYU. Info needs to be collected by January 2016 if at all possible. Please submit your number of addresses to Glen Tanner by December 4, 2015.
  - A. It was proposed to also put those questions out on individual city web pages to try and get responses as well. It was proposed to add a question about elementary students sharing info from Jenny's presentation with parents at home.
- 4. Annual Stormwater Training will be held on Tuesday, March 8, 2016 at the Utah County Health & Justice Building. Breakfast will be offered. Discussion was held about ideas for trainings. It was suggested that we not hire AccenaGroup but ask people to teach two different breakout sessions. Ideas for sessions included: Low Impact Develop during the

development process, Rhonda Thiele discussing New Permit Requirements, and SWPP Development including NOT for Contractors and maybe what Harry is looking for.

Please email additional ideas or clarification of the ones above to Glen Tanner by Friday, November 20 so he can try to line up presenters. If you have a presenter in mind, please let him know. With the date change, it will be up to the cities to really push the training with businesses.
