Contract term 3 years.

Fixed price for contract term with no increases. Required

databases updated at least once per quarter:

All Utah state court, Utah federal district court and 10<sup>th</sup> Circuit court decisions.

Federal and Utah rules of civil and criminal procedure.

Utah State Code, United States Code.

Utah and US constitutions.

All federal district and Circuit courts and US Supreme Court.

Search results to indicate whether indicated cases have been overruled or have possible negative treatment.

Monthly fee includes unlimited use on 2 terminals.

No internet access to inmates through the provided program. Computer access must be site specific. No inmate access to any general search engines or other websites through the provided program.

System compatible with existing Utah County hardware. Software compatible with Windows XP and Windows 7

Final agreement to include the conditions of this bid and acceptable to Utah County Attorney's Office. Submit standard contract with bid.

Each party is responsible for and shall indemnify and hold the other harmless for their own acts, errors and omissions. County indemnification obligations are subject to the Governmental Immunity Act of Utah.

Access for two computers. One located in the inmate law library and one computer located in jail administration. Jail administration access to include all state and federal courts.
