 - A. <u>Inspection Committee</u> Ryan Johnson-Orem, Juan Garrido-Springville, Don Overson-Vineyard, Mark Atwood-Pleasant Grove, Scott Allen-Provo, Jeff Maag-Cedar Hills. The intent of the Inspection Committee meeting was to determine a collective terminology for municipalities to use on the land disturbance form. It was agreed that inspection form terminology is standard to all and no further changes will be required at this time.

- 6. State Storm Water program updates
 - A. Juan Garrido-Springville eported the State Storm Water webpage is up and running. It was recommended that all Coalition members go online to create their City account to log on and access the webpage. It was also recommended that they call the State office to activate their new account. They will have access to NOI information for their areas and be able to view all requests for permits.
 - B. Utah County Storm Water Coalition representative voting members are Juan Garrido-Springville and Steve Johnson-Orem. Ryan Johnson-Orem was added as the newest voting member to represent the Coalition at State meetings for a replacement if Juan or Steve are unable to attend.
- 7. Mark Crane's, EnviroCare Inc, presentation helped coalition members to see the importance of using caution and prevention regarding waste management procedures. He explained how they are working with cities as a full-service hazardous materials company. EnviroCare Inc. is working to train many companies and municipalities on preventive measures. 8. Ryan Dickson from ACCENA Group gave some demonstrations on how to use a web-based compliance system called ComplianceGo. He passed out a user guide. Once logged on to the program, a user will have password protection to their information. The system will automatically send email notifications regarding such things as inspections. It will notify customers of scheduled inspections and reports that are required by each City. The program has administrative and customer access. The Coalition will use this online program on a trial bases. No need for extra funds from Coalition members to use the ComplianceGo program since surplus funds will be used to start the program.
