Rather than having 1large training for the morning - breakout sessions are being considered. Suggestions for such sessions are: MS4s Responsibilities Industrial/Illicit Discharges (Industrial company requirements), Visit a construction site and do an inspection or BMP training, SWPP prep class (a step by step SWPP procedure), Show them how BMPs work and help them to create a site plan, Help them to learn how complete a SWPP permit application. How to help the HOAs on how an employer can train their own employees on Storm Water recording (By teaching the employers to train their own people to know how to do their site planning and SWPP record keeping, means less time and energy by Coalition members when doing a sites inspection). Suggestions to have students design poster boards that could be placed in local malls rather than billboards was discussed. A template was passed around to show some ideas. A poster board including some of the necessary information was passed around.

The Discharge Committee gave a presentation entitled Illicit Discharge Detection & Elimination. All Coalition members were encouraged to contact Nestor or any other coalition member to request copies of any forms, studies or templates that have been designed so that all the coalition member Cities can be up to date with their programs. Many of the studies are the same for the region and can be used by other coalition members to complete their programs. IDDE requirements were also included in the presentation. New State corrective action requirements were announced. The State has set time limits, 24 hours to correct a violation, 7 days to complete the work, 14 days to verify the work. Training videos have been developed to train city employees. Such videos can be electronically mailed to coalition members.  
A demonstration of two different kinds of water sampling machines was done to show how convenient and easy they are used. Coalition members were encouraged to get these machines to do their own water samples. The machines can show the BOD, Minerals, Ph balances, and many other readings for reporting and recording water samples. Having a water sampling machine although may be a larger expense in the beginning it can save time and money from sending samples to laboratories.
