IMMUNIZATIONS

1. Government provided Vaccines for Children (VFC) for State required vaccines for children on Medicaid and CHIP, Alaskan Native/American Indian children, uninsured children, and children whose insurance does not fully pay (under-insured) for immunizations.

Administration fee per vaccination is \$25. For payment made at the time of service, the administration fee will be discounted to \$16 per immunization.

2. For insurance covered vaccines, the fee will be set by analysis of customary payments by insurance companies and the cost of vaccines plus a \$25 administration fee per dose of vaccine.
3. For non-insurance covered vaccines paid at the time of service the discounted fee will be vaccine cost rounded up to the next dollar plus a \$16 administration fee per dose of vaccine.
4. School immunization exemption is a \$25 administration fee per child for all years of Utah school attendance.

ENVIRONMENTAL HEALTH

NOTE:

Establishments that open without a permit will be assessed a double permit fee + the expedited plan review fee. All fees will need to be paid prior to inspection.

Overdue Payment: 20% for each 30 days late. Permit is revoked after 60 days past due.

Plan Reviews will be completed within 15 business days. Expedited plan reviews will be completed within 5 business days.

Establishments that fail to complete the renewal process within 60 days will have their permit revoked. The owner/operator will need to apply and pay for a new permit.

FOOD SERVICE

Food establishments that fail to complete the renewal process within 60 days will have their permit revoked. The owner/operator will need to apply and pay for a new permit.

Class 1: under 1,000 sq. ft.

Class 2: 1,001 – 3,000 sq. ft.

Class 3: 3,001 – 5,000 sq. ft.

Class 4: over 5,000 sq. ft.
