Article 28-1. Consolidation of County Offices of County Clerk and County Auditor

28-1-1. Consolidation of County Offices of County Clerk and County Auditor

(a) The duties, functions and responsibilities of the county offices of the Utah County Clerk and the Utah County Auditor are hereby consolidated, with the consolidation to take effect on September 5, 1989.

(1) The consolidation of the county offices of the Utah County Clerk and the Utah County Auditor shall create the consolidated office of the Utah County Clerk/Auditor effective on September 5, 1989.

(2) The consolidated office of the Utah County Clerk/Auditor shall perform the statutory duties of the County Auditor as enumerated in Title 17, Chapter 19, Utah Code Annotated, 1953 as amended, and the statutory duties of the County Clerk as enumerated in Title 17, Chapter 20, Utah Code Annotated, 1953 as amended.

(3) Only one person shall be elected to the consolidated office of Utah County Clerk/Auditor at the general election held in November, 1990. The elected Utah County Clerk/Auditor shall be entitled to one annual salary, the annual salary for the Utah County Auditor as fixed by the Board of County Commissioners of Utah County, Utah.

(4) The term of office for the consolidated county office of Utah County Clerk/Auditor shall be a term of four (4) years commencing on the first Monday in January, 1991, with each succeeding term to be four (4) years thereafter. (Ord. 2004-02, 2-17-04)

Utah County Code

(a) The duties, functions and responsibilities of the previously consolidated offices of the Utah County Recorder and the Utah County Surveyor are hereby separated, with the separation to take effect at noon on January 3, 2011.

(1) The separation of the previously consolidated offices of the Utah County Recorder and the Utah County Surveyor shall create separate county offices of the Utah County Recorder and the Utah County Surveyor effective at noon on January 3, 2011, pursuant to the provisions of Section 17-16-3(3)(b), Utah Code Annotated, 1953 as amended.

(2) The separated office of the Utah County Recorder shall perform the statutory duties of the County Recorder as enumerated in Title 17, Chapter 21, Utah Code Annotated, 1953 as amended.

(3) The separated office of the Utah County Surveyor shall perform the statutory duties of the County Surveyor as enumerated in Title 17, Chapter 23, Utah Code Annotated, 1953 as amended.

(4) Pursuant to the provisions of Section 17-16-3, Utah Code Annotated, 1953 as amended, the separation of the previously consolidated county offices of the Utah County Recorder and the Utah County Surveyor shall take effect at noon on January 3, 2011, and one person shall be elected to the separated office of Utah County Recorder, and another person shall be elected to the separated office of Utah County Surveyor, at the general election held on November 2, 2010. The elected Utah County Recorder and the elected Utah County Surveyor shall each be entitled to a separate annual salary as fixed by the Board of County Commissioners of Utah County, Utah.

(5) The term of office for the separated county offices of the Utah County Recorder and the Utah County Surveyor shall each be for a term of four (4) years commencing at noon on January 3, 2011, with each succeeding term to be four (4) years thereafter.

(6) The separation of the previously consolidated county offices of the Utah County Recorder and the Utah County Surveyor shall not, in any way, affect the term of office of the currently elected Utah County Recorder/Surveyor, which term shall expire at noon on January 3, 2011.
