# UTAH COUNTY AUDITOR'S OFFICE TRANSIENT ROOM TAX MONTHLY RETURN

## GENERAL INFORMATION

**IF BUSINESS WAS DISCONTINUED OR NEW BUSINESS STARTED OR IF THERE HAS BEEN A CHANGE OF OWNERSHIP, ATTACH A STATEMENT OF EXPLANATION.**

Transient room tax is imposed by Utah County on all operations of motor or trailer courts, hotels, motels, and similar public accommodations on the amount charged for every occupancy subject to sales tax.

This monthly return should be used by businesses with a tax liability of \$50,000 or more for the previous calendar year. Businesses with a tax liability of less than \$50,000 should file a quarterly return but may opt to file a monthly return.

This return must be filed even if no tax is due. Return the entire form to Utah County with any payment due; keep a copy for your records.

Make check or money order payable to: UTAH COUNTY AUDITOR'S OFFICE.

This return must be postmarked on or before the applicable due date:

If the due date for filing a return falls on a Saturday, Sunday, or legal Utah County holiday, you may file your return on the next business day.

Late fees in the amount of \$20 or 10 percent of the reporting month's tax due, whichever is greater, will be assessed on returns filed past the due date.

**AMENDED RETURNS** - To amend a previously filed return, please check the "Amended Return" box below the "Account Number" box and enter the tax period being amended in the "Tax Period" box. Amended returns should be filed with corrected amounts (not net amounts). Calculate any refund or balance due by subtracting the original payment from the corrected tax due. Submit payment of the balance due or send a letter to the Utah County Auditor's Office requesting a refund of an overpayment. Failure to pay all additional tax and interest could result in additional charges.

Utah County has elected to directly collect its transient room tax. This transient room tax return should only be used to report tax for businesses located in Utah County.

## INSTRUCTIONS

- Column 1** Enter the total **taxable charges** for accommodations. (Do NOT include occupancies for continuous periods of 30 or more days or other exemptions provided by the Sales and Use Tax Act in *Utah Code Annotated* Title 59, Chapter 12).
- Column 2** Tax rate for Utah County.
- Column 3** Total tax due (taxable amount from column 1 multiplied by the tax rate in column 2).
