PERMIT SUBJECT TO THE FOLLOWING CONDITIONS:

1. Prior to burning- Notify the local police and fire authorities by accessing the website: utahcounty.gov/burn; a link can be found at utahcounty.gov.
2. *When atmospheric conditions (clearing index) indicates it is satisfactory to burn. This information may be obtained at the website listed above. (Applies to Open Burn Permits only). Note: for those without internet access call 801-374-2876
3. Burning shall not be done when circumstances make such fires hazardous; i.e. high winds, red flag, etc.
4. Burning shall be done at a distance of more than 50 feet from any building, structure, or other combustibles.
5. An adequate water supply or other fire extinguishing equipment shall be available.
6. The burning area shall be constantly attended by a competent person and shall be completely extinguished before being left. All fires shall be completely extinguished before dark.
7. Applicant must be in legal control of the land on which the burning is to take place.
8. Approved fuel breaks shall be established between the controlled burning area and any endangered property. (The width of fuel breaks shall be determined by height, type, and amount of growth, wind conditions, geographical conditions, and type of exposure.)
9. Adjacent neighbors shall be notified prior to burning.
10. Such burning shall not pose a threat to forest, range, or watershed lands.
11. Notification by applicant to the BURN notification website is required for each day of burning.
12. Applicant agrees to burn only during valid burning dates for which permit is issued.
13. Applicant certifies that their burn site is located in unincorporated Utah County, and understands this permit does not allow burning in city limits.

*REQUIRED CONDITIONS FOR OPEN BURN PERMITS; RECOMMENDED FOR AGRICULTURAL PERMITS

- FAILURE TO COMPLY WITH ALL CONDITIONS MAY RESULT IN A CITATION BEING ISSUED TO APPLICANT AND/OR REVOCATION OF THIS PERMIT.

- ABSOLUTELY NO BURNING OF TIRES, PLASTIC PRODUCTS, COATED WIRE, OR BUILDING PRODUCTS. ITEMS NOT GROWN ON THE PROPERTY, CANNOT BE BURNED.

A burning permit is subject to the laws of the State of Utah, Utah County laws, and the conditions stated upon permit. The Utah County Fire Marshal reserves the right to refuse, revoke, or postpone the permit when the Fire Marshal deems it necessary to prevent danger to life or property. This permit shall in no way relieve any individual from personal liability due to neglect or incompetence. Any person responsible for the existence or spread of fire necessitating suppression action shall be liable for the payment of costs.
