UTAH2011 UPDATE

During the fourth quarter of 2009 Utah's four I/M counties collectively solicited qualified vendors for the new UTAH2011 vehicle emissions program equipment. Under the leadership of Salt Lake County an RFP was published. A selection committee consisting of representatives from each county evaluated each of the four responses and selected an equipment vendor to provide UTAH2011 program products and services.

Unfortunately, some minor procedural problems resulted in Salt Lake County withdrawing the original RFP, effectively voiding all prior work done in the selection process. Salt Lake County has indicated they intend to put out a new revised RFP most likely in the first quarter of 2010. Salt Lake County also indicated they would be selecting a vendor for their program without including the other I/M counties participation.

Utah County will be closely watching this new RFP and depending on the outcome may get onboard if we agree with the SLC vendor selection. Another possibility would be for Utah County to put out our own RFP or combine our efforts with Davis and Weber Counties similar to the Utah2000 RFP.

Hopefully this will only be a minor setback and Utah's four I/M counties can successfully standardize our programs. At this point we feel our original implementation target date of April 2011 is still possible.

TSI Testing Difficulty on 1996 + Heavy Duty Vehicles

Some drive-by-wire Heavy Duty Vehicles, particularly 2007 and newer GM vehicles, may experience difficulty in completing the TSI inspection. Severe engine RPM surging during the high speed portion of the test may cause the count down timer to reset repeatedly. We've found that controlling the gas pedal with your hand rather than your foot may make it easier to respond to these rapid and violent fluctuations in engine speed.

If, after you've made an honest attempt to complete a TSI test on one of these vehicles without success you may call our office for further instructions on an alternate inspection procedure.
