
TENTATIVE CLASS SCHEDULE FOR 2018



OBD Tamper Visual Inspection Failure Procedure

Procedure clarification on O2 extender type of OBDII tampering and the process required for inputting the failure. The Utah County Emission Ordinance 9.10.2 requires that **any** type of defeat device for the onboard diagnostic system be failed during the visual inspection portion of the emission test. We will be verifying that you can identify and fail O2 sensor extenders specifically. Violations may result in suspension of your station permit and/or mechanic permits. Images are included of an Oxygen sensor extender and a screen shot of the analyzer page that you are to record the failure on.





Do not fail the Catalytic converter for O2 extenders, fail the OBDII system.
