Chase Hale of American Heritage Schools stated these parcels are used for overflow parking. There was a discussion between the Board and Mr. Hale on ways the school could more easily meet the qualifications for a tax exemption. A large part of the discussion centered around combining multiple parcels into one larger parcel. However, Deputy Attorney Paul Jones wanted to clarify that any ideas or thoughts that were discussed by the Board in this regard may not necessarily be in harmony with the school's long-term plans or city building ordinances. He stated this discussion should not be construed as advice from the Board to the school on how to proceed in the future.
