Karrie Galloway, CEO of Planned Parenthood Association of Utah, stated that they had provided 6,258 residents of Utah County with family planning services.

The BOE made the following findings regarding Agenda Item No. 12:

With the question whether Standards IV and V are met, Standard IV requires that the policies of the organization integrate and reflect the public interest. Planned Parenthood's services as an organization do not reflect the public interest of the residents of Utah County. We have sent several children to Planned Parenthood to obtain birth control pills and they were handled over with no attempt to contact parents. There was no attempt to notify the parents at all and the thirteen-year old girls who went were Type 1 diabetic. This does not align with the public interest of Utah County. Virtually every parent in the county would want to know if their little girl was being given hormonal birth control that could have serious, even life-threatening, impacts. Also, the comments to Standard IV and in Standard V are referenced made to "gifts" of the organization. Planned Parenthood calculates their "gift" at over \$400,000 in services. However, they fail to calculate the cost of their organization to the community. By the last statistics I have seen, approximately 379 babies from Utah County mothers per year are killed in Planned Parenthood facilities. Noting, not the one here, but they are part of referrals and sending them. How do we value their lives? How to calculate what they would have contributed to Utah County and to other communities? If we are calculating value and so called "gifts", we would argue that the value of 379 Utah County residents per year is incalculable and completely eclipses the \$400,000 in services rendered. The cost of their services is far too great.
