4. BYU Field Study

State Report & Meeting:

As reported by Richard Hatfield, Provo City:

State Storm Water Committee will now be under the umbrella of the APWA. The group will be structured with a representative from each county. We need to look at an individual to represent our coalition. They are currently working on a model ordinance for all cities. They are looking at different ways to fund the committee. One proposal is to write a letter to the Department of Environmental Quality to request funding. They are also working on trying to unify the certification for contractors throughout the state. They have requested coalition members to submit any test questions they would like to see on the Storm Water Contractor Tests.

Other Business:

Flood Plain Conference will be held in St. George on November 20-21, 2008. They are requesting assistance from coalition members to supply speakers and/or information regarding their progress of storm water training. It was proposed to send pictures of Julia in the classroom training setting.
