1. Welcome and Roll
2. Storm Water Instructor update

3. County Storm Water Training

Class # 2: Site BMPs- Implementation through permit termination, What to install, When to install, What to maintain, Terminations Specifics.  
  
Class #3: Industrial Facility SWPPP training: MS4 oversight responsibilities related to phase II permit/IDDE, What private companies/businesses must do to be compliant.  
  
Field Class 60 minutes: This class will be held if weather permits:  
An onsite field inspection using the state form MS4 and contractor considerations.
