1. Welcome and Roll

3. County Storm Water Training

  - D. Post Construction Committee - Trapper Burdick(Spanish Fork City), Steve Weber(Orem City), Curtis Chatwin(Lehi City), Juan Garrido(Springville City)  
Steve Weber was welcomed as the newest of the post construction committee members. At this time, every City needs a template for MS4 Ordinances. PMPs maintenance is to be done by the owners. Alpine City broke up the ordinance into two portions. The first is the manual and the second is the agreement. This will be emailed to the Coalition members for them to review and use it if this works for them. The goal of the EPA is to have more PMP tracking and maintenance. The Coalition’s goal with this procedure is to assist with the EPA goals.  
  
Steve Weber/Orem City gave an update regarding the Construction General permit. Glen Tanner nominated Steve Weber be the representative to attend the construction permit review meetings. Nomination passed with all Coalition members in agreement.  
Nestor Gallo was nominated to represent the Coalition at the Industry Illicit meetings. Nomination passed with all Coalition members in agreement.
5. State Storm Water program updates  
  
The web dashboard page has been updated by the State. If a coalition member had created a shortcut, the link is now obsolete. They will need to create a new access. Go to the Administrator access and put in their user name and password to update the link. If you are having issues with the site, contact Monequa Rodriguez.  
  
Cancelling the NOI/NOT is to be done by the Contractor/Operator electronically or by faxing the request to cancel. The State will then send a copy to the City Storm Water Coalition member. Some have been receiving these.  
  
Juan Gurrido/Springville City gave synapses regarding the Construction General Permit review meeting. The permit has a total of 95 pages which causes some concern. Recommendations have been given to use a template for the agreement referencing the permit. This creates some agreement issues. The issues will continue to be reviewed. There are also issues regarding the Common Plan of Development which has 65 pages. This also is under review. It is hoped that all of this can be resolved before the Permits are released to the public for public comment. It was suggested that representatives from the Coalition go directly to the State Office to go over the permit and make the changes the Coalition suggested.

Ryan Johnson/Orem City was nominated to represent the Coalition at the RSI Committee State meetings. Nomination passed with all Coalition members in agreement.

Paul Miller/Lindon City brought a printed copy of the mouse pad page that they have created for their Coalition. This was reviewed by the members. The link on the web page shows storm water links and phone numbers for those who view the web page. The addition of the Utah County hot line and email address will be added to the page.
