7. Matt Stayner from UtiliSync demonstrated to the Coalition a new App to customize construction management tracking. They have developed the app along with Bowen & Collins so that it can be used with wifi to layer information regarding inspected sites by storm water management. All the information can be added on site. With added information that can be done back at the office to create a paperless tracking system. It was brought out the USWAC and EPA will soon be requiring all tracking be done electronic formats. The cost for their App will be billed as a City. For the Reporting App the cost is \$120 per month. For the App with extra reporting forms and applications the cost is \$150 per month with multiple users. 8. Rebecca Andrus (Salem City) gave a power point presentation on the topic of water harvesting and water rights. She explained that the laws have changed since the 1970s. She gave a brief description of Bill 36. Her research found that a parcel can store up to 2,500 gallons of water as long as it is released and not used for any benefit after it has been stored. This 2,500 gallons of water stored is per parcel not per parcel size. This is in regards to rain water and gray water. Gray water is a different subject all together. There are many variables that need to be taken into consideration. Each coalition member would need to do research in regards to the compliance of their own City. In regards to Storm Water inspected sites, she recommended that it would be best to refer the parcel owner to the State and Federal guidelines found online, then leave the issue with the parcel owner and the State.
9. State Storm Water Meeting USWAC  
Breaking News:  
MS4 Permits expire July 1, 2015.  
A new NOI needs to be submitted. It was due January 1, 2015. All members are expected to re-submit their NOI no exceptions. The form will be sent to Nestor who will distribute them.  
The Industrial web site is in an update process. The two permits are being revised to condense the size.  
The EPA is moving towards electronic submittals and recording. Having an electronic data tracking system is recommended for all Cities.
