

Financial Disclosure Information

ONLY FOR COUNTY AND LOCAL SCHOOL BOARD CANDIDATES

- Your first financial disclosure is due no later than 7 days before County Convention
 - Only applicable to candidates who participate in County Convention
- If you are eliminated at County Convention, a separate financial disclosure is due no later than 30 days after County Convention
- If you are a candidate that appears on the Primary Election ballot, a financial disclosure is due no later than 7 days before the Primary Election
 - Failure to file this financial disclosure will result in you being eliminated from the Primary Election
- If you are eliminated in the Primary Election, financial disclosure are due no later than 30 days after the Primary Election
- If you are a candidate that appears on the General Election ballot, a financial disclosure is due no later than 7 days before the General Election
 - Failure to file this financial disclosure will result in you being eliminated from the General Election
- All candidates that appear on the General Election ballot are required to file a financial disclosure no later than 30 days after the General Election
- If you are a current county or school board officer, the first financial disclosure that you file in 2024 must include all of the required information since your last financial disclosure was filed.
