Declaration of Candidacy Filing Period Dates:

For **qualified political party candidates**, filing begins on Tuesday, January 2, 2024 and ends at 5:00 p.m., Monday, January 8, 2024.

For **registered political party candidates**, filing begins on Tuesday, January 2, 2024 and ends at 5:00 p.m., Monday, April, 29, 2024.

For **local board of education candidates**, filing begins on Tuesday, January 2, 2024 and ends at 5:00 p.m., Monday, January 8, 2024.

For **Lieutenant Governor candidates**, filing begins on Tuesday, January 2, 2024 and ends at 5:00 p.m., Monday, April, 29, 2024.

For **Unaffiliated Lieutenant Governor candidates**, filing begins on Tuesday, January 2, 2024 and ends at 5:00 p.m., Friday, July, 5, 2024.

For **judges of a court of record and justice court judges**, filing begins Monday, July I, 2024 and ends at 5:00 p.m., Monday, July 15, 2024.

The Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Tuesday, January 2, 2024 and ends at 5:00 p.m. on January 8, 2024.

Qualified political party candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office.

Registered political party candidates must submit nomination petition signatures no later than April I, 2024.
