



NOTICE OF ELECTION 2026 REGULAR GENERAL ELECTION

I, Aaron R. Davidson, Clerk of Utah County Utah, in accordance with Utah Code Annotated § 20A-5-101, do hereby notify the voters of Utah County that:

1. attached is a list of the offices to be filled at the regular general election to be held in Utah County, Utah on Tuesday, November 3, 2026;
2. attached is a list of filing fees and the filing location;
3. the Declaration of Candidacy filing period for qualified political party candidates begins on Friday, January 2, 2026 at 8:00 a.m. and ends at 5:00 p.m., Thursday, January 8, 2026;
4. the Declaration of Candidacy filing period for local board of education candidates begins on Friday, January 2, 2026 at 8:00 a.m. and ends at 5:00 p.m., Thursday, January 8, 2026;
5. the Declaration of Candidacy filing period for registered political party candidates begins on Friday, January 2, 2026 at 8:00 a.m. and ends at 5:00 p.m., Monday, April 27, 2026;
6. the Declaration of Candidacy filing period for justices and judges of a court of record begins Wednesday, July 1, 2026 and ends at 5:00 p.m., Wednesday, July 15, 2026;
7. the Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Friday, January 2, 2026 at 8:00 a.m. and ends at 5:00 p.m., Thursday, January 8, 2026;
8. qualified political party candidates must submit nomination petition signatures no later than 14 calendar days before the day on which the qualified political party holds its convention to select candidates for the elective office;
9. registered political party candidates must submit nomination petition signatures no later than 5:00 p. m., Tuesday, March 31, 2026;
10. the Declaration of Candidacy filing period for candidates not affiliated with a political party begins on Friday, January 2, 2026 at 8:00 a.m. and ends at 5:00 p.m., Monday, June 15, 2026; and
11. candidates not affiliated with a political party must submit certificates of nomination no later than 5:00 p.m., Monday, June 15, 2026.



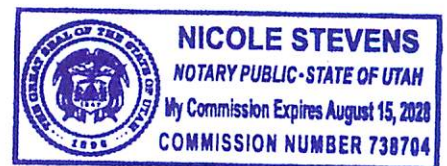
