Ballot Questions

Proposition #8 (Salem Residents)

Shall Salem, Utah (the "City") be authorized to impose a sales and use tax of one-tenth of one percent (0.1%) to provide revenues for purposes related to Recreational (Including Parks), and Cultural Facilities and Organizations (commonly known as the "RAP TAX")* within the City for a period of ten (10) years?

Note: The tax rate of one-tenth of one percent (0.1%) is equal to one cent (\$0.01) for every ten dollars (\$10.00) spent on sales tax-eligible purchases within Salem City.

Funds collected from this tax may be used for RAP capital improvements of publically owned or operated amenities such as, but not limited to:

- Long-term planning for recreation and parks; including playing fields and courts
- Upgrades for senior activities and facilities
- Arts and cultural programs & organizations
- Trails and pathways
- Improvements to parks, recreational spaces and programs

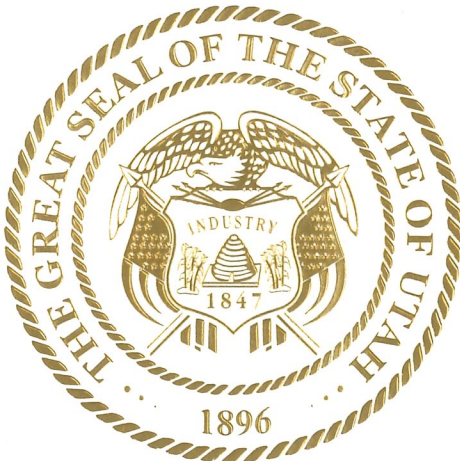

I, Deidre M. Henderson, Lieutenant Governor of the State of Utah, do hereby certify that:

1. Pursuant to Utah Code Annotated § 20A-5a-209(2)(a), candidates whose names appear on the attached list are qualified for placement and shall appear on the 2026 General Election ballot; and,
2. Pursuant to Utah Code Annotated § 20A-5a-209(2)(b), candidates' names shall appear on the 2026 General Election ballot as written and in the order listed on the attached list; and,
3. Pursuant to Utah Code Annotated § 20A-12-201(3)(a), the names of the following judicial offices subject to retention election shall appear on the 2026 General Election ballot; and,
4. Pursuant to Utah Code Annotated § 20A-5a-209(2)(c), no statewide ballot propositions have qualified for placement on the 2026 Utah General Election ballot; and,
5. Pursuant to Utah Code Annotated § 20A-7-103(4), the following proposed constitutional amendments as passed by the Utah State Legislature shall appear on the 2026 General Election ballot; and,
6. Pursuant to Utah Code Annotated § 20A-8-106(2)(b), the following official political parties are currently registered in Utah; and,
7. Pursuant to Utah Code Annotated § 20A-5a-210, a county clerk shall publish the required notice for the county, as a class A notice, for 30 calendar days, no earlier than Monday, August 31, 2026, and no later than Wednesday, September 2, 2026.

B. Written procedures for election officials to use the Master Ballot Position List.

In accordance with Utah Code § 20A-6-110, election officers shall use the Master Ballot Position List for 2026-2027 to determine the order in which to list candidates on the ballot for any election held during those years. To determine the order in which to list candidates on the ballot, the election officer shall apply the randomized alphabet as so:

- The candidates' legal surnames as listed on the declaration of candidacy.
- If two or more candidates have legal surnames that begin with the same letter, the list shall be applied to each subsequent letter in the candidates' legal surnames as listed on the declaration of candidacy.
- If two or more candidates list identical surnames on the declaration of candidacy, the list shall be applied to the candidates' legal given (first) names as listed on the declaration of candidacy or, if a candidate filed a name affidavit under Utah Code § 20A-6-109, as listed on the name affidavit.

C. Written procedures for the Lieutenant Governor in conducting the randomization in a fair manner and record of the random selection process used.

The Office of the Lieutenant Governor will conduct the randomization process by drawing wooden letter tiles from an opaque bag and following these procedures:

1. A wooden tile with each letter of the alphabet printed is to be placed in an opaque bag.
2. Three individuals are to be selected to draw tiles out of the bag.
3. The order the individuals draw tiles out of the bag is selected at random by rolling a die. The person rolling the highest number on the die picks first, the second highest roller picks second, and the lowest roller picks third.
4. Ties are broken by rolling the die until one of the individuals in the tie rolls a number that is higher than the other person they are tied with.
5. Letters are pulled out of the opaque bag until all tiles are removed.
6. The order the tiles were picked from the bag becomes the Master Ballot Position List. For example, the first tile pulled being the first letter on the list, the second tile pulled being the second on the list and so on.

The randomization was done on Monday April 6, 2026, at 4:00 p.m. in the rotunda of the Utah State Capitol. Notice of the meeting was published on the Public Notice Website and broadcast live on Zoom. A recording of the meeting can be found on the www.vote.utah.gov website.
