COMMISSIONER LEE: SUGGESTED REFERRING TO THE PLANNING COMMISSION. RECOMMENDED TWO OPTIONS. OPTION #2 HAS GOT MORE PROBLEMS THAN OPTION #1.

COMMISSIONER AINGE – HAS NOT RECEIVED MUCH RESPONSE FROM THE CONCERNED PROVO RESIDENCE. PORTION OF DEVELOPMENT IS IN THE CITY OF PROVO. EVEN THE UNINCORPORATED PORTION IS WITHIN PROVO'S ANNEXATION PLAN. DOESN'T SEE THIS AS FEASIBLE WITHOUT CONNECTING TO PROVO CITY WATER AND SEWER. THE DEVELOPER INDICATED THAT THE INTENTION IS TO DEVELOP IN THE COUNTY AND THEN ANNEX TO THE CITY. STRONGLY DISCOURAGES THIS KIND OF DEVELOPMENT WITHIN THE COUNTY.

COMMISSIONER LEE - TR5 ISSUE IN THE COUNTY HAS BEEN PROBLEMATIC OVER THE YEARS. THIS NEEDS TO GO BACK AND HAVE A SERIOUS CONTEMPLATION OF TR5. NEED TO TAKE A LOOK AT THE ZONES AND SEE WHAT IS APPROPRIATE AND DISCUSS WITH PLANNING COMMISSION.

COMMISSIONER IVIE – SUGGESTED REFERRING THIS TO THE PLANNING COMMISSION TO DISCUSS HOW TO NOT HAVE THIS PROBLEM IN THE FUTURE. NEED TO MAKE AN ADJUSTMENT TO ZONING LAWS TO INSURE COHESIVENESS.

ANGELA MERRICK/PROVO RESIDENT – REQUESTING THAT THE COMMISSION LOOK HARDER AT THE BIGGER VISION. POTENTIAL DOMINO AFFECTS ALL THE WAY UP PROVO CANYON. PROVO FOOTHILLS NEED MORE PARKS, PARKING AND TRAILS. PEOPLE ARE VOTING FOR MORE PUBLIC ACCESS. WE NEED TO CAPITALIZE ON THE FOOTHILLS THAT WE HAVE.

SCOTT G. SMITH/RESIDENT OF PROVO – HIS CONCERNS ARE REGARDING RIGHT-OF-WAYS TO THE ORCHARD. HAS IRRIGATIONS LINES. OWNS OVER 51 ACRES. WOULD LIKE TO HAVE A HEADS UP ON WHAT IS GOING TO HAPPEN.

HELENA CARTER-THOMAS – FROM A DEVELOPER'S STANDPOINT, SUGGESTED IF THEY REQUIRE UTILITIES FROM THE CITY, THEY SHOULD ANNEX AT THAT TIME.

SHANNON BINGHAM/PROVO RESIDENT – REQUESTED TO BE REVIEWED. PROVO CITY COUNCIL UNANIMOUSLY VOTED AGAINST THE ZONE CHANGE LAST WEEK. THIS TYPE OF DEVELOPMENT IS NOT A SUSTAINABLE DEVELOPMENT. SHARON HYATT/RESIDENT OF EDGEMONT – FEELS THIS WOULD BE UNSTABLE GEOLOGICALLY CAUSING LANDSLIDES. ALSO CONCERNED ABOUT THE WILDLIFE.

PEGGY KELSEY/COMMUNITY DEVELOPMENT – STATED THAT THE INTENT OF BRYCE ARMSTRONG, WAS TO HAVE AN EITHER/OR. IF BOTH ARE REFERRED BACK TO THE PLANNING COMMISSION, IT'S GOING TO BE TOO MUCH DATA TO GO THROUGH SO WOULD LIKE IT TO BE NARROWED DOWN WITH SUGGESTION FROM THE BOARD AS TO WHICH ONE THEY WOULD LIKE US TO DO.

COMMISSIONER AINGE – HAS NOT WANTED TO REFER OR MODIFY OUR COUNTY ORDINANCES TO ONE, SINGLE INCIDENT. THERE IS NO ACTION THE COUNTY IS TAKING. THERE HAS BEEN NO APPLICATION. NOTHING HAS HAPPENED AT THE COUNTY LEVEL. THIS ACTION IS TO REVIEW GENERALLY.
