1. APPROVE AND AUTHORIZE THE ADOPTION AND IMPLEMENTATION OF A NEW COUNTY STORMWATER ORDINANCE

RICHARD NIELSON, PUBLIC WORKS DIRECTOR - RICHARD NIELSON, PUBLIC WORKS DIRECTOR WITH GLENN TANNER FROM PUBLIC WORKS ALSO. COMMISSIONERS THIS, WE HAD A CONVERSATION LAST WEEK WITH COMMISSIONER AINGE, WE HAD THIS ON AN ITEM ON THE AGENDA, I BELIEVE TWO WEEKS AGO AND WAS ASKED TO GIVE YOU SOME ADDITIONAL TIME TO LOOK AT IT. WHAT THIS ORDINANCE IS, A BRAND NEW ORDINANCE THAT'S COME ABOUT BECAUSE OF THE RULES THAT ARE IN PLACE FROM THE EPA THROUGH THE STATE REGARDING STORMWATER. THERE'S BEEN RULES IN PLACE FOR MANY YEARS; FOR A LOT OF THOSE YEARS THE COUNTY WAS UNDER AN EXEMPTION THAT WAS GRANTED THROUGH THE STATE BECAUSE OF OUR POPULATION IN THE UNINCORPORATED COUNTY. A FEW YEARS AGO. THE STATE SAID NO, YOUR EXEMPTION IS NO LONGER VALID, YOU HAVE 650,000 PEOPLE IN THE COUNTY AND WITH THE PROXIMITY TO THE OTHER MUNICIPALITIES THAT ARE REQUIRED TO HAVE PERMITS, THEY REQUIRED THE COUNTY TO GET PERMITTED AS WELL. I DON'T KNOW, IT'S ABOUT FIVE YEARS AGO THAT WE STARTED THIS, SENT THE PAPERWORK IN FOR A PERMIT THROUGH THE STATE, CALLED AN MS4 AND I COULDN'T TELL YOU WHAT THAT ACRONYM STANDS FOR, ANYWAY THE STORM WATER SYSTEM.

COMMISSIONER LEE - CAN I JUST ASK YOU A QUESTION?

RICHARD NIELSON - PLEASE.

COMMISSIONER LEE - YOU SAID THE STATE, THEY GAVE US NOTIFICATION? HOW THAT COME ABOUT?

RICHARD NIELSON - WHEN THEY TOOK OUR EXEMPTION AWAY?

COMMISSIONER LEE - YES.

RICHARD NIELSON - THE EXEMPTIONS HAD A TIMEFRAME ATTACHED TO THEM, THEY WOULD GO LIKE A FIVE-YEAR PERIOD AND SO WHEN OURS WAS UP FOR RENEWAL, THEY WOULDN'T RENEW IT. SO, WE WERE GIVEN, AND I COULDN'T TELL YOU EXACTLY WHAT THE NOTIFICATION WAS, IT WAS AN EMAIL OR A HARD COPY LETTER, I'M SURE WE CAN GO BACK AND FIND IT, BUT IT WAS, WE WERE TOLD AT THAT POINT IN TIME THAT OUR EXEMPTION WAS NO LONGER VALID, AND WE HAD TO GO THROUGH THIS AND PERMITTING PROCESS.

COMMISSIONER LEE – OKAY. SO, IT'S NOT WRITTEN IN WRITTEN ANY CODE OR ANY STATUTE THEN?

RICHARD NIELSON - IT IS AND THEN IT TALKS ABOUT IT'S BASED ON POPULATION AND ALSO PROXIMITY TO OTHER PERMITTED USERS. SO, I'LL USE LIKE SAY MAPLETON FOR INSTANCE. IF SPRINGVILLE AND SPANISH FORK ARE BOTH PERMITTEES, MAPLETON STILL IS MAY BE UNDER THAT THRESHOLD FOR POPULATION, BUT BECAUSE OF THEIR PROXIMITY TO THE OTHER TWO, THEY COULD BE REQUIRED TO HAVE IT. SO, THE STATES KIND OF LOOKED AT IN TWO WAYS. ONE, THEY'RE SAYING OUR POPULATION COLLECTIVELY AT THE COUNTY IS WELL OVER THAT THRESHOLD AND THEN ALSO BECAUSE OF ALL OF THE MUNICIPALITIES THAT ARE IN THE COUNTY THAT ARE OUR PERMIT HOLDERS, THAT WE HAD TO BE AS WELL.

COMMISSIONER LEE – OKAY.

COMMISSIONER AINGE - IF I UNDERSTOOD IT, IT WAS THAT WE HAVE A STATUTORY OBLIGATION FOR THIS, IT WAS JUST THAT WE HAD AN EXEMPTION.

RICHARD NIELSON - YES.

GLENN TANNER, ASSOCIATE DIRECTOR, PUBLIC WORKS - CORRECT.

COMMISSIONER AINGE – RIGHT? AND SO THAT'S THE QUESTION. SO, THE STATUTORY REQUIREMENTS ARE PRETTY CLEAR, BUT BECAUSE THE EXEMPTION CAN BE GRANTED OR WITHDRAWN,

RICHARD NIELSON - YEAH.

COMMISSIONER AINGE - THAT'S WHY WE'RE KIND OF SUBJECT TO THIS OBJECTIVE REASON.

RICHARD NIELSON - WE COULD ARGUE THAT BECAUSE OUR UNINCORPORATED POPULATION IS UNDER THE 10,000 THRESHOLD, THAT WE SHOULD STILL BE EXEMPT, BUT THE STATE DID NOT AGREE WITH THAT AT THE TIME.

COMMISSIONER LEE - THAT'S WHAT THE LANGUAGE SAYS IN THE STATUTORY REQUIREMENT, IT HAS THAT UNDER 10,000.

RICHARD NIELSON - YEAH.

GLEN TANNER - THAT'S ONE OF THE THINGS.

RICHARD NIELSON - SO THAT'S ONE OF THE CRITERIA.

GLEN TANNER - THAT'S ONE OF THE CRITERIA.

RICHARD NIELSON – THE OTHER IS THE PROXIMITY TO OTHER PERMITTED AGENCIES.

COMMISSIONER LEE – RIGHT. THAT'S THE STATE TELLING US THAT? THAT'S NOT NECESSARILY THE EPA?

RICHARD NIELSON - I DON'T KNOW THE ANSWER THAT.

GLEN TANNER - I WOULD SAY IT WOULD BE BOTH BECAUSE THE STATE IS ACTING IN THEIR BEHALF. IT'S THE INTERPRETATION FROM THE STATE. YEAH, THEY FELT LIKE WE SHOULD. WHEN WE ACTUALLY GOT STARTED GOING THROUGH AND REQUESTING THE VARIANCE LIKE THE SECOND TIME, THEY DIDN'T FEEL LIKE WE SHOULD HAVE GOT IT FIRST TIME AS THEY DUG INTO IT BECAUSE OF THE OTHER MUNICIPALITIES IN THE AREA THAT WERE REQUIRED TO BE PERMITTED AND WE'RE ADJOINING THEM. THAT WAS ONE OF THEIR CONCERNS AND SO THAT WAS ONE OF THE REASONS IT WAS WITHDRAWN.

COMMISSIONER LEE – YEAH. I MEAN SO OBVIOUSLY WE'RE ADJOINING THEM BECAUSE IF YOU DON'T HAVE THIS, IF THE CITY IS THERE, THE COUNTY IS NEXT DOOR, RIGHT?

RICHARD NIELSON – YEAH, WE TOUCH ALL OF THEM.

COMMISSIONER LEE – SO THE SAME THING WOULD APPLY EVEN IN THESE RURAL COUNTIES WHERE THEY MAYBE ONLY HAVE 1000 BUT YOU KNOW 1000 RESIDENTS, BUT THEY ARE TOUCHING THE CITIES TOO THAT HAVE TO COMPLY.

RICHARD NIELSON - AND TO MY KNOWLEDGE AND I COULD BE WRONG, I BELIEVE YOU GOT UTAH COUNTY, SALT LAKE COUNTY, DAVIS, WEBER, CACHE AND WASHINGTON COUNTY, I BELIEVE ARE THE ONLY COUNTIES THAT HAVE POPULATION CENTERS THAT THE MEET THIS THRESHOLD FOR THE STORMWATER RULES. I THINK THAT THERE ARE MORE RURAL COUNTIES THAT ARE IN THAT EXEMPTED CATEGORY IS MY UNDERSTANDING.

COMMISSIONER IVIE - COUNTY IS SECOND CLASS BASICALLY.

RICHARD NIELSON – BASICALLY, YES, 1ST AND 2ND CLASS. WE CAN RUN DOWN THROUGH SOME ITEMS HERE THAT'S WHAT THIS ORDINANCE ADDRESSES IF YOU'D LIKE, OR IF THERE ARE OTHER QUESTIONS YOU HAVE.

COMMISSIONER AINGE - WELL SO LET ME JUST AS A PREFACE, BECAUSE I APPRECIATE YOU GUYS CAME ON TWO WEEKS AGO, AND THEN I ASKED YOU IF WE HAD A CHANCE TO SIT DOWN. I WILL SAY JUST AS A NOTICE TO OTHERS, THIS IS OUR FIRST TIME WHERE WE'RE ACTUALLY HAVING AN ORDINANCE CHANGE WHEN WE'RE DOING THIS KIND OF WORK SESSION AND SO I APPRECIATE THE TIME YOU TAKE TO SIT DOWN WITH ME. PART OF THE REASON WHY WE'RE DOING THIS FORMAT, IS SO THAT YOU DON'T HAVE TO DO THAT THREE SEPARATE TIMES. AND SO I KIND OF HAVE WHAT I NEED. IT SOUNDS LIKE THE OTHER COMMISSIONERS, I DON'T KNOW, I WON'T SPEAK FOR THEM, BUT IT SOUNDS LIKE THEY'RE MORE UP TO SPEED ON THIS, I KNOW WE'VE BEEN WORKING ON THIS FOR A WHILE. BUT FOR OTHER FUTURE USERS OR PEOPLE WHO WANT TO MODIFY AN ORDINANCE, I WOULD EXPECT THAT THIS IS NOT JUST A STAND UP THERE, THIS IS WHAT WE WANT TO DO, ARE THERE ANY OUESTIONS, BUT ACTUALLY USE THIS AS AN OPPORTUNITY TO EXPLAIN THE CHANGES, EXPLAIN IN A PRETTY FULL MANNER. BUT YOU'VE ALREADY DONE THAT, AND I KNOW THESE OTHER TWO HAVE BEEN WORKING ON THIS, SO I DON'T HAVE ANY ADDITIONAL QUESTIONS TODAY.

RICHARD NIELSON - THANKS.

COMMISSIONER IVIE - YOU KNOW GLEN, WE WORKED ON THIS A BUNCH AND I THINK WHAT TWO YEARS NOW?

GLEN TANNER – YES, AND MAYBE ONE OF THE THINGS TO NOTE IS WE WERE SUPPOSED TO HAVE THIS IN PLACE TWO YEARS AGO, 2019 IS WHEN THAT FIVE-YEAR GRACE PERIOD ENDED SO WE'RE ON BORROWED TIME AT THIS POINT.

COMMISSIONER IVIE - I APPRECIATE ALL YOUR WORK ON THIS AND FROM MY READING THROUGH IT, WE'VE INCORPORATED ALL THE THINGS WE DISCUSSED ABOUT HISTORICALLY, SO THAT WAS THE GOAL.

RICHARD NIELSON - AND THEN YOU WILL ALSO SEE A FEE SCHEDULE COME BEFORE YOU. ONCE THIS IS ADOPTED, THERE ARE SOME FEES THAT ARE ASSOCIATED WITH THE STORMWATER PERMITTING, BUT WE HAVE TO CHARGE FOR DEVELOPMENT AND THINGS LIKE THAT AND SO ONCE THIS ADOPTED, WE WILL PUT FORWARD A FEE SCHEDULE FOR YOU TO REVIEW AND HOPEFULLY ADOPT AS WELL. SO, THANK YOU.

COMMISSIONER AINGE - OK IT LOOKS LIKE WE HAVE PEGGY ON FOR THE NEXT TWO AND I KNOW THAT WE'RE ALL STILL KIND OF LEARNING THE NEW AGENDA SYSTEM, SO I'M NOT POSITIVE IF THIS WAS INTENTIONALLY ON THE WORK SESSION AGENDA OR OKAY, IT IS.

PEGGY KELSEY, COMMUNITY DEVELOPOMENT - YES, IT WAS. I TALKED WITH LEGAL AND THEY ASKED TO HAVE IT PUT ON HERE SO WE CAN DISCUSS IT. I HAVE ACTUALLY 5 ITEMS ON THE AGENDA AND THEY'RE KIND OF SPREAD OUT A LITTLE BIT, SO I'M JUST GOING TO DO A REAL QUICK OVERVIEW OF ALL OF THEM JUST SO, KIND OF REFRESH OUR MEMORY A LITTLE BIT. THESE ARE AGRICULTURAL PROTECTION AREAS THAT HAVE EXISTED NOW FOR 20 YEARS. UTAH COUNTY CODE AND UTAH STATE CODE REQUIRES THAT IN THE 20TH YEAR, THEY GET A REVIEW BY THE LEGISLATIVE BODY TO DETERMINE IF WE'RE GOING TO CONTINUE THEM FOR ANOTHER 20 YEARS, IF WE'RE GOING TO MODIFY THEM OR IF WE NEED TO TERMINATE THEM. SO THAT'S WHAT WE'RE HERE TODAY TO DO. WITH EACH OF THESE, I DID SUBMIT A STAFF REPORT THAT GAVE HISTORY, CURRENT STATUS, RECOMMENDATION, THERE WAS PICTURES OF MAPS ALONG WITH ALL OF THAT. YOU PROBABLY WOULD HAVE SEEN THAT IN ALL OF THE BACKUP AND THEN ALSO I VISITED EVERY SITE AND ALSO ALL THE PROPERTY OWNERS AN ANY CITIES THAT WERE WITHIN THEIR ANNEXATION DECLARATION POLICY, THEY WERE SENT NOTICE OF THESE MEETINGS. SO THAT'S FOR ALL OF THEM AS A QUICK OVERVIEW. AND THEN I CAN GO THROUGH EACH ONE JUST A LITTLE INFORMATION ABOUT EACH ONE. SO, THE FIRST ONE ON YOUR AGENDA WAS, I BETTER PULL IT OUT HERE, SORRY. SO, THE CORPORATION OF THE PRESIDING BISHOP OF THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS AND THIS IS THE PHASE ONE OR PHASE TWO, EXCUSE ME, THE PHASE TWO AG PROTECTION AREA. IT ENCOMPASSES A LITTLE OVER 42,000 ACRES AND AT THE TIME OF THE APPLICATION THE APPLICANT DID NOT SPECIFY WHAT TYPE OF AGRICULTURAL PROTECTION THEY WERE DESIRING, THAT'S KIND OF THE WAY THAT APPLICATIONS LOOKED 20 YEARS AGO. TODAY WE HAVE A LITTLE BIT MORE INFORMATION ON THEM. THIS AREA IS LOCATED IN THE ELBERTA AREA AND IT'S NORTH OF HWY 6 AND WEST OF REDWOOD RD AND IT LIES IN OUR PLANNED COMMUNITY ZONE AND ALSO OUR MINING AND GRAZING ZONE. THERE'S 39 PARCELS IN THIS AG PROTECTION AREA AND THIS DOES NOT FALL WITHIN THE ANNEXATION POLICY DECLARATION OF ANY CITY. I DID DO A SITE VISIT. I DID CONFIRM THAT THERE WAS SOME CATTLE GRAZING ON THIS PROPERTY. MOST OF THE LAND KIND OF LOOKED FALLOW TO ME BUT IT WAS GOOD GRAZING LAND. I DID HAVE CONTACT FROM A COUPLE OF PROPERTY OWNERS WHO EXPRESS A DESIRE TO STAY IN THE AG PROTECTION AREA AND WE ALSO HAVE TO LOOK FOR ANY COMPLAINTS THAT WE HAVE HAD, ANY WRITTEN COMPLAINTS WITHIN THE LAST THREE YEARS AND WE DID NOT HAVE ANY OF THOSE FROM THE SHERIFF'S OFFICE OR FROM ENVIRONMENTAL

OKAY, MY NEXT ONE THEN IS ANOTHER ONE FROM THE CORPORATION OF THE PRESIDING BISHOP OF THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS AND THIS IS THE PHASE ONE AG PROTECTION AREA AND THIS ONE CONSISTS OF A LITTLE OVER 11,000 ACRES AND AGAIN THEY DID NOT SPECIFY THEIR TYPE OF PROTECTION THEY DESIRED TO HAVE. THE THREE ARE ALL KIND OF IN THE SAME AREA SO THE ELBERTA AREA AND THIS IS NORTH OF HWY 6 AND MAINLY ON THE EAST SIDE OF REDWOOD ROAD ALTHOUGH IT DOES SPREAD ACROSS THE WEST SIDE WHEN YOU GO A LITTLE BIT NORTH. 71 ACRES ARE INCLUDED WITH THIS. WHEN I DID MY SITE VISIT, I DID CONFIRM THAT THERE WAS CROPS IN THIS AREA AND I DID ALSO HAVE CONTACT FROM SITLA AND SITLA DID CONFIRM THAT THEY WOULD LIKE TO STAY IN THE AG PROTECTION. AND THERE WERE NO COMPLAINTS ON THIS AG PROTECTION AREA EITHER. AND SO WE WOULD RECOMMEND CONTINUATION FOR ANOTHER 20 YEARS. OKAY, AND THOSE ARE MY TWO.

JOSH SAMSON - JOSH SAMSON, VERY BIBLICAL.

STEVEN HEUMANN - MINE IS VERY GERMAN. WHILE JOSH IS GETTING THAT HOOKED UP, I JUST WANT TO INTRODUCE US REAL QUICK AND MENTAL HEALTHY. MENTAL HEALTHY IS A MENTAL HEALTH ORGANIZATION. IT'S A NONPROFIT THAT WORKS WITH COMPANIES IN ORDER TO HELP WITH THE MENTAL HEALTH OF JUST THE PUBLIC. WE'RE NOT BASED AROUND LOOKING AT WHEN THINGS GET REALLY BAD AND PEOPLE END UP HAVING TO YOU KNOW BE INSTITUTIONALIZED OR GO THROUGH PROGRAMS. WE ARE ABOUT TEACHING PEOPLE THE SKILLS THEY NEED TO DEAL WITH THEIR OWN MENTAL HEALTH BEFORE THINGS GET BAD. NOW I'M SURE THAT YOU ARE FAMILIAR WITH THE STUDY THAT CAME OUT LAST FALL FOR THE AMERICAN MEDICAL ASSOCIATION IN PARTNERSHIP WITH UNIVERSITY OF UTAH AND THE UTAH HOSPITAL ASSOCIATION THAT PLACED UTAH AND THE WASATCH FRONT IN PARTICULAR DEAD LAST WHEN IT CAME TO MENTAL HEALTH, SUICIDE RATES AND SUBSTANCE ADDICTION. WHEN THAT CAME OUT, WE DECIDED TO MOVE A LITTLE BIT AWAY FROM THE CORPORATE STRUCTURE THAT WE'VE HAD WHERE WE TALKED, WHERE WE WORK WITH MAINLY COMPANIES LIKE ADOBE AND WE DECIDED TO FOCUS A LITTLE BIT MORE ON PUBLIC HEALTH AND TALKING TO DIFFERENT COUNTIES, MANY OF WHICH DON'T HAVE ANY PROGRAMS LIKE THIS AT ALL. BASICALLY, WELL I'LL LET JOSH...

JOSH SAMSON - STILL WORKING ON IT.

STEVEN HEUMANN - ALRIGHT I'LL JUST KEEP GOING THEN. BASICALLY, OUR WHOLE PURPOSE IS TO TALK TO PEOPLE ABOUT THEIR MENTAL HEALTH THROUGH WORKSHOPS, THROUGH FILM FESTIVALS, THROUGH CREATIVITY, AND HELP THEM TO BE ABLE TO LEARN THE SKILLS THAT THEY NEED TO ELIMINATE THE STIGMA THAT GOES ALONG WITH MENTAL HEALTH PROBLEMS. AND WE'RE TALKING ABOUT THE BASIC MENTAL HEALTH PROBLEMS OF DEPRESSION AND THINGS THAT ALL OF US GO THROUGH, THAT SOMETIMES WE THINK THAT WE JUST NEED TO MUSCLE THROUGH AND BY DOING THAT WE END UP PUTTING OURSELVES ON A PATH WHERE WE END UP IN A WORSE SITUATION. AND AS OPPOSED TO WHERE A LOT OF OTHER PROGRAMS ARE VERY DRY, I MEAN I'M SURE YOU SAT THROUGH SOME OF THEM. THIS ONE IS MUCH MORE ENTERTAINMENT BASED, IS MUCH MORE ABOUT GETTING PEOPLE TO LISTEN AND TO UNDERSTAND AND TO ACCEPT THEIR OWN LIMITATIONS, THROUGH EDUCATION, THROUGH IMPACT, AND THROUGH ENTERTAINMENT. AND THOSE ARE THE THREE FOCUSES OF OUR PROGRAMS. WHAT WE TEND TO FOCUS ON WHEN WE DO OUR WORKSHOPS, IS BRING PEOPLE TOGETHER, HAVE BRIAN HIGGINS WHO IS THE CEO AND THE FOUNDER OF MENTAL HEALTHY, OH THERE WE GO. SO IT JUST TURNED OFF AGAIN.

JOSH SAMSON - IT'S JUST BECAUSE THERE'S AN ADAPTER.

STEVEN HEUMANN - OKAY, YOU WANT TO MESS AROUND WITH IT?

JOSH SAMSON - IT'S WORKING HERE.

STEVEN HEUMANN – ALRIGHT, I'LL GO AHEAD AND TURN THAT OVER TO JOSH REAL QUICK TO GO THROUGH THIS REAL FAST AND THEN I WILL TAKE OVER HERE.

JOSH SAMSON - OKAY, THANK YOU. SO, AS YOU CAN SEE, WE HAVE A LITTLE PRESENTATION HERE THAT MAKES IT A LITTLE BIT MORE EXCITING THAN JUST HEARING US TALK ABOUT IT. AND SO WHAT IS MENTAL HEALTHY? AND YOU CAN SEE ON THE RIGHT THERE WE HAVE A WHOLE LOT OF DIFFERENT THINGS RATHER THAN JUST READ EVERYTHING I'M GOING TO GO THROUGH ONE AT A TIME AND KIND OF COVER THOSE. SO, ONE OF THE ASPECTS THAT'S VERY IMPORTANT ABOUT MENTAL HEALTHY, IS WE KNOW WE CAN'T DO EVERYTHING ON OUR OWN, WE'RE ALWAYS LOOKING FOR COMMUNITY PARTNERS, AND COMMUNITY IMPACT TOGETHER, SO WHILE AS WAS ALREADY SPOKEN FOR, WE'RE NOT THERAPISTS, WE DON'T PROVIDE THERAPY. SO, WE DO THIS THROUGH MANY DIFFERENT WAYS. ONE IS THROUGH LOTS OF MATERIALS. HAVE THIS MENTAL HEALTH TIPS AND RESOURCES BOOK, SO, ONE OF OUR TRAININGS IS GOING INTO WORKPLACES AND TALKING ABOUT HOW TO FOCUS A LITTLE BIT MORE ON MENTAL HEALTH AND THIS IS JUST A LITTLE BOOKLET THAT HAS A LOT OF THOSE TIPS AND TRICKS TO IT, IT IS SOMETHING THAT CAN LIVE ON BEYOND JUST A SIMPLE DEMONSTRATION OR PRESENTATION. WE'LL GO TO THIS ONE HERE, AND THEN THESE ARE TWO OF THOSE PRESENTATIONS. AND THEN OF COURSE THERE'S THE ENTERTAINMENT SIDE. WE DO LOTS OF DIFFERENT ACTIVITIES, I GUESS YOU COULD SAY, THAT ARE FROM THAT ENTERTAINMENT SIDE. SO, HERE'S SOME OF THEM: OUCH MY MENTAL HEALTH, THIS IS HAPPENING AT WISE GUYS IN SALT LAKE CITY RIGHT NOW AND WE'D LIKE TO GROW THAT. JOSH SAMSON - SO MENTAL HEALTHY IS THE NEWEST INCARNATION OF WHAT WAS CALLED CREATE REAL CHANGE BEFORE, AND CREATE REAL CHANGE REALLY FOCUSED PRIMARILY ON THOSE ENTERTAINMENT ASPECTS, SO THAT'S THE PART WHERE WE HAVE A MUCH LONGER HISTORY. I'D CERTAINLY ENCOURAGE YOU TO GO THROUGH ALL OF IT BEFORE ANY FINAL DECISIONS ULTIMATELY ARE MADE. THIS IS A BRIEF HISTORY, WELL ONE GET THE BEGINNING. MY NAME IS GARY

RATCLIFFE, COUNTY SURVEYOR. I'M HERE TO DISCUSS THE ADDITION OF THREE POSITIONS TO THE COUNTY SURVEYOR'S STAFF. A BRIEF HISTORY: WHEN I STARTED HERE AT THE COUNTY SURVEYOR'S OFFICE IN JANUARY OF 1980, THE STAFF IN EXISTENCE IN 1980 AMOUNTED TO SIX FULL-TIME SURVEYORS, WE HAD THREE DRAFTSMAN WHICH WOULD DO THE DRAWING WORK, WE HAD THE ELECTED OFFICIAL, WE HAD THE DEPUTY, AND WE HAD THE SECRETARY. THOSE ELEVEN PEOPLE PROVIDED THE FUNCTIONS OF THE COUNTY SURVEYOR OFFICE IN 1980. THAT, BASED ON THE CENSUS IN 1980, THE POPULATION OF UTAH COUNTY WAS 218,000. YOU ARE ALREADY FULLY AWARE OF WHERE WE'RE LOOKING AT TODAY WITH THE POPULATION, YOU'VE HEARD IT MANY MANY TIMES OR THREE TIMES. NOW WE'VE BEEN ABLE TO MAKE UP A LOT OF GROUND OVER THE YEARS WITH THE EVOLUTION OF TECHNOLOGY. GPS SYSTEMS HAVE DEVELOPED TO THE POINT WHERE WE'VE BEEN ABLE TO DO A LOT MORE WITH LESS AND THAT'S HELPED MAKE UP A LOT OF THAT GROUND BUT OVERTIME ONLY TECHNOLOGY, TECHNOLOGY CAN ONLY ACCOUNT FOR PART OF THE ISSUES THAT COME WITH RAPID GROWTH AND DEVELOPMENT AND THE DESTRUCTION OF THE PUBLIC LAND SURVEY SYSTEM.

I WANT TO GIVE YOU A JUST A BRIEF, IF I CAN DO THIS AS BRIEFLY AS I CAN, I WANT TO TELL YOU BRIEF STORY ABOUT A GENTLEMAN BY THE NAME OF GREG JOHNSON. GREG WAS BORN IN AROUND 1937/38. WHEN HE WAS SIX YEARS OLD, HE CONTRACTED POLIO. SO AS WAS THE CASE WITH YOUNG CHILDREN OFTEN IN THOSE 1940S AND EARLY '50S, THERE WASN'T A CURE. POLIO IS A DISEASE THAT ATTACKS THE SOFT TISSUE, THE MUSCLE TISSUE, WHAT HAVE YOU, OFTENTIMES MAKING PEOPLE TO A POINT WHERE THEIR LIMBS ARE NOT USABLE. SOMETIMES IT GOT SERIOUS ENOUGH WHERE THE TISSUE AROUND THE LUNGS THAT CONTROL BREATHING, THE INHALING AND EXHALING WOULD BE AFFECTED TO THE POINT WHERE THEY JUST COULDN'T BREATHE. AND A LOT OF THOSE CASES THE PEOPLE JUST PASSED AWAY. A SOLUTION WAS TO THAT BACK IN THE 1940S WAS TO GO BACK EAST, THERE WERE SOME SPECIAL HOSPITALS BACK THERE AND THEY PUT HIM IN THESE BIG LONG MACHINES, THAT THEY RESEMBLED MUCH LIKE AN MRI MACHINE WOULD BE TODAY IN A MODERN FACILITY, ONLY THESE MACHINES, THEY CALL THEM AN IRON LUNG, MAYBE YOU'VE HEARD OF THEM, THEY WOULD HELP THEM. THEY WOULD THEY HAVE BUNCH OF ACCORDION TYPE DEVICES INSIDE THOSE MACHINES THAT WOULD OR BELLOWS I SHOULD SAY, THAT WOULD HELP PEOPLE BREATHE. SO, THIS GREG JOHNSON, WHO WAS MY FATHER-IN-LAW, YEAH, I WANT TO GET TO THE ANALOGY HERE IN A MINUTE. HE FROM THE AGE OF 6 CLEAR THROUGH ADULTHOOD, HE LEARNED HOW TO LIVE THE LIFE OF A PARAPLEGIC, EITHER ON CRUTCHES OR A WHEELCHAIR. IN 1961 A GENTLEMAN BY THE NAME OF ALBERT SABIN CREATED A VACCINE. NOW HE WASN'T THE FIRST CREATOR OF A VACCINE, BUT HE WAS THE FIRST TO USE, THE CREATOR OF VACCINE THAT WAS EASILY DISTRIBUTED. PRIOR TO THAT EVERYBODY HAD TO BE INOCULATED. I REMEMBER AS A YOUNG CHILD IN THE 1960S GOING TO SCHOOL AND NOT KNOWING THE REASONS WHY I WAS ADMINISTERED FOR TWO OR THREE YEARS IN A ROW OF LITTLE SUGAR CUBE. IT WAS FULL OF THE VACCINE FOR A LIVE VACCINE FOR POLIO. AND I'M SURE AT THAT TIME, PARENTS DIDN'T HAVE TO SIGN PERMISSION SLIPS FOR THEIR CHILD TO HAVE ONE OF THESE SUGAR CUBE TABLETS. I THINK UNFORTUNATELY SOMETIMES WE GET TO THE POINT IN GOVERNMENT, WE PANDER TO THE WHIMS OF THE

PUBLIC. I KNOW WE NEED TO LISTEN TO THEM, BUT WE PANDER TOO MUCH. WE DON'T PAY ATTENTION TO THE THINGS THAT REALLY ARE IMPORTANT IN SOCIETY. THIS FATHER-IN-LAW OF MINE, HE'S NOW PASSED, BUT THE ANALOGY I WANT TO MAKE WITH THE POLIO VACCINE, IT TOOK THEM GENERATIONS OF TIME TO FIGURE OUT WHAT WAS CAUSING THE DISEASE. IT TOOK MORE GENERATIONS OF TIME TO FIGURE OUT A CURE. AND IT TOOK THEM EVEN MORE TIME TO ERADICATE THE DISEASE FROM THE WORLD. I THINK IT'S SUPPOSED TO BE ERADICATED ENTIRELY, BUT IT WOULDN'T AT ALL SURPRISE ME IF THERE WEREN'T LITTLE POCKETS OF IT IN SOME REMOTE VILLAGE SOMEWHERE OF POLIO THAT EXISTED, BUT THE QUESTION I'VE GOT FOR YOU IS, WHAT WOULD HAPPEN HERE IN SOCIETY IF WE STOPPED THE IMMUNIZATION OF CHILDREN FROM ANY DISEASE? HOW MANY YEARS, HOW MANY GENERATIONS, HOW LONG WOULD IT TAKE UNTIL WE'RE BACK TO SQUARE ONE OR TO A POINT WHERE WE REALIZED IT WAS A HUGE PROBLEM? NOW I'M NOT GONNA PRETEND THAT WHAT I DO IS COUNTY SURVEYOR IS ANYWHERE NEAR THE IMPORTANCE OF WHAT I'M DISCUSSING WITH POLIO OR ANY OTHER TYPE OF DISEASE, BUT WHAT WE OFFER HERE IS A DIFFERENT TYPE OF VACCINE THAT HELPS PROTECT PROPERTY OWNERSHIP.

THIS VACCINE HAS BEEN ADMINISTERED NOW HEAVILY SINCE IN THE 1940S. THERE HAVE BEEN THREE COUNTY SURVEYORS, TWO PREDECESSORS AND MYSELF, THAT SINCE NO AND I WASN'T ALIVE OBVIOUSLY IN THE 1940S, BUT I HAVE THE RECORDS FROM THE 1940S AND 50S AND 60S AND 70S AND I KNOW WHAT WAS DONE, WHAT WAS ACCOMPLISHED AND WHY THEY DID WHAT THEY DID. WE'VE TAKEN ALL THAT INFORMATION AND OVER TIME WE'VE DEVELOPED STRATEGIES, WE'VE DEVELOPED POLICIES AND PROCEDURES AND HOW WE DID THINGS TO MAKE SURE WE WERE EFFECTIVE AND EFFICIENT, KNOWING THAT WE LIVE IN A COUNTY THAT'S UNDOUBTEDLY, IN MY MIND, THE MOST CONSERVATIVE COUNTY IN THE COUNTRY. AND KNOWING WE'D HAVE TO DO THINGS AS EFFICIENTLY AS WE COULD, IT'S GOTTEN TO THE POINT WHERE WITH THE GROWTH PARTICULARLY IN THE NORTH END, THAT WE'RE LOSING MONUMENTS. NOW THE KEY POINT TO THIS IS UNLESS WE GET TO THE MONUMENTS BEFORE THEY ARE REMOVED, THEN I'M TO A POINT WHERE WHEN I GO BACK IN TO PUT HIM BACK IN THE GROUND, I HAVE TO RELY ON OLD HISTORIC INFORMATION AND HOPE THAT IT'S SUFFICIENT ENOUGH THAT I CAN PRECISELY PUT THAT MONUMENT BACK IN. IF I'M A LITTLE BIT OFF, CAN THAT MAKE A DIFFERENCE? YOU KNOW IN PROPERTY AREAS WHERE WE'RE TALKING COMMERCIAL LAND OR EXTREMELY VALUABLE LAND, IT CAN MAKE A BIG DIFFERENCE. THE PROBLEM IS, I'M NOT GOING TO KNOW WHETHER MY DATA IS ANY GOOD OR NOT BECAUSE I DON'T HAVE ANYTHING TO GO BACK IN TIME AND SAY YEAH, THAT HISTORIC DATA IS SPOT ON, OR NO, IT'S NOT. SO, THE WHOLE POINT IS GOING IN AHEAD OF THE PROJECT, GET AHEAD OF THE DAMAGE TO REFERENCE MARKERS AND TO DO THAT SO WHEN THOSE DEVELOPMENT PROJECTS ARE OVER, WE CAN GO IN AND REESTABLISH THOSE MONUMENTS VERY PRECISELY WITH A CONVINCING IDEA IN OUR MINDS THAT WE'RE DOING THE RIGHT THING, PUTTING THEM RIGHT BACK IN THE RIGHT PLACE. LET ME GIVE YOU AN EXAMPLE ON THE SUNDANCE AREA WHERE PROPERTY IS A BILLION DOLLARS A SQUARE INCH. I'M PROBABLY NOT EXAGGERATING TOO MUCH, OKAY? THERE'S ONE MONUMENT UP THERE. ONE MONUMENT THAT BASICALLY CONTROLS EVERY LAND PARCEL

UP THERE. ONE. AND A NUMBER OF YEARS AGO I GOT CONTACTED BY A PRIVATE SURVEYOR AND HE SAYS YOUR MONUMENT UP THERE IS MIGRATING. I SAID WHAT ARE YOU TALKING ABOUT? HE SAID, WELL IT'S LEANING PRETTY GOOD, AND I'M TRYING TO CONNECT WITH OTHER SURVEYS THAT HAVE BEEN DONE YEARS BEFORE WITH THE ONE I'M TRYING TO DO NOW AND I'M GETTING SOME DISCREPANCIES. SO, WE WENT IN THERE, WE SPENT HALF A SUMMER IN THERE WITH ONE SURVEY CREW, TRYING TO RESOLVE THE ISSUE GOING BACK THROUGH OLD HISTORIC RECORDS, TRYING TO FIGURE OUT WHERE THAT MONUMENT WAS ORIGINALLY PLACED BACK IN 1923. I THINK MAYBE IT'S 1930S, BUT ANYWAY WHEN IT WAS FIRST PLACED THERE BEFORE REDFORD DEVELOPED, BEFORE STEWARTS, BEFORE REDFORD DEVELOPED AROUND ABOUT THE SAME TIME AS STEWARTS WHO WERE THE ORIGINAL DEVELOPERS IN THERE, AND I REALLY HAVEN'T RESOLVED IT YET. SO THAT'S JUST ONE EXAMPLE OF TRYING TO PROTECT THE BOUNDARIES, THE ORIGINAL BOUNDARIES OF LAND CLAIMANTS. SO THAT'S IN ESSENCE WHY I NEED THESE POSITIONS. I AM NOT KEEPING UP WITH WHAT I NEED TO KEEP UP WITH. I'VE ASKED FOR THREE POSITIONS, A TWO-PERSON SURVEY CREW THAT I WOULD PUT UP AND THEN PARTICULARLY UP IN THE NORTH END OF THE COUNTY, WITH AN ADDITIONAL CREW THAT'S ALREADY THERE. IT WOULD ALLOW MY DEPUTY AND I TO DO, BE MORE PROACTIVE WITH THE EDUCATION SIDE OF THIS. WE'VE ALREADY INITIALLY STARTED THAT WITH CITIES AND WITH STATE AGENCIES. IT WOULD HELP US TO BE MORE PROACTIVE IN THAT EFFORT BECAUSE IT'S A CONTINUALLY ONGOING EFFORT. IT'S EACH ONE OF YOU GENTLEMEN COME INTO THE OFFICE I TRY TO DRAG YOU OFF ON SOME EXPEDITION WITH ME OR TO COME OVER AND SIT AND LISTEN TO ME. I HAD BILL OUT IN THE VAN ONE DAY OUT IN THE DESERT, SO I TRIED TO EDUCATE AS THOSE THINGS HAPPEN.

COMMISSIONER LEE - YOU EVEN BROUGHT ME BACK.

GARY RATCLIFFE - YES, I DID. I ABOUT DIDN'T. YES, I KNOW.

COMMISSIONER IVIE - THAT'S WHAT YOU ARE COUNTING ON THIS FALL.

GARY RATCLIFFE - BUT SO IT'S A CONTINUAL EFFORT WITH OUR CITIES, WITH THE STATE AGENCIES, AND THAT WILL CONTINUALLY EVOLVE. WITH THE DEPUTY, NOT THE DEPUTY EXCUSE ME, WITH THE FIELD SUPERVISOR POSITION, THAT'S A LICENSED POSITION. THAT POSITIONS RESPONSIBILITY WILL HAVE TOTAL RESPONSIBILITY OVER THE FIELD CREWS, FROM START TO FINISH. IT'S GOING TO FREE ME UP, IT'S GOING TO FREE ANTHONY UP, IT'S GOING TO FREE US UP TO PROACTIVELY BE ENGAGED WITH THE POLITICAL SIDE OF THIS, INTERACTING WITH THE CITIES AND THE STATE AGENCIES. THERE'S NEW LEGISLATION AS OF LAST LEGISLATIVE SESSION, SENATE BILL 104 CREATED SOME THINGS IN STATE STATUTE, THE MODIFICATIONS TO 17-23-14 AND THOSE, I WAS UP TO THE LEGISLATURE TRYING TO PROMOTE THAT AND PUSH THAT AND FEEL REALLY HAPPY THAT WE'VE DONE THAT, ALL KNOWING

6. HEAR AN ECONOMIC DEVELOPMENT PROPOSAL FROM TODD BRIGHTWELL OF ADVISORS CONSULTING SERVICES

TODD BRIGHTWELL, PRESIDENT, ADVISORS CONSULTING SERVICES - GOOD AFTERNOON, TODD BRIGHTWELL. I PROVIDED SOME DOCUMENTATION; I TRUST THAT YOU HAVE. I'D LIKE TO JUST REVIEW THIS QUICKLY.

COMMISSIONER AINGE – SORRY, I DON'T BELIEVE, THERE WASN'T ANY APPLIED TO THE AGENDA SYSTEM.

TODD BRIGHTWELL – OKAY. IF I MAY, AND I'LL REVIEW THIS IN SUMMARY, AND I GUESS WE CAN THEN GO THROUGH IT.

COMMISSIONER AINGE - THANK YOU.

TODD BRIGHTWELL - SO WE HAVE WORKED HARD TO PROVIDE AS A CONTRACTOR TO THE COUNTY, TO PROVIDE GOOD VALUE TO THE COUNTY AND PROVIDE SUPPORT ON ECONOMIC DEVELOPMENT INITIATIVES. WE'VE RECEIVED GOOD FEEDBACK FROM ALL OF YOU AND A SIGNATURE WIN FOR THE COUNTY WAS THE TYSON FOODS PROJECT. IT WAS SAFE TO SAY WITHOUT OUR STRATEGIC INVOLVEMENT AND THE COUNTY'S SUPPORT, THE PROJECT WOULD NOT HAVE LOCATED AN EAGLE MOUNTAIN OR UTAH COUNTY. THE POSITIVE IMPACTS OF THE PROJECT ALONE, FINANCIALLY AS WELL AS CULTURALLY, I BELIEVE IS UNPARALLELED. IT SERVES AS A CATALYST TO WHAT'S GOING ON THE WEST SIDE OF THE VALLEY AND EAGLE MOUNTAIN THERE, AND MANY MORE PROJECTS WITH HUNDREDS OF MILLIONS OF DOLLARS IN CAPEX, WHICH WILL TRANSLATE INTO DOLLARS INTO THE COUNTY COFFERS. WE ARE CURRENTLY WORKING ON OR WORKING WITH TWO COMPANIES THAT ARE SHORTLISTED UTAH AND UTAH COUNTY THAT HAVE CAPEX ESTIMATES OF OVER \$300 MILLION EACH. I RECOGNIZE THAT THE

BUDGET CONSTRAINTS IN ACTIONS DEPLOYED FOR THE JANUARY 2020 BUDGET REDUCED THE ECONOMIC DEVELOPMENT BUDGET SIGNIFICANTLY FROM \$140,000 TO \$35,000 WHICH SERVED OUR CONTRACT. WITH ALL THIS IN MIND WE'D LIKE TO PROPOSE AN OPTION TO THE COMMISSION THAT WILL FULFILL THE FOLLOWING: COUNTY REPRESENTATION FOR INCOMING PROJECTS OR PROJECT MANAGEMENT, FINISH THE WEBSITE DEVELOPMENT THAT WE WERE CURRENTLY REENGINEERING AND REDEVELOPING. WE BELIEVE WE CAN ENABLE THE COUNTY TO USE THE LIMITED BUDGET THAT IT HAS TO BRIDGE TO A NEW STRUCTURE THAT WE LOOK TO DEVELOP THIS YEAR, BUT IT WOULDN'T REQUIRE ANY FUNDING ADDITIONAL FUNDING FROM THE COUNTY UNTIL 2021, AND THAT CERTAINLY ASSUMES THAT THE COUNTY WOULD BE INTERESTED IN PARTICIPATING BUT DOESN'T ASSUME THAT THAT ACTUALLY WILL HAPPEN AT THIS POINT. MAINTAIN CONTINUITY FOR 2020 LEVERAGING ALL THE GOOD WORK THAT'S BEEN DONE TO THIS POINT, AGAIN PROVIDE PROJECT MANAGEMENT ON CURRENT PROJECTS THAT WE'RE WORKING ON AS WELL AS NEW PROJECTS THAT WILL COME IN THIS YEAR. OUR PLAN IS TO BUILD A NEW PROGRAM TO SUPPORT ECONOMIC DEVELOPMENT IN THE COUNTY THAT WILL BE SUPPORTED PRIMARILY BY CITIES, AND THE IDEA IS TO PROVIDE SUPPORT TO THE FOLLOWING AND LEVERAGE THE FOLLOWING INITIATIVES WHICH INVOLVE THINGS AND I KNOW THEY'RE IMPORTANT TO THE COUNTY, WHICH TRANSPORTATION, AIRPORT DEVELOPMENT, BUSINESS ATTRACTION, WORKFORCE DEVELOPMENT, HOUSING AND OTHER COUNTY WIDE GOALS. THE NEW PROGRAM WE BELIEVE WILL REQUIRE MUCH LESS FUNDING FROM THE COUNTY. WE'VE RECEIVED STRONG INITIAL SUPPORT FROM SOME OF THE MAJOR CITIES IN THE COUNTY, THAT LEADS US TO HAVE CONFIDENCE IN THE DIRECTION OF DEVELOPING A NEW ECONOMIC DEVELOPMENT PROGRAM. THE PROPOSAL WILL CARRY ON, OUR PROPOSAL IS TO CARRY ON ECONOMIC DEVELOPMENT RESPONSIBILITIES FOR THE COUNTY, WITH THE REMAINING BUDGET THAT'S CURRENTLY IN THERE FOR 2020. THIS ALLOWS US TO STRETCH AGAIN, AS I SAID THROUGH THE OPPORTUNITY TO BUILD A NEW PROGRAM AND THEN IDEALLY PRESENT THAT TO THE COUNTY COMMISSION TO SEE IF THEY WOULD LIKE TO PARTICIPATE. SO, IT'S A GENERAL OVERVIEW OF WHAT YOU SEE IN FRONT OF YOU. I'D BE HAPPY ANSWER ANY QUESTIONS.

COMMISSIONER AINGE - I JUST, I'LL JUST BE PRETTY BLUNT. IN OUR BUDGET MEETING WE CUT THIS. I VIEW IT AS NOT ESSENTIAL, AS WE DEAL WITH OUR BUDGET CHALLENGES. I AM NOT SUPPORTIVE OF DOING THIS AND SO I WILL NOT BE SUPPORTING, OR I DON'T REALLY EVEN WANT TO ENTERTAIN ANY FUTURE ECONOMIC DEVELOPMENT CONTRACT WITH ADVISORS CONSULTING SERVICES.

COMMISSIONER IVIE - WHAT KIND OF DOLLAR FIGURES ARE YOU THINKING FOR 2021? BECAUSE OBVIOUSLY HAVING GONE THROUGH THE TRUTH IN TAXATION PROCESS NOW, ESTABLISHED THE BUDGET AS WE'RE LOOKING AT POTENTIAL FUTURE INCREASES, THAT WOULD BE A HUGE IMPACT. SO, I MEAN, ARE YOU THINKING WE WOULD HAVE SOME TYPE OF A NEW YOU KNOW A NEW AGREEMENT THAT WOULD BE SIMILAR IN COST TO WHAT WE USED TO HAVE? ARE YOU THINKING IT'S GOING TO STAY AT THE \$35,000 MODEL FROM THE COUNTY'S PARTICIPATION THAT WE HAD BUDGET BUILT INTO THIS YEAR?

WHERE ARE WE TALKING ABOUT IN TERMS OF LONG-TERM FINANCIAL COMMITMENT?

TODD BRIGHTWELL - I WOULD ANTICIPATE NOT KNOWING THAT EXACT FIGURE, THAT IT WOULD BE SOMEWHERE IN THE NEIGHBORHOOD OF WHAT WE'RE PROPOSING FOR THIS YEAR BASED ON THE ADDITIONAL FUNDING THAT WOULD COME IN FROM OTHER MULTIPLE SOURCES. I BELIEVE THAT IN THE PROCESS OF DEVELOPING THE NEW ENTITY, WHICH WOULD BE A SEPARATE ENTITY AND INDIVIDUAL ENTITY, IF THE COUNTY WAS INTERESTED IN PARTICIPATING, SOME OF THOSE QUESTIONS WOULD BE ASKED AND WORKED ON DURING THE DEVELOPMENT OF THE CREATION OF THE NEW ENTITY. BUT BASED ON WHAT WE'VE GENERALLY WORKED ON TO THIS POINT WITH SOME OF THE CITIES WE BELIEVE THAT IT WOULD BE IN THE NEIGHBORHOOD OF CURRENTLY WHAT WE'RE ASKING FOR NOW.

COMMISSIONER IVIE - OKAY. THANK YOU.

TODD BRIGHTWELL - DOES THAT ANSWER YOUR QUESTION?

COMMISSIONER IVIE - THANKS AND THAT ANSWERS THAT, AS WE'VE TALKED PREVIOUSLY MY BIGGEST CONCERN IS YOU KNOW THE BUDGET AND I AGREE WITH TANNER ON THIS ONE THAT A GREAT CHALLENGE WITH THIS ONE IS I JUST DON'T SEE IT AS A MANDATED OR ESSENTIAL SERVICE, AND SO TRYING TO JUSTIFY THAT TO THE TAXPAYER AFTER WE'VE RAISED TAXES IS A LITTLE DIFFICULT.

COMMISSIONER AINGE - WELL AND IN SOME WAYS IT'S EVEN WORSE, BECAUSE IT'S AN UNNECESSARY SERVICE THAT WE ARE ASKING THE TAXPAYER TO FUND, THAT ALSO THEN GIVES ADDITIONAL TAX BREAKS POTENTIALLY.

TODD BRIGHTWELL - RELATIVE TO UNNECESSARY IN TERMS OF NEW CAPITAL INVESTMENT THAT COMES INTO THE COUNTY ACTUALLY REPRESENTS REVENUE.

COMMISSIONER AINGE – YEAH, WELL AND THEN THERE'S ANOTHER PART OF THIS WHICH IS THAT I THINK THE COUNTY IS PROBABLY, CAN DO JUST FINE, YOU KNOW WITH OUR CIVIL DEPARTMENT LOOKING AT THESE AS THEY COME IN. I'M NOT SAYING ECONOMIC DEVELOPMENT IS INCREDIBLY IMPORTANT IN THE COUNTY, BUT IT'S MOSTLY DONE IN THE PRIVATE SECTOR. AND THOSE BUSINESSES THAT ARE COMING IN OR LIKELY TO TALK WITH THE GOVERNOR'S OFFICE OF ECONOMIC DEVELOPMENT THEN TO HAVE TOUCH POINTS WITH THE CITIES AND THEN THEY'LL REACH OUT TO US AND WE WILL BE ADVOCATES FOR ECONOMIC DEVELOPMENT IN THE COUNTY, I THINK THE THREE OF US WHO WOULD INTEND TO PASS, WHICH WE HAVEN'T HAD IN PLACE, A TRULY KIND OF ECONOMIC DEVELOPMENT POLICY FOR UTAH COUNTY AT THE COMMISSION LEVEL, SO IT'S VERY CLEAR WHAT OUR STANDARDS, WHAT OUR OBJECTIVES ARE, AND I THINK OUR COUNTY IS THRIVING SO THE OPPORTUNITIES ARE GOING TO COME TO US, AND WE WILL BE ABLE TO NEGOTIATE AND MANAGE THOSE OPPORTUNITIES AS THEY COME IN.

TODD BRIGHTWELL - I THINK THOSE ARE POINTS WELL TAKEN. I THINK THAT THE CHALLENGES PROBABLY COME RELATIVE TO PROJECTS THAT DON'T COME IN THROUGH THE AVENUES THAT YOU'RE TALKING ABOUT, WHEN THEY COME IN DIRECTLY TO THE COUNTY ITSELF, MANY OF WHICH THAT WE'VE FIELDED AND THAT WE'VE MANAGED. THOSE WOULD BE LEFT TO POTENTIALLY NOBODY, THEREFORE NOT GETTING THE ATTENTION THAT THEY NEED AND THEREFORE BE ABLE TO PROVIDE OPPORTUNITY FOR THE COUNTY.

COMMISSIONER LEE - BUT TODD, I'VE GOT A LITTLE DIFFERENT PERSPECTIVE. I'VE BEEN LOOKING AT THIS. I WATCHED OVER THE YEARS EVEN CITIES WHO DECIDED THAT ECONOMIC DEVELOPMENT WASN'T NECESSARILY SOMETHING THAT THEY WERE GOING TO PURSUE, AND THEY JUST WAS HOPING THAT IT WOULD JUST NATURALLY COME. IT DIDN'T THE MOST PART. IT'S NO LONGER THAT WE'RE COMPETING NECESSARILY WITH OUR NEIGHBOR COUNTIES OR THE CITIES ARE COMPETING WITH THEIR NEIGHBOR CITIES, WE'RE COMPETING ON NATIONAL AND EVEN GLOBAL MARKETS IN WHICH THE GAME IS A LOT DIFFERENT. AND I HAVE ALWAYS THOUGHT THAT ECONOMIC DEVELOPMENT, ALTHOUGH I AGREE WITH A LOT OF THE THINGS THAT WERE SAID WHEN IT COMES TO SOME OF THE TAX INCREMENT FINANCING, AND IN SOME OF THOSE THINGS I VOTED AGAINST SOME OF THOSE AS WELL IN THE PAST, AND VOTED FOR SOME OF THOSE THAT MADE SENSE YOU KNOW FOR ME IN THE PAST AS WELL, BUT I LOOK AT THE WORKLOADS THAT WE HAVE AS COMMISSIONERS AND I DON'T HAVE THE EXPERTISE TO BE OUT THERE BEATING THAT DRUM AND SO IF WE DON'T HAVE SOMEBODY THERE LOOKING OUT FOR THAT, ONE WAY OR THE OTHER, TO LET IT GO ONTO THE CIVIL DEPARTMENT, I DON'T THINK THAT THEY EVEN WANT THAT.

COMMISSIONER AINGE - WELL TO BE CLEAR, I'M NOT SAYING ANYONE IS GOING TO BE BEATING ANY DRUM. THAT JUST HAPPENS. UTAH COUNTY IS THRIVING. BUSINESSES DON'T COME HERE JUST BECAUSE. THEY COME HERE BECAUSE THEY WANT ACCESS TO OUR WORKFORCE, THAT THIS IS A GREAT PLACE TO BE, IT'S A BUSINESS-FRIENDLY PLACE, WE HAVE SOME OF THE LOWEST TAX RATES OF ANY COUNTY, THERE'S A LOT OF REASONS WHY THEY WANT TO BE HERE. COMMISSIONER LEE – YEAH, THAT'S ON US. THAT'S ON US IF WE IF WE BOW TO THAT OR NOT. I STILL THINK THAT THERE NEEDS TO BE SOME PLACE TO LAND. THE MULTIPLE SOLAR DEVELOPERS THAT ARE ON THE WEST SIDE, THE PROJECTS, WE HAVE FOUR PROJECTS RIGHT NOW THAT HAVE COME IN, THEY'RE REQUIRING INFORMATION, THEY WANT TO UNDERSTAND WHAT THE OPPORTUNITIES ARE FOR THEM TO LAND HERE, BUT THEY'RE ALSO LOOKING IN SALT LAKE COUNTY, DAVIS AND WEBER AND SO PROVIDING THAT TYPE OF SUPPORT DOES PROVIDE OPPORTUNITY TO GET THEM THE RIGHT INFORMATION, TO GET THE RIGHT PROJECTS HERE THAT INVEST IN, PUT CAPITAL INVESTMENT IN, THAT ULTIMATELY PROVIDE REVENUE AND I DON'T BELIEVE EVERY PROJECT NEEDS TO HAVE TAX

INCREMENT FINANCING OR INCENTIVES. AGAIN, I'LL REFERENCE THE SECOND PROJECT THAT WE'RE WORKING ON AFTER THE TYSON PROJECT IS ONE WHERE IT WAS REPRESENTED VERY CLEARLY TO THEM ON THE FRONT END, THAT THERE WILL NOT BE COUNTY INCENTIVES FOR THIS PROJECT. JASON VERNON - FOR ALL THAT LAND. I ALSO HAVE...

COMMISSIONER LEE – CAN WE AT LEAST GET IT ON GREENBELT STATUS?

COMMISSIONER IVIE - THAT'D BE NICE.

JASON VERNON - I HAVEN'T THOUGHT ABOUT THAT.

COMMISSIONER IVIE - THAT WOULD BE REALLY NICE.

JASON VERNON - I ALSO HAVE A HANDOUT IN HERE,

COMMISSIONER IVIE – YOU CAN TALK TO THE LEGISLATORS ABOUT THAT.

JASON VERNON - I'M SORRY? YEAH, YEAH. I ALSO HAVE A HANDOUT HERE TALKING ABOUT UTAH'S WATERSHED RESTORATION INITIATIVE. IT'S AN INITIATIVE THAT WE'RE COOPERATING ON, WITH MANY AGENCIES, FEDERAL AND STATE, COUNTY, ALL THROUGHOUT THE STATE. IT'S BEEN IN PLACE SINCE 2006 AND IT'S BASICALLY TO REHABILITATE WATERSHEDS THROUGHOUT THE STATE. SINCE 2006 WE'VE DONE NEARLY 2,000,000 ACRES OF RESTORED LAND ACROSS THE STATE. HERE IN UTAH COUNTY, WE'VE AFFECTED ABOUT 84,000 ACRES. SOME OF THOSE BIG CHUNKS CAME TWO YEARS AGO WITH THE POLE CREEK AND BALD MOUNTAIN FIRES. WE ACTIVELY RESEEDED THOSE AND WORKED WITH THE FOREST SERVICE IN THE COUNTY ON THOSE LANDS. AND THERE'S SOME MORE INFORMATION HERE THAT I'LL LET YOU PERUSE OVER. THE OTHER PURPOSE FOR BEING HERE IS JUST ANSWER ANY QUESTIONS YOU MIGHT HAVE CONCERNING THE WILDLIFE WITHIN YOUR COUNTY OR ANY OF THE CITIES THAT ARE HERE AS WELL, AND HOPEFULLY ANSWER ANY QUESTIONS YOU HAVE.

COMMISSIONER LEE - I'VE GOT SOME QUESTIONS.

JASON VERNON - ALRIGHT.

COMMISSIONER LEE - AND BY THE WAY ON THE RESEEDING EFFORTS YOU DID UP THERE, FANTASTIC. THANK YOU FOR THAT. I THINK YOU'RE THE STAR ON THAT, YOU KNOW DOING THE WORK AHEAD OF TIME AND DOING APPROPRIATE WORK. YESTERDAY I SAT UP IN THE STATE LEGISLATURE ON PREDATOR CONTROL, I DON'T KNOW IF YOU WERE THERE, I DIDN'T SEE YOU THERE.

JASON VERNON - I WASN'T THERE, BUT I'M AWARE OF IT.

COMMISSIONER LEE – RIGHT. CAN YOU GIVE US AN UPDATE IN OUR AREA WHEN IT COMES TO THE COUGARS, THE BEARS AND THE PREDATORS AND OUR DEER HERD POPULATION HERE IN UTAH COUNTY? BECAUSE I KNOW FROM TALKING WITH THE OTHER COMMISSIONERS AROUND THE STATE, THERE'S A THERE'S A BIG FIGHT KIND OF GOING ON WITH THAT, AND I'M IN FAVOR OF GIVING YOU THE PROPER TOOLS NEEDED AND NECESSARY TO MANAGE, AND I'M SUPPORTIVE OF THE STATE GOING THROUGH THAT PROCESS IN A PROPER WAY, BUT CAN YOU GIVE US AN IDEA HERE IN UTAH COUNTY WHERE WE'RE AT?

JASON VERNON - SO PRIMARILY ACROSS THE FACE HERE IN UTAH COUNTY, WE HAVE A LOT OF NUISANCE COUGARS AND BEARS THAT COME DOWN, ESPECIALLY MOUNTAIN LIONS THIS TIME OF THE YEAR, THEY'RE FOLLOWING THE DEER HERD OFF OF THE MOUNTAIN AS THEY MIGRATE DOWN AND TRYING TO FIND SOME FOOD. SO, WE'RE OFTENTIMES DEALING WITH THOSE MOUNTAIN LIONS. THEY'LL COME INTO TO PEOPLE'S YARDS. I THINK WE SEE A LOT, OR WE HAVE A LOT MORE REPORTS OF THEM, BECAUSE EVERYBODY HAS A CAMERA ON THEIR DOORBELL OR A CAMERA IN THEIR BACKYARD, AND SO EVERYBODY SEEING THEM QUITE A BIT. SO, WE RESPOND TO ALL OF THOSE. WE'LL GO INTO THOSE SITUATIONS AND TRY TO REMOVE THE ANIMAL. USUALLY, WE'LL DART IT WITH DRUGS AND THEN TAKE IT BACK UP THE MOUNTAIN. IN THE SUMMERTIME THIS LAST SUMMER WAS EXTREMELY BUSY WITH BEARS COMING DOWN OFF THE MOUNTAIN. TWO YEARS AGO, WE HAD A REALLY DRY SUMMER AND THEN WENT INTO A REALLY WET WINTER AND IT KIND OF FORCED THE BEARS OUT A LITTLE BIT EARLY AND SO WE DEALT WITH A LOT OF BEARS. AS FAR AS PREDATION ON LIVESTOCK, THERE IS A BILL GOING THROUGH OR SORRY A STUDY GOING ON RIGHT NOW UP IN THE STRAWBERRY AREA TO LOOK AT PREDATION BY MOUNTAIN LIONS AND BEARS ON LIVESTOCK AND MAKE SURE WE'RE COMPENSATING THE LIVESTOCK MEN, THE RANCHERS APPROPRIATELY. WE DO HAVE IT SEEMS LIKE SOME SUPPORT IN THE LEGISLATURE TO, AS YOU PROBABLY SAW YESTERDAY, TO GIVE OUR DIRECTOR THE ABILITY TO GO AND MAKE DECISIONS BASED ON WHAT WE'RE SEEING WITH OUR DEER HERDS AND PREDATION ON THOSE DEER HERDS. I THINK IT'S A LITTLE BIT MORE HOT OF A TOPIC AND SOME OF THE MORE RURAL AREAS VERSUS ACROSS THE WASATCH FRONT HERE, BUT WE DO DEAL WITH A NUISANCE QUITE A BIT AND TRY TO REMOVE THOSE ANIMALS, THEY DON'T NEED TO BE HERE IN THE VALLEY WITH YOUR RESIDENTS, SO WE'LL MOVE THEM OUT OF HERE.

COMMISSIONER LEE - SO OUR DEER HERDS IN THIS AREA, HOW ARE THEY GENERALLY? ARE THEY AVERAGE? BELOW AVERAGE?

JASON VERNON – THEY ARE BELOW POPULATION OBJECTIVE RIGHT NOW. THIS WINTER'S BEEN A REALLY MILD WINTER, SO WE'RE REALLY HOPING THAT THE FAWNS THAT ARE MAKING IT THROUGH THE WINTER, WILL MAKE IT THROUGH INTO THE SPRING. WHAT REALLY TELLS IF YOU'RE DOING WELL WITH THE WITH THE DEER HERDS AND WHAT WE'RE LEARNING IS HOW THEY COME INTO THE WINTER, IF THEY HAVE A WHOLE BUNCH OF FAT ON THEM, IF THEY HAD A GOOD SUMMER, THEY COME INTO THE WINTER, THEY'RE GOING TO BE LOSING THAT FAT ALL WINTER LONG. THEY DON'T GAIN ANY FAT. SO OUR JOB IS TO TRY TO MAKE SURE THAT THEY LOSE THAT FAT AT A REALLY SLOW RATE. IF THEY CAN LOSE THAT FAT AT A REALLY SLOW RATE, LOOKING AT THE FOOTHILLS HERE WHERE THERE'S NO SNOW, THEN WE'LL HAVE A GOOD FAWN CROP INCOMING IN THIS NEXT YEAR, WHICH IS WHAT WE'RE LOOKING AT RIGHT NOW. IT LOOKS REALLY GOOD.

COMMISSIONER LEE - THANK YOU.

JASON VERNON - THANK YOU. ANY OTHER QUESTIONS? ALRIGHT THANK YOU I APPRECIATE YOUR TIME. I DON'T KNOW WHO TO GIVE THIS TO.

COMMISSIONER LEE - I DON'T WANT TO TOUCH IT.

JASON VERNON – (PROCEEDS TO GIVE CHECK TO COMMISSIONER AINGE) YOU WOULDN'T THINK IT WOULD BE SO HARD TO GIVE MONEY AWAY.

COMMISSIONER AINGE – I'LL GIVE IT TO YOU RIGHT AFTER (SPEAKING TO DANENE JACKSON).

COMMISSIONER AINGE - SO SORRY, YOU'RE STILL ON #12, RIGHT? SOMETIMES YOUR NUMBERS HAVE BEEN A LITTLE BIT DIFFERENT THAN WHAT WE SEE ON THE AGENDA, LIKE THIS ONE HAS EIGHT, JUST OVER 8000 ACRES.

PEGGY KELSEY - YES, THIS ONE HAS JUST OVER 8000 ACRES.

COMMISSIONER AINGE - OKAY, I THOUGHT YOU JUST SAID 68 ACRES.

PEGGY KELSEY - OH IT WAS, SORRY IT WAS 68 PARCELS. THAT WAS PROBABLY ME, I PROBABLY MISSPOKE. SORRY. I DID VISIT THE SITE AND THERE IS CATTLE, FEED YARDS AND CROPS GROWING IN THIS AREA. THERE WAS ONE COMPLAINT REGISTERED WITH THE SHERIFF'S OFFICE IN THE LAST THREE YEARS, AND THAT WAS FOR LOOSE CATTLE. AND THOSE CATTLE WERE DIRECTLY CONNECTED TO THE LDS CHURCH, AT LEAST THAT'S WHAT THE REPORT HAD SAID. SO, THERE WAS ONE. I DID NOT RECEIVE ANY CONTACT FROM LANDOWNERS IN THAT AREA, BUT WHERE THERE WAS ONLY ONE IT DOESN'T MEET THE THRESHOLD OF FIVE AND SO WE WOULD RECOMMEND CONTINUING THIS ONE ALSO FOR ANOTHER 20 YEARS.

COMMISSIONER AINGE - OUT OF CURIOSITY WHAT DO? WE DO I MEAN THIS ONE, THEY ALL SOUND LIKE THEY HAVE HAD MINIMAL COMPLAINTS, THIS IS THE FIRST ONE THAT HAD ANY COMPLAINTS.

PEGGY KELSEY - RIGHT.

COMMISSIONER AINGE - IS THERE ANY SORT OF WAY THAT WE CAN JUST CHECK TO SEE IF THERE'S BEEN ANY RESPONSIVENESS FROM A PROPERTY OWNER IN THE EVENT THAT WE HAVE COMPLAINTS? PEGGY KELSEY - WELL OBVIOUSLY AS THE COMPLAINTS COME IN, IF THEY COME INTO MY OFFICE, WE WOULD INVESTIGATE THOSE AND SEE IF THEY HAVE MERIT AND IF THE PROPERTY OWNERS ARE DOING EVERYTHING THAT THEY SHOULD BE DOING TO KEEP THE CATTLE CONTAINED OR FOR WHATEVER YOU KNOW WHATEVER IS GOING ON. WE DID HAVE COMPLAINTS, NOT OF THIS ONE, BUT YOU KNOW LIKE MINK FARMS WE'LL GET COMPLAINTS, AND WE WILL INVOLVE HEALTH DEPARTMENT WITH THOSE ALSO, TO SEE IF WE CAN REMEDY ANYTHING RIGHT THEN. WHEN IT COMES UP FOR REVIEW, ONCE IT MEETS THAT THRESHOLD OF FIVE, THEN THE FILE WOULD AUTOMATICALLY BE REFERRED BACK FOR A FULL REVIEW. SO THAT'S 120 DAYS AND PUBLIC HEARINGS AND LOTS OF MEETINGS AND STUFF AND SO AT THAT POINT IN TIME, WE WOULD DO A MORE THOROUGH REVIEW AT THAT.
