COMMISSIONER IVIE – RECOGNIZED EMPLOYEE OF THE MONTH, ANNETTE DYER. READ NOMINATION:

We are incredibly lucky to have some of the best county employees working at the Children's Justice Center. There is one employee who I feel is deserving of special recognition for her superior work and ability to manage quite the interesting job assignment. I would like to nominate Annette Dyer for Utah County Employee of the Month. Annette's job title does not fully capture the many hats she wears here at the CJC. Annette is the coordinator over our two main volunteer programs: our Onsite Victim Assistance Program as well as our Mentor Program. Annette is continually recruiting, training, and supervising volunteers who generously give their time to the CJC and help in its primary mission to reduce the trauma of the child abuse investigation and help the child feel safe to reveal the truth. Having our center in a heavily populated college town means we have frequent turn over with our volunteers who are not permanent residents or are getting involved as part of a school assignment. If volunteers are not able to come in for their assigned two-hour weekly shift, Annette will try and contact a substitute, but more times than not, acts as the volunteer during that shift spending her time

with children down in our waiting rooms keeping them engaged in fun activities while they wait for their interview and investigative officials to meet with their parents. Annette has a natural comfort with children and can engage with kids of all ages, with varied backgrounds, behaviors, and needs. She can very quickly gauge the kids' interest. I've walked in on fun imaginative Lego creation projects and intense games of Jenga.

In addition to recruiting and maintaining the onsite program, Annette is keeping track of multiple families and mentors participating in our Mentor Program. Mentors are community volunteers who go through 40 hours of training and commit to working one-on-one with a child whose been through our center for a 6-month period. 3 times a year she organizes the training (inviting the speakers, preparing the materials, advertising the training, hosting the training, etc.) This is a huge project undertaking and this training always receives such high words of praise for both content as well as overall experience. She is very invested in not only the success of the program, but the experience for the child, the family, as well as the mentor. She follows-up regularly with both the family and the mentor during the placement to ensure a successful match has been made.

As if dealing with 50+ volunteers (and their communications, needs, and personalities) isn't enough she is also the first person who volunteers to help cover phones, help a walk in, do an intake with a family when appointments have been double/triple booked, read someone's grant report and offer constructive feedback and assistance, clean up and log a donation, etc. She is one of the hardest working, most dedicated staff at the center and we're lucky to have her with us.

I could go on and on for pages and pages about the amazing things Annette does. I feel she is deserving of this recognition and our appreciation.

- 1) HEALTH & JUSTICE BUILDING PARKING STRUCTURE THERE IS A BRICK VENEER ON THE BUILDING THAT IS STARTING TO DELAMINATE FROM THE STRUCTURE, AND IT NEEDS TO HAVE SOME REPAIR WORK DONE. WHAT THE GSBS CONTRACT WOULD DO IS DESIGN THE FIX AND DO ALL THE BIDDING DOCUMENTS TO BE ABLE TO GO OUT TO A CONTRACTOR TO HAVE THE WORK DONE.
- 2) EFIS REPAIRS ON THE SECURITY CENTER IN SPANISH FORK THE STUCCO IS AGING OUT AND NEEDS TO HAVE SOME REPAIRS DONE ON IT.

ONE OF THE QUESTIONS THAT I HAVE IS THAT I UNDERSTAND THAT THIS IS INTENDED FOR A ONE-YEAR PURPOSE AND THEN HOPEFULLY WE'LL HAVE OUR OWN BUILT. WASN'T THERE A COMPANY THOUGH, INSTANT PAY, THAT SAID THAT THEY'D DO IT FOR FREE? I'M JUST WONDERING WHEY WE'RE PAYING FOR SOMETHING IF WE'RE DOING IT FOR A ONE-YEAR PERIOD OF TIME IF WE'RE GOING TO REBUILD IT OURSELVES AT THE END OF THE ONE YEAR?

RICHARD NIELSON, DIRECTOR OF PUBLIC WORKS – INSTANT PAY I BELIEVE, COVERED THE PAYMENT SIDE OF IT. IT DID NOT COVER THE RESERVATION SIDE OF IT SO THIS WOULD MAKE AN ALL ONLINE SYSTEM FOR PARKS, RESERVATIONS PAVILIONS, CAMPING SITES – THINGS LIKE THAT. IT WOULD ALSO MAKE IT IS SO WE CAN DO THE ONLINE PAYMENT. WITH THE SUGGESTIONS FROM I.T. IS THAT WE GO WITH THIS IN A CONTRACT FOR A YEAR AND THEN HOPEFULLY WITHIN THAT YEARS' TIME, THEY WOULD HAVE THE BANDWIDTH TO BE ABLE TO GO IN AND ACTUALLY GET US A SYSTEM BUILT THAT WOULD ALLOW US TO DO ALL OF THE RESERVATIONS AND PAYMENTS ONLINE THROUGH A COUNTY SYSTEM.

COMMISSIONER LEE – I'VE HAD PROBLEMS WITH ASSET WORKS AND OBVIOUSLY I VOTED AGAINST IT WHEN IT WAS FIRST BEING IMPLEMENTED. THERE WERE SOME PROMISES THERE THAT WE'D HAVE SOME THINGS THAT WOULD HAPPEN WITH ASSET WORKS AND IT'D BE ONLINE, AND WE'D GET SOME PROGRAMS OUT OF IT WHICH WE'RE STILL WORKING ON UNFORTUNATELY. WE'RE GETTING RID OF A PROGRAM TO GET ANOTHER PROGRAM WHICH HAS HARDWARE AND SOFTWARE BUT ALSO THERE IS SOME TRAINING THAT'S GOING INTO IT AS WELL. THIS IS NEW ENOUGH IN THE WAY OF THIS PROGRAM THAT I DON'T UNDERSTAND WHY WE DIDN'T KNOW ABOUT THIS WHEN WE WERE GOING THROUGH THE PURCHASING PROCESS. IS IT NEW? I DON'T UNDERSTAND WHY

IT'S A COMPONENT THEY HAD IN ASSET WORKS. AT THE TIME WE WERE NOT ANTICIPATING CHANGING IT OUT FROM PETROVAN. IN THE TIME THAT WAS TAKEN TO GET EVERYTHING UP AND RUNNING WITH ASSETS WORKS, WE'VE HAD SOME ISSUES WITH OUR PETROVAN SOFTWARE AND HARDWARE THAT WE NEED TO UPGRADE AND IF WE'RE GOING THROUGH THAT, WE FELT LIKE IT WAS THE MOST ADVANTAGEOUS TO HAVE IT SO IT'S ALL IN ONE SOFTWARE PACKAGE RATHER THAN TRYING TO MAKE THE TWO SOFTWARE PACKAGES MARRY TOGETHER IF WE'RE GOING TO HAVE TO SPEND THE MONEY ANYWAY. THAT'S THE MAIN REASON WHY WE'RE LOOKING AT DOING A CHANGE ORDER NOW BECAUSE WE HAVE HAD SOME SOFTWARE ISSUES ON OUR CURRENT SYSTEM THAT WE'RE GOING TO HAVE TO CHANGE OUT SOFTWARE AND HARDWARE ON WHETHER WE STAY WITH PETROVAN OR GO WITH ASSETS WORKS OR ANY OTHER VENDOR.

COMMISSIONER LEE - WE'VE HAD PETROVAN FOR TWO YEARS NOW?

RICHARD NIELSON – PETROVAN IS ACTUALLY THE ONE WE'VE BEEN USING FOR A NUMBER OF YEARS, PROBABLY 15-18 YEARS. BUT THE HARDWARE IS 'END OF LIFE'. THE IDEA WOULD BE TO CHANGE IT TO THE ASSET WORKS HARDWARE AND SOFTWARE AND HAVE IT ALL ON ONE INTEGRATED SYSTEM THAN HAVE TWO DIFFERENT SYSTEMS WORKING TOGETHER.
