COMMISSIONER AINGE – I RECEIVED A LETTER JUST A SHORT TIME AGO, BUT I HAD RECEIVED A LOT OF COMMUNICATION FROM DIFFERENT MEMBERS OF THE COMMUNITY. I'LL START BY READING THIS LETTER. IT CAME FROM MAYOR WESTMORELAND OF EAGLE MOUNTAIN. ON A NOTE; ONLY 2 OF THE 22 MAYORS DID NOT SUPPORT PUBLICLY THE CHANGE ON PROPOSITION 9 AND MAYOR WESTMORELAND WAS ONE OF THOSE AND I THINK YOU'LL SEE IN THE SPIRIT OF THESE COMMENTS AND THE INTRODUCTION I'M ABOUT TO MAKE THAT THE POINT IS REGARDLESS OF WHERE YOU WERE ON THAT TOPIC, THERE'S A LOT OF CONSENSUS ABOUT SOME CHANGES THAT WE COULD MAKE TO MAKE COUNTY GOVERNMENT MORE EFFECTIVE, MORE EFFICIENT. THIS IS THE LETTER.

"DEAR UTAH COUNTY COMMISSIONERS, THIS PAST ELECTION VOTERS REJECTED A WHOLESALE CHANGE TO UTAH COUNTY'S FORM OF GOVERNMENT, SO WE WILL CONTINUE WITH THE 3-COMMISSIONER STRUCTURE. STILL THE ISSUE OF EFFECTIVE GOVERNANCE REMAINS AS WE TRY TO PROVIDE THE BEST COUNTY GOVERNMENT AT THE LOWEST COST. A CHANGE WOULD BE A STEP IN THIS DIRECTION WOULD BE TO SWITCH FROM DEDICATED PERSONAL ASSISTANTS FOR EACH COMMISSIONER TO A SHARED SUPPORT MODEL. ONLY TWO UTAH COUNITES USE DEDICATED RESOURCES HIRED BY EACH ELECTED OFFICIAL – UTAH AND SALT LAKE COUNTY, THE REMAINDER OF COUNTIES ALL USE A SHARED SUPPORT MODEL (AND THEN HE SAYS WHERE). SOME OF THEIR ADVANTAGES THEY SAY IS RETENTION OF INSTITUTIONAL KNOWLEDGE BECAUSE YOU DON'T HAVE AUTOMATIC TURNOVER WITH NEW ELECTIONS, STAFF ARE VIEWED AS NEUTRAL ON POLITICAL ISSUES. THEY DON'T CARRY THE SAME BAGGAGE AS SOMEONE WHO'S DEDICATED OR ALIGNED WITH EACH OF THE ELECTED OFFICIALS AND BECAUSE THEY REPRESENT THE ENTIRE COMMISSION, ADMINISTRATIVE TASKS CAN BE DELEGATED TO THIS BODY ALLOWING COMMISSIONERS TO FOCUS ON BROADER POLICY AND ADMINISTRATIVE FUNCTIONS. WE BELIEVE THAT SWITCHING TO A SHARED SUPPORT STAFF CAN BE MORE COST EFFICIENT AND PROMOTE A LESS DIVISIVE ENVIRONMENT AT THE COUNTY."

I'M NOT GOING TO READ THE REST OF IT BUT AT THE END HE STATES THAT WITH A NEW COMMISSIONER COMING INTO OFFICE IN JANUARY, THE SOONER

THE COMMISSION ADDRESSES THIS ISSUE, THE LESS DISRUPTION THERE WILL BE AMONG EXISTING EMPLOYEES.

I THINK THAT'S INTERESTING COMING FROM THE COMMUNITY. IN MY OWN OPINION, WE STILL DO NEED TO LOOK AT WAYS THAT WE CAN MAKE COUNTY OPERATIONS MORE EFFECTIVE AND IN WAYS THAT WILL LEAD TO BETTER GOVERNANCE. WHEN I LOOK PAST THE PROP 9 DISCUSSION AND INTO THE COMING YEAR WITH COMMISSIONER LEE AND COMMISSIONER-ELECT SAKIEVICH, I THOUGHT ABOUT HOW WE CAN CONTINUE TO COLLABORATE. TOM AND I RAN AGAINST EACH OTHER IN THE SAME PRIMARY IN 2018 AND DURING THAT TIME, WE BOTH TALKED ABOUT TWEAKS THAT COULD BE MADE. GEOGRAPHIC DISTRICTING WAS SOMETHING WE BOTH SPOKE ABOUT AND THEN IN 2019 HE AND COMMISSIONER LEE WERE SPONSORS OF A PLAN TO MOVE TO A 5-MEMBER COMMISSION WITH 5 GEOGRAPHIC DISTRICTS AND MOVING TO A ½ TIME COMMITMENT.

I WAS READING SOME OF THIS THAT WHEN THE DAILY HERALD ASKED COMMISSIONER LEE ABOUT THE PART-TIME FEATURE, COMMISSIONER LEE SAID, "THIS ALLOWS FOR SOMEBODY TO COME ON AND STILL KEEP THEIR CAREER PATH GOING BUT STILL TO BE FULLY INVOLVED I SEE IT AS INCREASING OUR BASE OF INDIVIDUALS WHO WOULD LIKE TO LOOK AT BEING A PUBIC SERVANT." I WHOLEHEARTEDLY AGREE ON THAT TOPIC. RIGHT NOW, WE CAN'T TAKE ANY ACTION AT THE COUNTY LEVEL TO MOVE TO FIVE. THAT REQUIRES SOME STATE COORDINATION, BUT I'M WILLING TO TAKE A SERIOUS LOOK AT THESE REFORMS WITH COMMISSIONER LEE AND COMMISSIONER SAKIEVICH.

I WENT TO HIGH SCHOOL IN MARICOPA COUNTY, ARIZONA, AND THEY HAVE THIS MODEL. THEY HAVE A 5-MEMBER MODEL GEOGRAPHIC DISTRICTS. THEY'RE BASICALLY A ¾ TIME COMMISSION BOARD OF SUPERVISORS AND I SPOKE WITH THEM AND ASKED, "HOW DO YOU DO THAT? HOW DOES IT NOT FEEL LIKE YOU HAVE 5 CEO'S TRYING TO DO VERY ADMINISTRATIVE TASK?" THEY RESPONDED SAYING THAT IT WORKS WELL FOR THEM BECAUSE THEY HAVE A STRONG ADMINISTRATOR AND THEY WERE BAFFLED TO HEAR THAT WE DID NOT HAVE THAT TYPE OF FUNCTION. SO, AS I LOOK TO EXPLORE THIS MODEL, I THINK THERE'S A LOT OF BENEFITS TO IT EVEN WITHOUT THAT, BUT I DO THINK IT'S IMPORTANT THAT WE LOOK AT THIS SHARED STAFF AS THE MAYOR SAID OR ADMINISTRATIVE FUNCTION.

SO ON TO WHAT THIS AGENDA ITEMS ACTUALLY IS, IS THAT'S WHAT IT DOES – IT CREATES AN ADMINISTRATOR POSITION. I'VE GONE BACK AND FORTH ON THE TITLE. I THINK ON THE AGENDA ITEM IT SAYS, 'CHIEF ADMINISTRATIVE OFFICER'. YOU COULD ALSO CALL IT A 'DIRECTOR OF ADMINISTRATION AND PUBLIC AFFAIRS'. THAT SPEAKS TO 2 OF THE MAIN ISSUES THAT YOU COMMONLY HEAR WITH PEOPLE WHO DEAL WITH COUNTY GOVERNMENT IS: 1) SOMEONE NEEDS TO HAVE THAT CENTRALIZED TASK TO TAKE CARE OF THOSE SMALL THINGS AND 2) ON THE PUBLIC AFFAIRS SIDE, IT'S REALLY HARD TO UNDERSTAND COMMUNICATIONS FROM THE COUNTY WHEN IT COMES FROM 3 DIFFERENT VOICES AND FOR SOME BASIC THINGS, WE DO NEED AT LEAST A

SINGLE POINT OF CONTACT. SO, THAT'S WHY THE PUBLIC AFFAIRS SIDE IS IN THERE.

THIS IS THE PROPOSAL. ON THE BUDGETARY PERSPECTIVE, ALL OF THE FUNDING NEEDED FOR THESE POSITIONS IS ACTUALLY AVAILABLE IN OUR NON-DEPARTMENTAL BUDGET. I WOULD CUT OUT ECONOMIC DEVELOPMENT. SOME OF THE MEMBERSHIP FEES THAT WE HAVE IN THERE AND LOBBYING CONTRACT TO BE ABLE TO PAY FOR THIS ON THE NON-DEPARTMENTAL SIDE AND SO THEN IF WE REMOVED THE SENIOR POLICY ADVISORS, THAT WOULD BE A SAVING OF \$300,000 IN THE COUNTY COMMISSION BUDGET. WE COULD ALSO HAVE A CONVERSATION ABOUT KEEPING SOME TYPE OF SUPPORT THERE FOR EACH OF THE COMMISSIONERS, BUT I FEEL STRONGLY ABOUT THIS. I'M HAPPY TO MOVE FORWARD WITH SOMETHING LIKE THIS. I'M HAPPY TO HAVE A DISCUSSION ABOUT THIS AND I AT LEAST WANTED TO GET IT OUT THERE AS WE LOOK INTO THE NEW YEAR.

COMMISSIONER LEE - WELL, I'VE LOOKED THIS OVER. MONDAY NIGHT IS WHEN I FIRST HEARD ABOUT IT. I THINK THERE'S A LONGER DISCUSSION THAT NEEDS TO BE HAD WITH THIS, ESPECIALLY WITH COMMISSIONER-ELECT TOM SAKIEVICH COMING IN. I WOULD PREFER THAT IT WOULD BE A DISCUSSION THAT WE HAVE TOGETHER WITH THE NEW COMMISSION NEXT YEAR. I WOULD HAVE A HARD TIME AS A NEW COMMISSIONER COMING IN, WITH A PROPOSAL LIKE THIS WITHOUT HAVING CONVERSATION. I UNDERSTAND THAT YOU HAVE SOME PROVISIONS IN HERE TO LOOK AT IT, OR RATIFIED. I CAN'T REMEMBER WHAT THE TERMS WERE ON THERE INTO FEBRUARY OF NEXT YEAR AND I GUESS IF THE CASE IS THAT YOU JUST WANT TO START THE BALL, I CAN UNDERSTAND THAT. I WILL BE VOTING 'NO' ON THIS ONE JUST BECAUSE I THINK THAT IT'S A DISCUSSION FOR NEXT YEAR.

COMMISSIONER AINGE - YOU WOULD HATE FOR A NEW INCOMING COMMISSIONER TO HIRE SOMEONE ON THE DEDICATED MODEL ONLY IF THERE'S GOING TO BE A SWITCH, SO IN SOME WAYS THIS IS ACTUALLY TRYING TO HELP PLAN AND ACCOMMODATE THE FACT THAT THERE'S BEEN SOME DISCUSSION ABOUT THIS AND SO PERHAPS THIS IS A WAY OF GIVING COMMISSIONER-ELECT SAKIEVICH SOME OF DIRECTION OF WHAT DIRECTION WE'RE GOING SO HE CAN PLAN ACCORDINGLY.

COMMISSIONER LEE - I BELIEVE FROM MY CONVERSATIONS WITH RALPH BARNES, THAT AN OFFER HAS ALREADY BEEN EXTENDED. HE MENTIONED TO ME THAT AN OFFER HAS ALREADY BEEN EXTENDED FROM COMMISSIONER-ELECT SAKIEVICH TO SOMEBODY. I KNOW DON'T WHO THAT IS OR WHAT THE PROCESS IS. I THOUGHT THEY WERE, FROM WHAT RALPH TOLD ME, POSSIBLY STARTING THE ONBOARDING SOON. SO THAT'S ALREADY STARTED.

COMMISSIONER AINGE – TO ME THAT'S ANOTHER EXAMPLE. IF THIS IS SOMETHING THAT WE CARE ABOUT AND WE WANT TO DO, I THINK THAT ANSWER WOULD SUGGEST THAT WE'RE NOT GOING TO TAKE A SERIOUS LOOK AT THIS BECAUSE ONCE SOMEONE IS HIRED, YOU HATE TO PULL THE RUG OUT FROM UNDER THEM SO QUICKLY. I ACKNOWLEDGE THE POINTS THAT YOU'VE MAKE I THINK THAT THOSE ARE FAIR AND SOMETHING THAT WE NEED TO

CONSIDER. I'M JUST PRESENTING COUNTERPOINTS OF WHY IT MAY BE TIMELY TO ADDRESS IT NOW.

COMMISSIONER IVIE - FOR ME, I ACTUALLY HAVE SOME INITIAL CONCERNS ABOUT THE CHIEF ADMINISTRATIVE OFFICER POSITION. I ALWAYS GET CONCERNED HAVING A NON-ELECTED INDIVIDUAL SERVING AS A CHIEF ADMINISTRATOR SO THAT'S ALWAYS A CONCERN FOR ME WHEN IT COMES TO GOVERNMENT JUST ON A PRINCIPLED MATTER. THE REASON IT TROUBLES ME IS BECAUSE I CAN THINK OF A HANDFUL OF PEOPLE WHO I WOULD ABSOLUTELY LOVE TO SEE IN THAT POSITION AND A HANDFUL OF PEOPLE WHO I WOULD DREAD TO SEE IN THAT POSITION AND SO THAT GIVE ME PAUSE AS TO IF THIS IS REALLY A GOOD MODEL TO GO WITH. IF IT'S HIGHLY DEPENDENT UPON THAT SIMPLY BECAUSE AS A SOON-TO-BE ONLY CITIZEN, I CAN'T VOTE FOR THAT PERSON. IF I VOTE FOR THEM AND THEY WIN, GREAT. IF I VOTE FOR THEM AND THEY LOSE, THAT'S GREAT TOO BECAUSE I STILL GOT THE OPPORTUNITY TO VOTE FOR THE PERSON WHO WOULD BE HANDLING THE VAST MAJORITY OF THE ADMINISTRATIVE OFFICES SO THAT ONE ON A PRINCIPLED MATTERS DOES GIVE ME PAUSE AND CONCERN.

I WOULD SAY ON THE SECOND PORTION OF THIS, I ACTUALLY REALLY LIKED SOME OF THE CONTEXT AND AS WAS PRESENTED IN THE WORK SESSION ON CENTRALIZING SOME OF THE COMMISSION STAFF. I THINK THAT TAKES A LOT OF THE POLITICALNESS OUT OF IT, HELPS THE COMMISSION WORK BETTER AS A WHOLE UNIT AND THESE PEOPLE ARE SIMPLY DEDICATED TO THE COUNTY AS OPPOSED TO ONE INDIVIDUAL. SO, ON THE SECOND PART OF THIS PROPOSAL, THERE'S COMPONENTS TO THAT THAT I REALLY LIKE STRUCTURALLY. MY CONCERN WITH THAT IS I WOULD PERSONALLY WANT TO HAVE A CONVERSATION WITH COMMISSIONER-ELECT SAKIEVICH TO GET HIS FEELINGS ON THAT BECAUSE I DON'T NECESSARILY WANT TO THRUST SOMETHING ON HIM JUST BECAUSE I THINK IT'S A GOOD IDEA, BUT I'D BE HAPPY TO SHARE THAT WITH HIM. THE CHANGES TO SOME OF THE STAFFING I REALLY, REALLY LIKE BUT AGAIN, I HAVE A LITTLE BIT OF PAUSE BECAUSE IF I PUT MYSELF IN MR. SAKIEVICH'S POSITION, I WOULD NOT NECESSARILY APPRECIATE THAT BEING THROWN ON ME COMING INTO OFFICE. COMMISSIONER AINGE – BOND RATING AGENCIES ENCOURAGED US TO PUT THIS INTO PLACE WHICH WE DID BY PASSING A POLICY AND FORMING A COMMITTEE IN 2019 AND NOW WE'RE ACTUALLY GOING THROUGH THE PROCESS OF IDENTIFYING WHICH PROJECTS AND ENSURING THAT WE HAVE FUNDING SET ASIDE FOR THEM. THIS IS A CRITICAL DEVELOPMENT ON OUR PATH TOWARD CONTINUED FISCAL RESPONSIBILITY HERE IN UTAH COUNTY. THIS YEAR WE ADDRESSED OUR OPERATING DEFICIT AND THAT WAS A BIG STEP IN THE RIGHT DIRECTION AND FOR THE FIRST TIME IN 4 YEARS WE OPERATED WITH A STRUCTURALLY BALANCED BUDGET. THE REASONS WHY BOND RATING AGENCIES CARE ABOUT THIS CAPITAL PLAN IS THAT IF WE DON'T HAVE ONE IN PLACE, IT COULD BITE YOU JUST AS MUCH AS INDEBTEDNESS COULD, BECAUSE IF WE HAVE REAL ASSETS THAT ARE DETERIORATING AND ALL OF A SUDDEN YOU HAVE A HUGE OUTLAY THAT'S REQUIRED AND YOU HAVEN'T SET ANYTHING ASIDE THEN THAT'S A LIABILITY JUST AS REAL AS DEBT. THIS IS THE PROCESS WHERE WE'RE GOING TO GO AHEAD AND PASS THIS AND WE HAVE A COMMITTEE.

ONE OTHER COMMENT THAT I'LL MAKE AS WE LEAD INTO THIS, BRIDAL VEIL FALLS IS LISTED ON THIS CAPITAL IMPROVEMENT PLAN AND THERE'S A MILLION DOLLARS GOING TO BRIDAL VEIL FALLS AND THAT WAS PASSED UNANIMOUSLY BY EACH OF THE COMMISSIONERS. I WOULD PROPOSE THAT WE AMEND THAT TO ADD AN ADDITIONAL \$500,000 SO THAT THAT RESOURCE IS PROPERLY ENDOWED GOING FORWARD TO MAKE SURE THAT WE CAN HAVE THE ENHANCEMENTS THAT ARE NEEDED TO PRESERVE IT WITH TRAILS AND THE PROPER LANDSCAPING AND ANYTHING ELSE THAT WE NEED TO DO THE ENHANCE PUBLIC ACCESS AND ENJOYMENT. AMELIA POWERS GARDNER, UTAH COUNTY CLERK/AUDITOR – THE TENTATIVE BUDGET WAS ADOPTED IN OCTOBER. THE TENTATIVE BUDGET FOR 2021 WAS \$106,719,661. SINCE THAT TIME, WE'VE WORKED WITH SEVERAL OF THE DEPARTMENT HEADS AND SOME OF THEM WITHDREW SOME REQUESTS, BRINGING THAT DOWN SOME. ON TOP OF THAT, THE OUTLOOK FOR THE ECONOMY IN 2021 HAS BECOME A LOT SOFTER THAN IT WAS WHEN WE ORIGINALLY CREATED THE TENTATIVE BUDGET, SO OUR EXPECTED REVENUES HAVE COME DOWN SLIGHTLY.

MY DEPARTMENT DID SOME REORGANIZATION AND WE'VE BEEN TALKING ABOUT THIS FOR YEARS AND WE TALKED ABOUT IT MORE RECENTLY WITH YOU COMMISSIONER LEE AND ALSO COMMISSIONER IVIE AND AINGE THAT WE WANTED TO RESTRUCTURE THE WAY THAT WE DO ACCOUNTING A LITTLE BIT. THE MAIN REASON FOR THAT AND ESPECIALLY FOR THE FOLKS LISTENING TO HELP BETTER UNDERSTAND THAT, THERE'S A LOT OF PROGRAMS THROUGHOUT THE COUNTY THAT ARE FUNDED BY STATE AND FEDERAL GRANTS. THEY COME WITH OUTSIDE FUNDS AND THOSE PROGRAMS ARE SUPPLEMENTED BY OUR TAXPAYERS AND BY OUR PROPERTY TAXES IN THE WAY THAT ALL OF THE HUMAN RESOURCE COSTS FOR THE PEOPLE WHO WORK IN THOSE DIVISIONS COME DIRECTLY OUT OF OUR GENERAL FUND AS WELL AS ANY OF THE PURCHASING THAT IS DONE FOR THEM. ANY OF THE ACCOUNTS PAYABLE OR ACCOUNTS RECEIVABLE OR ANY OF THE CIVIL LITIGATION FROM THE ATTORNEY'S OFFICE. ALL OF THOSE THINGS GO TO SUPPORT THESE FUNCTIONS, EVEN IF THESE ARE GRANT FUNDED DIVISIONS. WHEN WE DO THAT, WE'RE SUPPLEMENTING THOSE PROGRAMS. THEY'RE REALLY PRESENTED TO THE PUBLIC AS BEING GRANT FUNDED BUT THEY'RE BEING SUPPLEMENTED USING OUR TAXPAYER DOLLARS. SO, IF WE REARRANGE THE WAY THAT WE DO OUR ACCOUNTING AND ACCOUNT FOR THOSE THINGS, WHAT IT DOES IS IT TAKES SOME OF THOSE OVERHEAD COSTS LIKE H.R. MY AUDITOR FUNCTIONS, INTERNAL AUDIT, ACCOUNTS PAYABLE, ACCOUNTS RECEIVABLE, PURCHASING, THE CIVIL DIVISION OF THE ATTORNEY'S OFFICE, AND PUTS THEM INTO WHAT'S CALLED AN ADMINISTRATIVE FUND AND THEN EACH DEPARTMENT PAYS THAT ADMINISTRATIVE FUND BASED OFF OF THEIR SIZE. THAT MORE ACCURATELY ACCOUNTS FOR THOSE THINGS, WE WERE GOING TO WAIT UNTIL THE END OF 2021 TO REARRANGE THE WAY WE DO ACCOUNTING IN OUR COUNTY SO THAT THAT WOULD BE ACCOUNTED FOR IN THE 2022 BUDGET. BUT WHEN WE REALIZED THAT THE ECONOMIC OUTCOME AND THE OUTLOOK FOR 2021 IS A LOT SOFTER THAN ECONOMISTS THOUGHT IT WOULD BE, THAT WOULD HAVE GIVEN US ABOUT A \$5 MILLION SHORTFALL WITH THE ADJUSTED REVENUE NUMBERS. THAT'S A BIG SHORTFALL FOR US AND SO WE WENT AHEAD AND IMPLEMENTED INTO THIS BUDGET, THAT CHANGE IN ACCOUNTING. THAT WILL MAKE US MORE EFFICIENT AND MORE EFFECTIVE AS A COUNTY AND IT WILL MORE ACCURATELY ACCOUNT FOR THE COST OF INDIVIDUAL PROGRAMS THROUGHOUT THE COUNTY. DOING THAT SAVED US ABOUT \$4 MILLION OUT OF THE GENERAL FUND BECAUSE THAT \$4 MILLION IS THEN REALLOCATED INTO OTHER REVENUE SOURCES AND OTHER FUNDS FOR OTHER DEPARTMENTS. THAT'S REALLY THE BIG DIFFERENCE ON THIS BUDGET.

THEN THERE WERE A COUPLE OF THINGS ON THE BUDGET THAT ALL 3 COMMISSIONERS AGREED UNANIMOUSLY THAT THEY WEREN'T GOING TO

FUND AND SO WE WERE ABLE TO PULL THOSE THINGS OUT OF THE BUDGET. THOSE WERE REQUESTS FROM DEPARTMENTS. THE TENTATIVE BUDGET THAT YOU PASSED WAS THE \$106.7 MILLION. THE BUDGET THAT YOU SEE IN THE SYSTEM RIGHT NOW IS ACTUALLY \$101.6 MILLION SO IT'S GONE DOWN BY ABOUT \$5 MILLION. ABOUT \$4 MILLION OF THAT WAS THIS RESTRUCTURING OF THE WAY WE'RE GOING TO DO ACCOUNTING TO MAKE OUR COUNTY MORE EFFICIENT, EFFECTIVE AND MORE ACCURATELY ACCOUNT FOR THE TRUE COST OF DIFFERENT PROGRAMS THAT THE COUNTY GOVERNMENT OFFERS. THE OTHER \$1 MILLION THAT THIS REFLECTS IS THAT DIFFERENCE ON THOSE REOUESTS FROM THE DIFFERENT DEPARTMENT HEADS – ONES THAT WE FELT COMFORTABLE THAT WE HAD REACHED OUT AND ALL 3 OF YOU COMMISSIONERS UNANIMOUSLY SAID YOU DON'T THINK WE SHOULD FUND THAT. WE PULLED THOSE OUT AND THAT BROUGHT US DOWN ABOUT \$5 MILLION DOLLARS LESS SO THE BUDGET THAT YOU SEE IN THE SYSTEM IS \$5 MILLION LESS THAN THE TENTATIVE BUDGET THAT WAS UNANIMOUSLY ADOPTED IN OCTOBER.

FROM THIS POINT ON, MY DEPARTMENT IS DONE WITH THE BUDGET WITH THE EXCEPTION OF BEING A CONSULTANT FOR YOU AS COMMISSIONERS. AT THIS POINT, IT'S YOUR JOB TO TAKE THIS BUDGET, GO THROUGH AND SEE IF THERE ARE ANY ADJUSTMENT YOU WISH TO MAKE TO THIS, OTHER THINGS YOU WOULD LIKE TO CUT FROM THIS BUDGET OR ADD, SO THAT WE CAN COME UP WITH OUR FINAL NUMBER.

BENJAMIN YOUNG, UTAH COUNTY PUBLIC DEFENDERS OFFICE - LAST WEEK IN THE WORK SESSION BUDGET WAS PRESENTED TO THE COMMISSION REQUESTING \$7,176,298.59. THE FEEDBACK FROM THE COMMISSION WAS TO STRIKE A COUPLE OF THE ASKS. THAT CHANGE WAS MADE, AND THE NEW REQUEST IS \$6,955,569.03. IN THE PROPOSED BUDGET THERE'S AN INTERESTING ALLOCATION OF \$9,443,007.00. I WAS JUST WONDERING IF I COULD GET THE DETAIL OF HOW MUCH OF THAT IS ALLOCATED TO PUBLIC DEFENDERS.

COMMISSIONER AINGE - I CAN SPEAK TO MY BUDGET PROPOSAL. THERE IS A THERE IS A SLIGHT DISCONNECT. I THINK YOU'RE RIGHT TO LOOK TO THAT LINE ITEM OF THE BUDGET. THAT'S WHERE PUBLIC DEFENDER WOULD FUND BUT PASSING THE BUDGET ONLY SETS ASIDE CERTAIN SPENDING. THE FINALIZATION OF ANY BUDGET AMOUNT WITH THE PUBLIC DEFENDER'S OFFICE WOULD NOT BE APPROVED VIA PASSING THE BUDGET - IT WOULD BE APPROVED WHEN A MAJORITY OF THE COMMISSION AGREES TO A CONTRACT WITH THE PUBLIC DEFENDERS AND SO THERE IS A LARGE BUCKET BEING PASSED THAT IS INTERAGENCY AND OUT OF THAT BUCKET IS WHERE THE FINAL NUMBER WILL BE PULLED FROM THAT IS AGREED TO IN A CONTRACT.

SO, THERE ARE TWO STEPS, AND THIS IS JUST ABOUT THE BUDGET AND THEN WE NEED TO FIGURE OUT THE CONTRACT WITH PUBLIC DEFENDERS.

BENJAMIN YOUNG - IS THERE ANY DIVISION WITHIN INTERAGENCY ALLOCATION FOR OTHER ORGANIZATIONS?

COMMISSIONER AINGE - YES THERE ARE OTHER ITEMS IN THAT DEPARTMENT.

BENJAMIN YOUNG - WHERE CAN I GET A DETAIL OF WHAT IS MADE UP OF INTERAGENCY ALLOCATION?

COMMISSIONER AINGE - YOU CAN TALK WITH OUR BUDGET STAFF. THEY WOULD BE HAPPY TO GO THROUGH THAT.

BENJAMIN YOUNG - OK. I WILL GET WITH THEM. THANK YOU.

MARK ALLEN, PROTECT AND PRESERVE AMERICAN FORK CANYON - ONE OF THE THINGS THAT I WOULD LIKE TO SEE YOU BALANCE IS THERE'S ABOUT 700 MAN-YEARS ON THE ATTORNEY PROSECUTORIAL SIDE AND 300 MAN-HOURS OF EXPERIENCE ON THE DEFENDER SIDE. THERE'S HALF THE BUDGET FOR PUBLIC DEFENDERS THAN THERE IS FOR THE PROSECUTORIAL SIDE. THE PRESUMPTION OF INNOCENCE SHOULD FAR OUTWEIGH BUDGETARILY, OR AT LEAST EQUALIZE, SO I'D ENCOURAGE YOU TO BALANCE THAT. GIVE DAVID LEAVITT WHAT HE NEEDS TO DO HIS JOB AND GIVE THE PUBLIC DEFENDERS WHAT THEY NEED TO DO THEIR JOB. RIGHT NOW, PUBLIC DEFENDERS ARE AT A DEFICIT NOT ONLY WITH EXPERIENCE BUT DOLLARS. THANK YOU.

AMELIA POWERS GARDNER, UTAH COUNTY CLERK/AUDITOR - ONE OTHER THING THAT I WANTED TO POINT OUT - I WANTED TO POINT OUT THAT THE \$101 MILLION DOLLAR BUDGET THAT'S BEING PROPOSED RIGHT NOW IS ABOUT \$3 MILLION LESS THAN OUR 2020 ACTUALS. SO, OUR 2021 BUDGET WOULD BE LOWER THAN OUR 2020 BUDGET.

VIC DEAUVANO - I WANT TO TALK JUST ABOUT THE BUDGETARY ITEM AND I JUST HEARD THAT YOU'RE TALKING ABOUT IMPLEMENTING THE \$1 MILLION AND THEN ANOTHER \$500,000 AND I'M WONDERING, IS THAT GOING INTO THE 2021 BUDGET OR IS THAT COMING OUT OF THE 2022 BUDGET IF YOU'RE NOT IMPLEMENTING TILL 2022 AND 2023 IS WHAT I HEARD. WHERE IS THAT MONEY COMING FROM AND IS IT GOING TO BE APPROPRIATED IN 2021 OR IS IT BEING APPROPRIATED IN 2022-2023? I HEARD THAT NOTHING WAS GOING TO BE DONE UNTIL THE 2022-2023.

AMELIA POWERS GARDNER - WE WERE GOING TO WAIT TO IMPLEMENT IT JUST BECAUSE OF THE WORKLOAD IT WOULD TAKE, AND WE DECIDED TO ACCELERATE THAT. WE WILL BE IMPLEMENTING IT IN 2021.

VIC DEAUVANO - SO WHAT ARE WE DOING SINCE YOU'RE APPROPRIATING THAT MONEY. WHAT ARE YOU DOING WITH ABOUT THE OTHER \$700,000? YOU GUYS BOUGHT IT FOR LIKE \$2.3 MILLION, AND I'M JUST WONDERING ON

APPROPRIATIONS - WE PAID THAT MONEY OUT. WHEN DID THAT MONEY COME OUT FOR BRIDAL VEIL FALLS?

AMELIA POWERS GARDNER - WE HAVEN'T TALKED ABOUT BRADWELL FALLS YET THAT'LL BE NEXT.

VIC DEAUVANO – NO, I'M NOT TALKING ABOUT WHAT'S GOING ON WITH BRIDAL FALLS. I'M TALKING ABOUT BUDGET -DID THAT BUDGET MONEY OVER THE LAST FIVE YEARS OR WAS IT THE YEAR THAT HE PURCHASED IT OR IS THERE STILL MONEY?

COMMISSIONER IVIE - I THINK I UNDERSTAND YOUR QUESTION. SO, WE HAVE ALREADY SET ASIDE IN PREVIOUS BUDGETS THROUGH OUR TRCC FUNDING, \$1 MILLION FOR IMPROVEMENTS TO BRIDAL VEIL FALLS. THAT PROJECT WAS ACTUALLY SLATED TO START IN SPRING OF THIS YEAR AND WITH COVID, OUR PUBLIC WORKS DEPARTMENT ENDED UP PUTTING PLEXIGLASS AND ALL KINDS OF SAFETY PRECAUTIONS IN PLACE AND SO THAT WAS PUSHED BACK AS FAR AS GETTING STARTED BUT THE MONEY WAS STILL SET ASIDE. THEN THE ADDITIONAL \$500,000 THAT WE JUST SPOKE ABOUT THAT FROM COMMISSIONER LEE'S EARLIER MOTION, WILL COME OUT OF OUR TRCC FUND AND BE IMPLEMENTED IN 2021 AS SOON AS A CONTRACT IS PUT IN PLACE WITH PUBLIC WORKS FOR THOSE ENHANCEMENTS THROUGH THE BOARD THAT AUTHORIZES THAT SPENDING.

VIC DEAUVANO - PRIOR TO YOU GUYS BECOMING COMMISSIONERS, YEARS AGO, THERE WAS PROMISES MADE BY THAT COMMISSION THAT THEY WERE GOING TO DO SOMETHING WITH THAT AREA THERE AND NOTHING WAS REALLY EVER DONE SO WE JUST WANT TO MAKE SURE ON FUNDING IF IT'S GOING TO BE APPROPRIATED PROPERLY AND ACTUALLY GO TO THE PROJECT?

COMMISSIONER IVIE – YES, IT IS A LINE ITEM FOR BRIDAL VEIL FALLS AND THAT HAS BEEN APPROVED SPECIFICALLY FOR THAT PROJECT. PUBLIC WORKS HAS A PLAN IN PLACE FOR ENHANCEMENTS AND AGAIN THAT WAS SLATED TO START THIS SPRING BUT BECAUSE OF COVID AND THE DRAW TAKEN ON THEIR PERSONNEL TO MAKE THE MODIFICATIONS TO OUR BUILDINGS AND OTHER THINGS, THAT WAS PUSHED BACK.

VIC DEAUVANO - AMELIA, WE WERE IN A VERY TUMULTUOUS YEAR IN 2020 AND MOST PEOPLE LAID A LOT OF PEOPLE OFF IN OUR COUNTRY AND SO MY QUESTION WHEN I WENT TO CITY HALLS IN A COUPLE OF THE CITIES THIS YEAR AND PROJECTS, I ASKED IF ANY OF THE CITY EMPLOYEES WERE BEING ROTATED TO 3/4 PAY OR ANYTHING ELSE LIKE THAT TO SHOW THE CITIZENS THAT WE WERE ACTUALLY BEING PRUDENT WITH OUR MONEY AND EVERYBODY WAS GOING TO BE IN THIS THING TOGETHER. IN 2020 AND IN THE 2021 BUDGET, WAS THERE ANY ADJUSTMENTS MADE FOR ANY REDUCTION OF PEOPLE WHO WORKED IN THE COUNTY CONCERNING COVID TO EQUAL WHAT WAS OUT IN THE GENERAL PUBLIC?

AMELIA POWERS GARDNER - WE ACTUALLY RECEIVED FUNDING FROM THE FEDERAL GOVERNMENT THAT THEY SENT TO US AND SO WHAT WE DID WITH THAT MONEY IS WE REACHED OUT AND HIRED TEMPORARY WORKERS TO DO

SOME OF THESE PROJECTS. SO, WE TRIED TO REACH OUT TO KEEP AS MANY OF OUR CITIZENS OFF THE UNEMPLOYMENT ROLLS AS POSSIBLE. WE DID TWO THINGS:

- 1) WE ALLOCATED ABOUT \$20 MILLION INTO SMALL BUSINESS GRANTS THAT WERE SPECIFICALLY FOR UTAH COUNTY- BASED COMPANIES SO THAT THEY WERE PAYING THOSE FOR PAYROLL FOR UTAH COUNTY BASED EMPLOYEES SO THE WE SPENT \$20 MILLION REACHING OUT TO JUST SMALL BUSINESSES LOCATED IN UTAH COUNTY
- 2) WE ALSO INCREASED THE DONATION TO THE CHARITABLE ORGANIZATIONS IN UTAH COUNTY I CAN'T REMEMBER THE EXACT NUMBER, BUT IT WAS EITHER \$7 MILLION OR \$10 MILLION, THAT WENT TO THE PEOPLE THAT WERE LAID OFF IN THE COMMUNITY. WE GAVE AN ADDITIONAL AMOUNT OF MONEY TO THOSE CHARITIES TO HELP SUPPORT THOSE PEOPLE.

THEN AS WE HAD TO DO THINGS LIKE OUR PUBLIC WORKS DEPARTMENT HAVING TO INSTALL PLEXIGLASS, WE TRIED TO HIRE SOME OF THESE PEOPLE THAT WERE FURLOUGHED IN THE PRIVATE SECTOR. IF WE DIDN'T SPEND THE MONEY THE FEDERAL GOVERNMENT GAVE US, THEN WE HAVE TO RETURN IT TO THE FEDERAL GOVERNMENT AND THEN THEY SEND IT TO CHICAGO OR NEW YORK. SO, TO ENSURE THAT THAT MONEY STAYED HERE IN UTAH COUNTY, WE REALLOCATED IT TO THE CITIZENS OF UTAH COUNTY EITHER THROUGH TEMPORARY WORK PROGRAMS FOR THOSE WHO HAVE BEEN LAID OFF, SUPPORTING THE SMALL BUSINESSES OR THROUGH THE CHARITABLE CONTRIBUTIONS.

COMMISSIONER AINGE - ONE ADDITIONAL COMMENT ON THAT. JUST LIKE YOU SAID VIC, IN THE PRIVATE SECTOR YOU SEE UNFORTUNATELY RESTAURANTS AND RETAIL STRUGGLED DURING COVID, BUT COMPANIES LIKE ZOOM WENT THROUGH THE ROOF AND WERE HIRING MORE AND SPENDING MORE. IN THE SAME WAY WE HAD SOME DEPARTMENTS LIKE OUR FIRST RESPONDERS, LAW ENFORCEMENT AND OUR HEALTH DEPARTMENT THAT HAVE BEEN BUSIER THAN THEY'VE EVER BEEN IN THE HISTORY OF UTAH COUNTY AND ACTUALLY ADDED STAFF. BUT THEN FOR EXAMPLE, THE CONVENTION AND VISITORS BUREAU - THEY FURLOUGHED ALMOST ALL OF THEIR STAFF AT ONE POINT THIS YEAR. OUR CONVENTION CENTER ALSO HAD SOME PRETTY DEEP CUTS AND FURLOUGHING AS THERE WERE NO EVENTS COMING THROUGH. SO, THERE WERE SOME OPERATIONAL CUTS TO GET TO YOUR POINT BUT MANY TIMES OUR CORE GOVERNMENT SERVICES, THE DEMANDS ARE ACTUALLY HIGH. ONE THAT PEOPLE DON'T THINK ABOUT IS WITH RATES BEING HELD AS LOW AS THEY ARE, AND I'M NOT SURE WHAT OTHER FACTORS ARE INVOLVED, BUT IN THE MIDST OF THIS THE AMOUNT OF REFINANCINGS HAS GONE THROUGH THE ROOF SO RECORDER'S OFFICE HAS BEEN BUSIER IN 2020 THAN THEY'VE EVER BEEN AT ANY TIME IN UTAH COUNTY. SO, JUST A LITTLE BIT MORE COMMENTARY FOR YOU.

VIC DEAUVANO - I APPRECIATE THAT. WE HAVE A PROJECT IN DOWNTOWN SALT LAKE ON SUNDAYS AND I JUST DROVE BACK LAST WEEK FROM SUNDAY ON STATE STREET ALL THE WAY TO 123RD DRAPER EXIT, AND I JUST NOTICED

HOW MANY SMALL BUSINESSES HAVE ACTUALLY CLOSED THEIR PLACES. I FEEL BAD FOR THEM. I FEEL BAD FOR ALL OF US WITH WHAT WE'VE GONE THROUGH IN THIS THING AND JUST WANT TO MAKE SURE THAT WE ARE TIGHT IN OUR BUDGETS AND STUFF LIKE THAT AND I THINK UTAH COUNTY'S BEEN VERY PRUDENT WHAT THEY'VE DONE BUT I JUST ASKED HIM THAT QUESTION SO I APPRECIATE IT.

AMELIA POWERS GARDNER - I THINK IT'S A GREAT QUESTION. THE OTHER THING IS WE PRIORITIZED PURCHASING FOR LOCAL SMALL BUSINESSES. FOR EXAMPLE: PLEXIGLASS THAT WE HAD TO PUT UP - WE TRIED, IF AT ALL POSSIBLE, TO GET IT FROM LOCAL COMPANIES. NOT THAT HOME DEPOT DOESN'T HAVE PEOPLE WHO LIVE LOCALLY WORKING THERE BUT INSTEAD OF JUST GOING TO HOME DEPOT BUYING PLEXIGLASS WE'VE REACHED OUT TO THE COMMUNITY FIRST AND SAID ARE THERE ANY SMALL BUSINESSES THAT COULD RE PURPOSE WHAT THEY'RE DOING AND PROVIDE US WHAT WE NEEDED. SO, WE ABSOLUTELY, LIKE COMMISSIONER AINGE MENTIONED, WHERE WE HAD TO FURLOUGH, WE FURLOUGHED BUT WHERE WE WERE IN NEED, WE TRIED TO MAKE SURE THAT WE WERE REACHING OUT TO THE LOCAL COMMUNITY AS MUCH AS POSSIBLE.

VIC DEAUVANO - I'LL JUST SAY THE CHARITABLE PART OF IT WE'RE VERY APPRECIATIVE AT THE COMMUNITY REHAB CLINIC. WE STILL DID ALMOST 6,000 HOURS OF REHAB DONE BY THE PROFESSIONAL STAFF OF MASTER'S AND GRADUATE STUDENTS AT THE ROCKY MOUNTAIN UNIVERSITY, SO THANK YOU FOR THAT. FIRST, BRIDAL VEIL FALLS HAS NOT BEEN FOR SALE. THAT SEEMS TO BE A NARRATIVE THAT HAS BEEN PUSHED AROUND OVER AND OVER THAT BRIDAL VEIL FALLS IS FOR SALE. 

IN THE 1960S, A PRIVATE ENTITY BUILT ON THE LAND UP THERE AND BUILT THE TRAMWAY THAT WENT ON TO THE TOP OF THE FALLS, HAD HAD A RESTAURANT AT THE TOP. IN 1996 THE LOWER SECTION OF THAT TRAM, THE LOWER TRAM BUILDING WAS DESTROYED BY AN AVALANCHE. IN 2008 THE BUILDING AT THE TOP, THE OLD RESTAURANT, WAS DESTROYED BY FIRE. AND IN THE LATTER PART OF 2014, THE LANDOWNERS WERE TRYING TO SELL THE PROPERTY. THEY HAD SOME INTERESTED PARTIES. THERE HAD BEEN A CONDITIONAL USE PERMIT, I THINK IS THE RIGHT TERM ROB, IS THAT RIGHT? (AFFIRMATIVE) AND THAT WAS APPROVED IN THE 1990S THAT ALLOWED FOR COMMERCIAL AND RESIDENTIAL DEVELOPMENT IN AND AROUND THE AREA BY BRIDAL VEIL FALLS. NOW THE COUNTY COMMISSION AT THE TIME SAID I THINK WE OUGHT TO BUY THIS, AND AT THAT POINT I WAS DIRECTED TO WORK WITH THE PROPERTY OWNERS AND THE COUNTY DID ULTIMATELY PURCHASE THE PROPERTY IN 2015. IN 2017 BECAUSE OF THE OLD TRAM SHACK THAT HAD BEEN PARTIALLY DESTROYED BY AN AVALANCHE AND THE REMAINDER OF THE BUILDING ON THE TOP THAT WAS THE OLD RESTAURANT, THE COUNTY CONTRACTED WITH A CONSTRUCTION FIRM TO DO THAT REMOVAL AND SPENT ABOUT \$1,000,000 TO REMOVE THOSE TWO STRUCTURES AND DO SOME OTHER CLEANUP WORK AROUND THE FALLS. THERE WAS AN OLD BRIDGE STRUCTURE THAT WAS THERE, IT WAS A VERY UNIQUE DEMOLITION PROJECT WHEN YOU'RE WORKING IN THE TOP OF 1100 FOOT CLIFF. EVERYTHING HAD TO BE FLOWN OUT BY HELICOPTER. ALSO, IN 2017 WE WERE DIRECTED BY THE COUNTY COMMISSION TO DO A SURVEY AND TRY TO GET USER INPUT. AND WE DID THAT AND COMMISSIONER LEE KIND OF ALLUDED TO IT IN HIS COMMENTS. WE DIDN'T GET A WHOLE LOT OF RESPONSE, WE HAD 50 OR 60, BUT NOT A GREAT DEAL OF RESPONSE FROM THE PUBLIC BUT THAT THEY DID ALL, THE MAJORITY OF THOSE COMMENTS WERE THAT THEY WANTED TO SEE THE FALLS STAY OPEN SPACE AND HAVE SOME IMPROVEMENTS TO ENHANCE THE FALLS THEMSELVES BUT NOT MAJOR IMPROVEMENTS UP THERE THAT WOULD BE IN THE LINE OF LIKE COMMERCIAL DEVELOPMENT AND THAT SORT OF THING. IN 2018 WE DID A REQUEST FOR PROPOSALS TO HAVE CONCESSIONAIRE GIVE US SOME PROPOSALS ON WHAT THEY COULD DO IN AND AROUND THE AREA, WHAT IMPROVEMENTS COULD BE DONE. THE COMMISSION REVIEWED THOSE AND ULTIMATELY DID NOT SELECT ANY OF THOSE. AND THEN IN 2019 THE MAJORITY OF WHAT'S ON THE SCREEN NOW IN THE CONCEPT PLAN WAS APPROVED BY THE COUNTY COMMISSION. I'LL JUST POINT OUT TO YOU A COUPLE OF THINGS THAT ARE ON THERE. THIS DOES ENHANCE SOME OF THE PARKING AND TAKES SOME OF THE OLD PARKING LOT OUT THAT'S IMMEDIATELY ACROSS FROM THE FALLS, PUTS THAT INTO A GREENSPACE WHERE PEOPLE CAN COME AND ENJOY THE VIEW OF THE FALLS WITHOUT STANDING IN THE PARKING LOT. THAT'S ON THE ROAD SIDE OF THE RIVER. IT ALSO DOES SOME IMPROVEMENTS ON THE TRAIL TO GIVE AN OPPORTUNITY FOR THE WHEELED TRAFFIC ON THE TRAIL TO BE OVER ON THE ROADSIDE AND NOT DOWN THROUGH WHERE ALL THE PEOPLE ARE STANDING ON THE TRAIL AND ENJOYING THE FALLS. IT INCLUDES SOME SMALL PAVILIONS WITH PICNIC TABLES. IT INCLUDES A RESTROOM, INCLUDES SOME TRAIL IMPROVEMENTS AND THEN ALSO A CONNECTION TO THE UPPER PARKING LOT THAT'S OFF THE HIGHWAY THAT'S NOT THERE NOW. THE THINGS THAT HAVE CHANGED ON THIS PLAN FROM WHEN THE COMMISSION APPROVED IT, IS TO THE LEFT SIDE OF THE SCREEN THERE'S A PARKING LOT DOWN TOWARDS THE HIGHWAY AND

THERE'S ALSO A GREEN BOX THERE THAT'S A PAVILION, IT WOULD BE ONE OF THE LARGER PAVILIONS THAT CITIZENS COULD RENT TO HOLD A FAMILY FUNCTION OR SOMETHING LIKE THAT. THERE WOULD ALSO BE SOME GREEN SPACE IN THAT AREA. IT ALSO INCLUDES UP NEAR THAT UPPER PARKING LOT THAT'S ACTUALLY ON UDOT PROPERTY A POTENTIAL FOR A VISITOR CENTER THAT COULD BE BUILT THERE AT SOME POINT IN THE FUTURE. THAT'S NOT SOMETHING THAT'S IN THE IMMEDIATE PLANS, BUT IT IS SOMETHING THAT COULD BE OUT THERE LATER ON. JUST BY WAY OF WHAT OUR NEIGHBORS ARE, THE PROPERTY TO THE EAST OF THE FALLS, SO UP CANYON, IS OWNED BY THE FOREST SERVICE. UTAH COUNTY OWNS NOW IT'S ABOUT 30 ACRES ISH IN AND AROUND THE FALLS AND THEN THE PROPERTY DOWN CANYON AND ON THE SOUTH SIDE OF THE RIVER IS ALL OWNED BY PROVO CITY. THE PROPERTY ALL AROUND BRIDAL VEIL FALLS IN PUBLIC OWNERSHIP AND IT IS SOMETHING THAT TO MY KNOWLEDGE, THERE'S NOT ANY DESIRE BY ANY OF THOSE ENTITIES TO DO ANYTHING COMMERCIALLY. PROVO CITY DOES ALSO HAVE SOME CULINARY SPRINGS THAT ARE IN THE AREA AND HAVE SOME PIPING IN THE AREA. MR. MOORE ALSO TALKED ABOUT THE CENTRAL UTAH WATER. NOW CENTRAL DOES OWN THE WATER RIGHTS FOR THE WATER THAT COMES OFF OF THE WATERFALLS. THERE IS A CURRENT COLLECTION POINT RIGHT AT THE BASE OF THE FALLS, BEFORE IT COMES DOWN TOWARDS THE TRAIL AND A PIPELINE THAT GOES FROM THERE OVER INTO THEIR AQUEDUCT ON THE OTHER SIDE OF THE CANYON. WHAT CENTRAL UTAH WOULD LIKE TO DO IS TO RECONSTRUCT. A COLLECTION POINT WOULD BE DOWN AT THE TRAIL AND ACTUALLY BE UNDERNEATH THE BRIDGE TO WHERE IT WOULD BE PROTECTED AND KIND OF OUT OF SIGHT, AND THEN A PIPELINE THAT WOULD GO OVER ON THE NORTH SIDE OF THE OF THE OLD HIGHWAY AND BUILD A SMALL PUMP STATION THAT WOULD BE TUCKED BACK INTO THE HILLSIDE, THAT'S WHERE THE EASEMENT COMES INTO PLAY IS GETTING FROM THERE BY THE TRAIL OVER TO THAT TO WHERE THEIR EXISTING EASEMENT IS ON THE PIPELINE. EVERYTHING WOULD BE UNDERGROUND WITH THE EXCEPTION OF THAT SMALL PUMP HOUSE THAT WOULD BE TUCKED BACK INTO THE HILLSIDE ON THE OTHER SIDE OF THE ROAD, KIND OF DOWN AROUND THE CORNER FROM THE FALLS. OTHER QUESTIONS FOR ME BEFORE I SIT DOWN?

COMMISSIONER LEE – NO, IT'S GREAT AND THANK YOU. AND I THINK THE ENHANCEMENT THAT YOU HAVE WITH THE PARKING LOT, I LOVE THE CONCEPT PLAN ON THIS. COULD YOU JUST GO OVER A LITTLE BIT MORE THOUGH ON THE TRAIL AND THE CHANGE IN THE TRAILS?

RICHARD NIELSON - ON THE PROVO RIVER?

COMMISSIONER LEE – NO, I'M TALKING ABOUT HOW WE ARE TRYING TO SEPARATE THE BIKERS FROM, YEAH, I THINK THAT'S AN IMPORTANT ENHANCEMENT THAT I LIKE IN THERE TOO.

COMMISSIONER IVIE - WE RECEIVED A LOT OF EMAILS IN OUR EMAILS THAT THAT WAS A CONCERN.

RICHARD NIELSON - SO ONE OF THE THINGS THAT WE'VE SEEN IN PUBLIC WORKS IS THE CONFLICTS IF YOU WILL, FROM THE WHEELED TRAFFIC, THE

CYCLISTS AND THE LONG-BOARDERS, THINGS LIKE THAT AND THEN THE PEDESTRIAN TRAFFIC THAT'S THERE AT THE FALLS, BECAUSE OFTENTIMES THE PEDESTRIAN TRAFFIC IS MORE STATIONARY. THEY'RE THERE TO LOOK AT THE FALLS WHERE THE OTHER USERS ARE TRYING TO GO THROUGH. WHAT THIS PROJECT WOULD DO IS WE'D GO ABOUT 500 FEET UPSTREAM FROM WHERE THE CURRENT FOOTBRIDGE IS AND TAKE THE TRAIL THAT'S CURRENTLY THERE NOW, TURN IT AND CROSS ON A NEW BRIDGE, ACROSS TO THE NORTH SIDE OF THE OLD HIGHWAY, RIGHT BELOW THE HILL. AND THAT WOULD BE WHERE THE WHEELED TRAFFIC, THE PEOPLE THAT JUST WANT TO GO UP AND DOWN THE CANYON ON THE TRAIL, THAT'S WHERE THEY WOULD GO. THE CURRENT TRAIL WOULD THEN BE RECONSTRUCTED BETWEEN THAT POINT AND THE PROVO CITY PARK, WHERE THE TRAIL SPLITS UP 500 OR 600 FEET BELOW THE FALLS. AND IT WOULD BE RECONSTRUCTED IN THAT AREA WITH CONCRETE AND IF YOU KNOW WHAT A STRIKE JOIN IS, IT'S THE LINES THAT ARE ACROSS THE CONCRETE. ONE REASON WE WOULD DO THAT RATHER THAN ASPHALT IS IF YOU'RE ON A BICYCLE AND YOU HIT THOSE JOINTS, IT'S NOT AN ENJOYABLE RIDE. SO, WE DO THAT TO TRY TO ENCOURAGE THE CYCLIST TO GET OVER ON THE OTHER SIDE. IF THEY WANT TO GO THROUGH, THAT GIVES THEM PLENTY OF ROOM TO GET THROUGH THERE, BUT IT MAKES IT SO WE DON'T HAVE THOSE CONFLICTS IN THAT AREA. THE WHEELED TRAFFIC WOULD THEN REJOIN THE MAIN PROVO CANYON TRAIL DOWN AT THE BRIDGE GOING INTO NUNN'S PARK.

COMMISSIONER LEE -YEP, VERY GOOD.

COMMISSIONER IVIE - THANK YOU.

COMMISSIONER AINGE – OKAY, THANK YOU FOR THIS OVERVIEW. ROB, I DO THINK IT PROBABLY MAKES SENSE GIVEN THAT UTAH OPEN LANDS' IS ON THE RECEIVING END OF A POTENTIAL CONTRACT THAT WE VOTE ON HERE TONIGHT, TO GIVE THEM A MOMENT PRIOR TO THE PUBLIC HEARING.

JOSH DANIELS, CHIEF DEPUTY, COUNTY CLERK/AUDITOR – OKAY, WE'RE GOING TO UNMUTE WENDY FISHER HERE IN A MOMENT. OKAY. WENDY SHOULD BE ABLE TO UNMUTE HERSELF NOW SO THAT SHE CAN SPEAK.

WENDY FISHER, EXECUTIVE DIRECTOR, UTAH OPEN LANDS' – WELL IT'S A PLEASURE TO BE WITH ALL OF YOU HERE TONIGHT. I'M WENDY FISHER. I AM THE EXECUTIVE DIRECTOR OF UTAH OPEN LANDS' AND TO GIVE JUST A BRIEF OVERVIEW, I WANTED TO MAKE SURE THAT IT WAS CLEAR THAT ACTUALLY UTAH OPEN LANDS' IS NOT A COMPANY. RATHER WE ARE A 501(c)3 PUBLIC CHARITY. WE ARE ESTABLISHED UNDER A SPECIFIC PART OF THE FEDERAL CODE, UNDER 178 THAT ALLOWS US TO ACCEPT CONSERVATION EASEMENTS AND TO BE A QUALIFIED ENTITY. WE ARE ALSO A NATIONALLY ACCREDITED ORGANIZATION THAT HAS THE ABILITY TO HOLD CONSERVATION EASEMENTS AND THAT EXEMPLIFIES AS PART OF THAT NATIONAL ACCREDITATION THE HIGHEST STANDARDS IN THE NATION AMONG WITH OTHER LAND TRUST ORGANIZATIONS. WE HAVE BEEN AROUND FOR 30 YEARS. I HAVE ACTUALLY BEEN WITH THE ORGANIZATION SINCE ITS INCEPTION AND FOR ME HAVING GROWN UP IN UTAH COUNTY, I AM VERY FAMILIAR WITH BRIDAL VEIL FALLS. I

THINK THAT WHAT IS PROBABLY IMPORTANT TO ALSO UNDERSTAND IS THAT AS UTAH OPEN LANDS' HAS HEARD BOTH FROM THE PUBLIC AND ALSO AS WE WERE APPROACHED IN TERMS OF HOW CONSERVATION EASEMENT WOULD WORK FROM THE UTAH COUNTY PERSPECTIVE, IT IS ONE, NOT SOMETHING THAT IS UNFAMILIAR. IN FACT, WE HOLD CONSERVATION EASEMENTS ON LAND THAT NUMEROUS CITIES AND COUNTIES OWN, INCLUDING CONSERVATION EASEMENTS ON STATE OWNED LAND, SUCH AS WASATCH MOUNTAIN STATE PARK, WHERE A JOINT EFFORT HELPED TO PRESERVE SNAKE CREEK CANYON. PROBABLY MOST PEOPLE IN THE AUDIENCE ARE FAMILIAR WITH ONE OF OUR MORE RECENT CAMPAIGNS, WHICH WAS THE PROTECTION OF THE BONANZA FLAT PROPERTY AT THE TOP OF BIG COTTONWOOD CANYON. SO, WHEN A CONSERVATION SOLUTION IS SOMETHING THAT FOLKS ARE LOOKING AT, THAT IS SOMETHING THAT UTAH OPEN LANDS' IS VERY FAMILIAR WITH AND WE'VE DONE IT WITH PRIVATE LANDOWNERS AS WELL AS PUBLIC LANDOWNERS. I ALSO WANT TO MAKE IT VERY CLEAR THAT THIS IS NOT AN ASSET THAT IS BEING GIVEN TO UTAH OPEN LANDS', RATHER I THINK AS COMMISSIONER AINGE INDICATED, THIS CONTRACT CREATES AN OBLIGATION FOR UTAH OPEN LANDS' TO PRESERVE, PROTECT, STEWARD, AND DEFEND THE CONSERVATION VALUES AS ITERATED BY THE COUNTY COMMISSION OF THE LANDSCAPE OF THE PROPERTY TO BE PROTECTED. THIS IS SOMETHING THAT WE DO IN PERPETUITY, AND WE UNDERSTAND THE OBLIGATION. THE CONSERVATION EASEMENT AS WE SEE IT, AND I THINK IT WAS PRESENTED BY THE STAFF, IS SOMETHING THAT CERTAINLY IS IN CONCERT WITH ANY INTENTION OF THE PURCHASE WITH RESPECT TO ITS PERMANENT PRESERVATION AND IS SOMETHING THAT THE ORGANIZATION CAN WORK TO ACHIEVE. WE HAVE BEEN VERY GRATEFUL TO ENGAGE IN THIS. WE STAND READY TO WORK THROUGH ANY ISSUES, BUT WE ALSO FEEL THAT WE'VE HELPED TO PROVIDE A PATH FOR CONSERVATION. AND WE APPLAUD THE COMMISSION AND THE PUBLIC FOR LOOKING AT THE POTENTIAL OF HAVING A CONSERVATION SOLUTION FOR THIS PARTICULAR PIECE OF PROPERTY IN PERPETUITY.
