THINKING ABOUT THOSE INTERRUPTIONS THIS MORNING MADE ME WONDER WHAT THE FACILITIES MANAGEMENT PLAN WAS FOR THIS CLIFF-TOP LODGE? DAILY HELICOPTER DROPS WITH THE SPECIALTY FRESH VEGETABLES AND MEATS THAT THE ELITE RESIDENTS WILL DEMAND? CONSTRUCTION OF AN ACCESS ROAD UP THE STEEP ROCKY SLOPES TO HAUL UP CONSTRUCTION MATERIALS, THEN KITCHEN AND LAUNDRY FACILITIES?

HAVE TRAINED COUNSELORS WEIGHED IN ON THE HAZARDS TO FOLKS SUFFERING FROM SUICIDE IDEATION WHO FIND THEMSELVES NEAR CLIFFS IDEAL WITH ONE SO INCLINED TO JUMP? IS THIS A SUITABLE LOCATION FOR SUCH A FACILITY?

ALL THAT'S CONFUSING NOW. I AM CONTENT
TO WATCH THE WORLD TURN COLD WITH ITS OLD GRACE.

WE NEED, AS A PEOPLE, A PLACE FOR POETS WHO ARE STIRRED BY BEAUTY TO WRITE POEMS THAT STIR OUR SOULS. WE NEED A PLACE WHERE FAMILIES CAN GATHER FOR A FEW MINUTES OF SPLASHING IN THE FALLS. WE NEED A PLACE WHERE TOURISTS STOP AND PULL OVER, IN BOTH WINTER AND SUMMER, TO ADMIRE THE BEAUTY. WE HAVE SUCH A PLACE IN BRIDAL VEIL FALLS. PLEASE DON'T TRADE IT FOR A FEW SILVER COINS.

DAVID P. CARTER - MY NAME IS DAVID CARTER, AND I AM A MEMBER OF THE BOARD OF DIRECTORS OF THE SALT LAKE CLIMBERS ALLIANCE (SLCA) AND CHAIR THE SLCA POLICY AND CONSERVATION COMMITTEE. THE SLCA IS A LOCAL 501(C)(3) NONPROFIT ESTABLISHED IN 2002. OUR MISSION IS TO SERVE AS THE UNIFIED VOICE OF THE OVER 20,000 CLIMBERS IN THE GREATER WASATCH REGION, ENGAGING AS AN ADVOCATE TO PROTECT OUTDOOR CLIMBING ACCESS AND AS A STEWARD TO MAINTAIN SUSTAINABLE CLIMBING RESOURCES IN THE WASATCH AND SURROUNDING REGIONS.

I WRITE TO YOU TODAY TO URGE THAT YOU ESTABLISH PERPETUAL CONSERVATION AND PUBLIC ACCESS TO PROVO CANYON'S BRIDAL VEIL FALLS.

BRIDAL VEIL FALLS IS A CORNERSTONE OF UTAH ICE CLIMBING HISTORY – WHICH, IN TURN, PLAYS A PROMINENT ROLE IN THE DEVELOPMENT OF ICE CLIMBING IN THE GREATER U.S. AMONG THE EARLIEST RECORDED ASCENTS ARE GREG LOWE'S ASCENT OF BRIDAL VEIL IN 1971. THE AREA DREW PROMINENT CLIMBERS, BOTH LOCALLY AND NATIONALLY, THROUGHOUT THE LATE 1970S AND EARLY 80S. THE BRIDAL VEIL AREA REMAINS A PROMINENT AND HEAVILY FREQUENTED ICE CLIMBING DESTINATION TODAY.

WE ALSO RECOGNIZE THE RECREATIONAL AND AESTHETIC SIGNIFICANCE OF BRIDAL VEIL FALLS FOR MANY MORE THAN ICE CLIMBERS. I CANNOT SAY HOW MANY PEDESTRIANS, PHOTOGRAPHERS, AND OTHER VISITORS I HAVE WITNESSED ON THE COLDEST DAYS (WELL BELOW ZERO DEGREES FAHRENHEIT) – MUCH LESS WARMER DAYS AND MORE FAVORABLE CONDITIONS.
