THOUGH I AM HIGHLY IN FAVOR OF REHABILITATION PROGRAMS FOR VICTIMS OF SUBSTANCE ABUSE, I STILL DO NOT SUPPORT THE DESTRUCTION OF PUBLIC LAND AND A WHOLE ECOSYSTEM TO CONSTRUCT SUCH A BUILDING. THE DRUG REHABILITATION PROGRAM COULD BE BUILT VIRTUALLY ANYWHERE ELSE--- AS A RESIDENT OF SOUTH JORDAN, I KNOW WE HAVE PLENTY OF SPACE IN OUR OWN CITY FOR SUCH A PROGRAM, AND WE CURRENTLY DO NOT HAVE ONE HERE. ADDITIONALLY. THE BEAUTY OF UTAH IS THE VAST OPEN SPACES, THE WILDLIFE AND THE DIVERSE ECOSYSTEM THAT WE HAVE HERE, AND IT MUST BE PRESERVED AND PROTECTED! WE CANNOT HAVE A REPEAT OF WHAT HAPPENED TO OUR BELOVED BEARS EARS. HOWEVER, THE TRAM WOULD ONLY BE FUNCTIONAL DURING THE SUMMER, AND IT FRANKLY WOULD MEAN THAT UTAH RESIDENTS WOULD NEED TO PAY TO ENJOY THEIR OPEN SPACES. THAT SEEMS COUNTERPRODUCTIVE AND SIMPLY UNNECESSARY. THE BEAUTY OF BRIDAL VEIL FALLS IS THAT THOSE WHO WISH TO ENJOY ITS BEAUTY CAN HIKE TO IT AND MAKE IT A FAMILY ACTIVITY, FREE OF CHARGE. DIVERTING THE BIKE LANE TO THE OTHER SIDE OF THE RIVER IS TOTALLY UNACCEPTABLE. DOING SUCH WOULD HAVE ONLY ONE PURPOSE - TO BENEFIT AN EXCLUSIVE FEW WHILE AN EVEN FEWER MAKE MONEY OFF THE DEAL.

UTAH COUNTY IS HOME TO SEVERAL WORLD CLASS CLIMBING OPPORTUNITIES, FROM SPORT CLIMBING IN AMERICAN FORK AND ROCK CANYON, TO ICE CLIMBING IN PROVO CANYON.

OUR GROUP IS INTERESTED IN ESTABLISHING LONG-TERM PROTECTIONS FOR ONE OF THE WASATCH FRONT'S MOST VALUABLE ICE CLIMBING RESOURCES AT BRIDAL VEIL FALLS.

THE SLCA HAS A LONG TRACK RECORD WORKING WITH BOTH PRIVATE AND PUBLIC LAND MANAGERS TO ADVOCATE AND STEWARD OUTDOOR CLIMBING AREAS, MOST NOTABLY THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS IN LITTLE COTTONWOOD CANYON, SNOWBIRD AND ALTA AT HELLGATE CLIFFS, AND WITH THE UINTA WASATCH CACHE NATIONAL FOREST.

WE HAVE WORKED TO REDUCE CLIMBER IMPACTS AND INCREASE SAFETY FOR THE PUBLIC AT OUTDOOR CLIMBING AREAS IN AMERICAN FORK CANYON WITH THE REPLACEMENT OF FIXED ANCHORS AND CLIMBING ACCESS TRAILS AND PLAN TO DO MORE IN UTAH COUNTY IN THE NEAR FUTURE, HOPEFULLY WITH YOUR SUPPORT.

BRIDAL VEIL FALLS IS A CORNERSTONE OF UTAH ICE CLIMBING HISTORY (WHICH IN TURN PLAYS A PROMINENT ROLE IN THE DEVELOPMENT OF ICE CLIMBING IN THE GREATER U.S.). THE EXPERIENCE OF ICE CLIMBING AT BRIDAL VEIL IS STEEPED IN CLIMBING HISTORY AND IS CHERISHED BY MANY. AMONG THE EARLIEST RECORDED ASCENTS ARE GREG LOWE'S ASCENT OF BRIDAL VEIL IN 1971. THE AREA DREW PROMINENT CLIMBERS, BOTH LOCALLY AND NATIONALLY, THROUGHOUT THE LATE 1970S AND EARLY 80S.

THE BRIDAL VEIL AREA REMAINS A PROMINENT CLIMBING DESTINATION TODAY. THE UTAH ICE GUIDEBOOK LISTS 35 DISTINCT ICE CLIMBS IN THE AREA.

THE SLCA WOULD LIKE TO SEE LONG TERM ACCESS MAINTAINED WHILE PROTECTING THIS NATURAL EXPERIENCE. WE SUPPORT A CONSERVATION EASEMENT THAT ALLOWS FOR RECREATION AT BRIDAL VEIL FALLS AND WE HOPE TO BE A STAKEHOLDER TO HELP STEWARD THIS RESOURCE INTO THE FUTURE.

WENDY PARMLEY, OREM - PLEASE PRESERVE BRIDAL VEIL FALLS FOR THE PUBLIC AT LARGE AND INVEST IN INFRASTRUCTURE TO IMPROVE SAFETY AND AMENITIES. PLEASE REJECT DEVELOPMENT BY PRIVATE DEVELOPERS - ESPECIALLY FOR A REHAB FACILITY THAT DOESN'T BELONG ON THE TOP OF A MOUNTAIN.

ALEX GROW, PROVO - MY FAMILY PURCHASED BRIDAL VEIL FALLS IN 1974 FROM THE CLEGG FAMILY AND OWNED AND OPERATED THE AERIAL TRAM AND SUPPORT FACILITIES FROM THAT TIME UNTIL THEY MET THEIR DEMISE IN AN AVALANCHE IN 1996. FROM 1996 TO 2015 WE OWNED THE PROPERTY UNTIL IT WAS SOLD TO UTAH COUNTY IN HOPES THAT THE COUNTY WOULD BE MORE WELL POSITIONED TO CREATE AN ENVIRONMENT WORTHY OF THIS NATURAL WONDER. I MET WITH COMMISSIONERS YESTERDAY THAT INDICATED THE PROPOSED CONSERVATION EASEMENT WASN'T EVEN FINALIZED, I FIND IT HIGHLY UNLIKELY THAT WE UNDERSTAND TODAY EXACTLY WHAT IS BEING PROPOSED. THE EASEMENT IS UNDENIABLY RUSHED. I WOULD PROPOSE THAT THE ITEM BE CONTINUED IN ORDER TO GIVE COMMISSIONERS, STAFF, AND THE CONCERNED PUBLIC SUFFICIENT TIME TO READ AND UNDERSTAND THE PROPOSED EASEMENT. MY FAMILY WHEN OPERATING THE RESORT GRANTED A CONSERVATION EASEMENT TO THE NATURE CONSERVANCY BASED IN WASHINGTON DC IN THE EARLY 90S. THERE'S NO WAY TO BE SURE THAT THE COUNTY EVEN OWNS THE RIGHTS THAT IS PROPOSING TO DISPOSE OF TO A NONPROFIT PARTY THAT SUPPOSEDLY HAS MORE OF THE INTEREST OF UTAH COUNTY RESIDENTS IN MIND THAN THEIR OWN ELECTED GOVERNMENT. THIS PROCESS IS EXTREMELY RUSHED. PLEASE CONTINUE THE ITEM SO ALLOW ALL PARTIES TO UNDERSTAND WHAT IS BEING PROPOSED BETTER.

THE RECENT NEWS THAT THE FALLS AND SURROUNDING AREA MAY MOVE FROM A PUBLIC TO PRIVATE SPACE HAS BEEN UNSETTLING. I KNOW THAT SOME YEARS AGO A TRAM DID EXIST TO THE TOP OF THE FALLS, WITH A RESTAURANT, ETC. ON TOP. BUT TODAY, I AM ADAMANT IN MY OPINION THAT THE AREA SURROUNDING BRIDAL VEIL FALLS SHOULD BE PROTECTED AS A PUBLIC PLACE, UNDISTURBED BY DEVELOPMENT AND DESIRES FOR MONETARY GAIN BY A FEW INDIVIDUALS. PROTECTION OF THE FALLS WILL SHOW THAT UTAH COUNTY RESIDENTS VALUE CLEAN AIR, OPEN SPACES, AND ACCESS TO OPEN, BEAUTIFUL PUBLIC SPACES OVER INCREASED DEVELOPMENT OF OUR LIMITED NATURAL SPACES IN THE COUNTY. I HOPE WE CAN ACT NOW TO KEEP BRIDAL VEIL FALLS THE WAY THEY ARE NOW: IN THEIR NATURAL, BEAUTIFUL STATE.

NICKOLAS CLARKE, ALPINE - I AM WRITING IN REGARDS TO THE PROPOSAL TO PLACE BRIDAL VEIL FALLS INTO A CONSERVATION EASEMENT VS SELLING/LEASING THE PROPERTY FOR PRIVATE DEVELOPMENT. I AM STRONGLY IN FAVOR OF PLACING THE FALLS AND THE SURROUNDING AREA INTO CONSERVATION EASEMENT TO PREVENT PRIVATE DEVELOPMENT AND ENSURE THE NATURAL AREAS PRESERVATION IN PERPETUITY FOR FUTURE GENERATIONS.

THE WASATCH RANGE, WHERE THESE FALLS ARE LOCATED, ARE BY DEFINITION A LIMITED RESOURCE. THESE MOUNTAINS ARE ONE OF THE PRIMARY DRAWS FOR MYSELF AND OTHERS TO LIVE AND WORK IN THE REGION. MUCH OF THE MOST SPECTACULAR FEATURES OF THESE MOUNTAINS HAVE ALREADY BEEN SOLD OR LEASED IN THE PAST TO PRIVATE INTERESTS. THERE IS IMMENSE PRESSURE ON THE NATURAL AREAS ALONG THE WASATCH FRONT FOR A GROWING POPULATION THAT IS INCREASINGLY INTERESTED IN ACCESS TO THE OUTDOORS, YEAR-ROUND. PROVO CANYON, IN PARTICULAR, HAS INCREDIBLE PRESSURE, BUT SOME OF THE MOST PRIVATE LAND HOLDINGS IN THE AREA. BRIDAL VEIL FALLS, WHICH ALREADY HAS GREAT INFRASTRUCTURE FOR EASY ACCESS OF CITIZENS, HELP RELIEVES PRESSURE FROM OTHER PARTS OF RANGE. FOR OUR LOCAL GOVERNMENT TO SELL OFF OR OTHERWISE PRIVATIZE OUR PUBLIC LANDS THAT CLEARLY ENJOY STRONG SUPPORT FROM LOCAL CITIZENS WOULD BE A TRAVESTY AND SHORT-SIGHTED DECISION.

I SEE STRONG PARALLELS TO THE DISCUSSIONS HAD FURTHER NORTH IN THE RANGE WHEN IT COMES TO EXPANSION AND INTERCONNECTION OF PRIVATE LANDS HELD BY SKI RESORTS. AS WILL MCCARVILL, A LONG TIME WASATCH BACKCOUNTRY USER HAS SAID: "WHEN PEOPLE TALK ABOUT COMPROMISE AND SHARING, WHAT THEY FORGET IS THAT YEARS AGO THE PUBLIC MADE A MAJOR COMPROMISE WHEN THEY GAVE AWAY ALL OF THE PRIME, UPPER ELEVATION, NORTH FACING TERRAIN AT THE HEAD OF THE CANYONS TO THE SKI RESORTS. WE'VE ALREADY MADE A HUGE COMPROMISE."

THE SAME CAN BE SAID FOR BRIDAL VEIL FALLS AND THE PUBLIC LANDS IN PROVO CANYON. THERE ARE ONLY SO MANY ACRES OF THE WASATCH RANGE THAT CAN BE ENJOYED. THE PUBLIC HAS ALREADY MADE HUGE COMPROMISES, AND THERE IS NO NEED TO PROVIDE MORE LAND FOR PRIVATE USE WHEN THE LOCAL ECOSYSTEM IS ALREADY BEING STRETCHED TO SUPPORT THE RECREATIONAL USE WE SEE TODAY. I URGE THE COMMISSION TO TAKE A LONG-TERM VIEW AND PRESERVE THESE LANDS IN PERPETUITY,

THE COMMENT THAT I WOULD LIKE TO GIVE IN THE CONVERSATION WE'RE HAVING TODAY ABOUT BRIDAL VEIL FALLS BEING PLACED INTO A CONSERVATION EASEMENT IS THIS: BRIDAL VEIL FALLS DESERVES AND NEEDS *SOME TYPE* OF COMMERCIAL DEVELOPMENT AT THE SITE. THE NATURAL SPLENDOR OF BRIDAL VEIL FALLS IS OVERWHELMING AND VERY WORTHY OF VIGILANT PROTECTION. AT THE SAME TIME, THE MAJORITY OF THE TERRAIN AT BRIDAL VEIL FALLS IS EXTREMELY DIFFICULT TO TRAVERSE AND IS INACCESSIBLE TO MANY PEOPLE. PLEASE VOTE IN FAVOR OF A CONSERVATION EASEMENT IN ORDER TO PRESERVE THIS BEAUTIFUL NATURAL PLACE FOR EVERYONE TO ENJOY FOR YEARS AND YEARS TO COME. NO PRIVATE DEVELOPMENT SHOULD HAPPEN HERE, ONLY IMPROVEMENTS TO ENSURE IT REMAINS BEAUTIFUL AND ACCESSIBLE TO THE PUBLIC.

JONAH JONES, OREM - THIS FATE OF THIS WATERFALL SHOULD NOT BE IN THE HANDS OF A PRIVATE BUSINESS OWNER. THIS WATERFALL HAS BEEN USED BY MY FAMILY FOR YEARS FOR MANY ACTIVITIES. I BIKED TO THIS WATERFALL EVERY SATURDAY GROWING UP. I SPENT COUNTLESS HOURS PLAYING IN THE WATER AT ITS BASE. I RAN TO THIS WATERFALL EVERY DAY FOR MY CROSS-COUNTRY PRACTICE THROUGHOUT HIGH SCHOOL. THIS WATERFALL ALLOWS THE MEMBERS OF OUR CITY A DESTINATION TO GET OUTSIDE AND GO TO. THIS WATERFALL CANNOT AND SHOULD NOT BE USED AS A SITE FOR A REHABILITATION CENTER. I WILL NOT LET THIS WATERFALL BE TAKEN FROM OUR CITY. BUILDING A TRAM GOING UP THE WATERFALL IS UNACCEPTABLE. IT WILL DESTROY THE VIEW OF THIS BEAUTIFUL FALLS. BUILDING A HELICOPTER LANDING PAD WOULD CREATE SO MUCH NOISE, THERE WOULD NOT BE A POINT FOR THE COUNTLESS CITIZENS THAT GO TO THE FALLS EVERY DAY TO CONTINUE GOING. TURNING THE FALLS INTO THIS KIND OF BUSINESS WILL NOT BENEFIT OUR CITY DIRECTLY, ONLY THE BUSINESS OWNER. I WILL NOT STAND FOR THIS ESTABLISHMENT. THIS IS OUR WATERFALL, I WOULD JUST LIKE TO SAY WHERE WILL DEVELOPMENT END? IF WE ALLOW THIS CENTER TO BE ESTABLISHED AT THE TOP OF THE FALLS, THIS WILL BE THE STEP STOOL FOR OTHER BUSINESSES TO START THEIR DEVELOPMENTS IN THE CANYON AND AROUND THE FALLS. WE CANNOT ALLOW THIS FIRST BUSINESS TO BUILD ON THE FALLS AS IT WILL LEAD TO A CASCADE OF BUSINESSES WANTING TO PUT THEIR BUSINESSES UP THE CANYON.

KENT FLOWERS, OREM - THERE ARE MANY BEAUTIFUL SPOTS IN UTAH COUNTY. ONE OF THEM IS BRIDAL VEIL FALLS. THE FALLS HAVE BE A FOCUS OF THE COMMUNITY FOR MANY YEARS BEFORE AND AFTER THE LAND BECAME PROPERTY OF THE COUNTY. TO NOW LET THIS GEM FALL OUT OF PUBLIC HANDS AND INTO PRIVATE DEVELOPMENT WOULD BE BEYOND TRAGIC.

THE CURRENT PROPOSAL TO SELL THE PROPERTY FOR AN EXCLUSIVE DRUG CENTER IS OUTSIDE OF THE PUBLIC INTEREST AND EXTREMELY SHORT SIGHTED. THE PROPOSED \$2.5 MILLION DOLLAR THAT THE COUNTY WOULD RECEIVE WILL DISAPPEAR INTO THE BUDGET WITHOUT ANY REAL PUBLIC BENEFIT.

I FEAR THAT ALLOWING THIS PARTICULAR PROPOSAL WILL BE LIKE ALLOWING THE CAMEL'S NOSE INTO THE TENT. JEREMIAH HODACK, LEHI - I WOULD HAVE LIKED TO HAVE VOICED MY COMMENTS LIVE IN THE ZOOM MEETING BUT WAS UNABLE TO ACCESS THE MEETING DUE TO THE ATTENDANCE BEING CAPPED. I LIVE IN LEHI WITH MY WIFE AND FOUR CHILDREN AND HAVE LIVED IN UTAH COUNTY FOR NEARLY A DECADE, I AM VOICING MY SUPPORT FOR A CONSERVATION EASEMENT. MY FAMILY AND I HAVE DECIDED TO RESIDE IN UTAH COUNTY IN LARGE PART DUE TO THE PROXIMITY TO OUTDOOR RECREATION AND THE NATURAL BEAUTY THAT SURROUNDS US. MY CHILDREN HAVE GROWN UP RECREATING IN AMERICAN FORK CANYON, HOBBLE CREEK CANYON, AND PROVO CANYON INCLUDING BRIDAL VEIL FALLS. I AM EXTREMELY APPRECIATIVE THAT THE COUNTY HAS UTILIZED ITS RESOURCES TO PURCHASE THIS GREAT ASSET. I STAUNCHLY OPPOSE SELLING ANY PORTION OF THE LAND FOR PRIVATE USE. MANY OF THOSE WHO WILL ARGUE AGAINST A CONSERVATION EASEMENT WILL STATE THAT IT IS PREMATURE OR UNNECESSARILY PLACES RESTRICTIONS ON THE LAND WHEN WE DO NOT KNOW THE FUTURE. CARLEE REBER, PROVO - I WHOLEHEARTEDLY SUPPORT A CONSERVATION EASEMENT FOR BRIDAL VEIL FALLS AND WAS THRILLED TO LEARN IN THIS MEETING ABOUT THE THOUGHTFUL VISION AND PLANS THE COUNTY HAS FOR THIS PUBLIC SPACE! WHEN I BIKE UP PROVO CANYON ON THE PARKWAY, I LOVE SEEING HOW MANY PEOPLE--ESPECIALLY KIDS AND YOUTH AS WELL AS ETHNICALLY DIVERSE RESIDENTS--ACTIVELY ENJOYING THE VIEW AND POOLS OF WATER AT THE BASE OF THE FALLS.

WHILE DEVELOPING THE FALLS AREA MAY SEEM FRUGAL AND HARMLESS IN THE SHORT-TERM, IT'S AN UNWISE CHOICE IN THE LONG-TERM. EVEN IF MR. LOSEE HAS INTEGRITY WITH PRESERVING THE FALLS AND COOPERATING TO KEEP PUBLIC ACCESS, THERE IS NO GUARANTEE THAT HIS SUCCESSOR(S) WILL DO THE SAME-AND AT THAT POINT, IT'D BE INCREDIBLY UNLIKELY THAT THE PUBLIC COULD DO ANYTHING ABOUT IT. KEEPING IT IN THE COUNTY'S HANDS MEANS THE PUBLIC, WHO VALUES ITS WELL-BEING FOR GENERATIONS TO COME, WILL HAVE A SAY IN WHAT HAPPENS THERE.

ADDITIONALLY, AS A LATTER-DAY SAINT I BELIEVE WE HAVE A MORAL RESPONSIBILITY TO CARE FOR GOD'S GIFT OF CREATION. GARRET ROUNDY, OREM - I SUPPORT A CONSERVATION EASEMENT. PLEASE DO NOT LEASE OR SELL THE LAND. THE FALLS SHOULD BE LEFT IN THEIR CURRENT CONDITION WITHOUT BUILDINGS OR TRAMS.

RUTH ELDREDGE, PROVO - I AM A 20-YEAR RESIDENT OF PROVO, A PROVO REPUBLICAN PRECINCT CHAIR, STATE AND COUNTY DELEGATE. I CURRENTLY REPRESENT 14,000 PROVO RESIDENTS AS FOOTHILLS NEIGHBORHOOD CHAIR. IN MY PROFESSIONAL LIFE, I HAVE CONSULTED CITY, STATE, AND FEDERAL GOVERNMENTS, INCLUDING THE WHITE HOUSE OFFICE OF SCIENCE AND TECHNOLOGY POLICY, ON MATTERS OF EQUAL ACCESS, AND CHILD WELL-BEING. I VISIT BRIDAL VEIL FALLS ON 3-4 TIMES A MONTH, YEAR-ROUND.

I ALSO HAVE SIGNIFICANT, MULTI-YEAR EXPERIENCE WITH REHABILITATION CENTERS, OWNED BY RICHARD LOSSEE AND OTHERS.

I AM BEYOND ALARMED AT THE APPROACH OF COMMISSIONER LEE AND MR. LOSSEE TOWARD THIS CAMPAIGN. SINCE THE MOVEMENT TO DEDICATE BRIDAL VEIL FALLS INTO A CONSERVATION EASEMENT, THEY HAVE FAILED TO INFORM THE PUBLIC, IN THE DETAIL THEY DESERVE, OF THEIR INTENTIONS OR INTERESTS. A STATE MONUMENT MEANS PUBLIC LAND OWNED AND MANAGED BY THE STATE, DESIGNED BY THE STATE FOR PRESERVATION OF HISTORICAL LANDMARKS, HISTORIC AND PREHISTORIC STRUCTURES, GEOLOGICAL FORMATIONS, CULTURAL SITES, ARCHAEOLOGICAL RESOURCES AND IN ESSENCE CONFINED TO SMALL AREAS COMPATIBLE WITH PROPER CARE AND MANAGEMENT OF HISTORICAL LANDMARKS.
